

Lockly Guard Wireless Transceiver is built with F433,92MHz and Lockly 2.0 proprietary encryption to provide stable wireless connectivity, security and reliability. It operates on 12V DC from the Access Control power supply and supports high-level or low-level of PUSH and monitors door open/closed status of the electromagnetic lock*. It is very quick and easy to install anywhere.

slide the bottom of the case as shown.

1. To remove cover, slide the bottom of lnsert cables through the bottom hole and connect to Insert cables through the bottom hole and connect to corresponding wireless transceiver terminals: PUSH GND, GND, +12V and LOCK NC. Then connect the cables to the corresponding terminals on the Access Control Power Supply: PUSH, V-, V+ and LOCK NC to electromagnetic lock NC terminal. Ensure you followed the wiring diagram and cables are connect-ed to the corresponding terminals. Tighten the screws to secure the cables.

The NC port is used to detect the opening and closing status of the door, Only the Lockly Guard Electromagnetic Lock supports this function. If you use a third-party Electromagnetic Lock other than the Lockly Guard Electromagnetic Lock, you do not need to connect this NC cable.

*Works ONLY with Lockly Electromagnetic Lock. Connection to NC of the LOCK NC cable is required.

3. Pair Wireless Transceiver to the Lockly Guard Ingress or Ingress Vision Access Control power supply will activate the Wireless Transceiver Wireless Transceiver Blue light indicator will be ON once connected to Ingress Vision. Refer to the Ingress/Ingress Vision Manual for pairing instructions.

Short Press the wireless transceiver pairing button to start connecting with Ingress/Vision, Blue light indicator flashes when pairing starts. It will automatically exit pairing mode if pairing is successful, if pairing is unsuccessful, it will continue to flash and automatically exits in 3 minutes.



Short press the wireless transceiver pairing button again to re-enter pairing mode.

4. How Wireless Transceiver and Ingress/Ingress Vision Works

- When wireless transceiver is activated through the smart access control power supply, the Blue light indicator turns ON when the door locks or unlocks.
