Simultaneous transmitting consideration (worst case):

The ratio=ERP_{BLE}/limit+ERP_{2.4G Wi-Fi}/limit+ERP_{5G Wi-Fi}/limit+ERP_{6G Wi-Fi}/limit = $0.014/0.768+0.122/0.768+0.088/0.768+0.014/0.768=0.310 \le 1.0$, so simultaneous exposure is compliant.

To maintain compliance with the FCC's RF exposure guidelines, place the equipment at least 20cm from nearby persons.

Result: Compliant.
