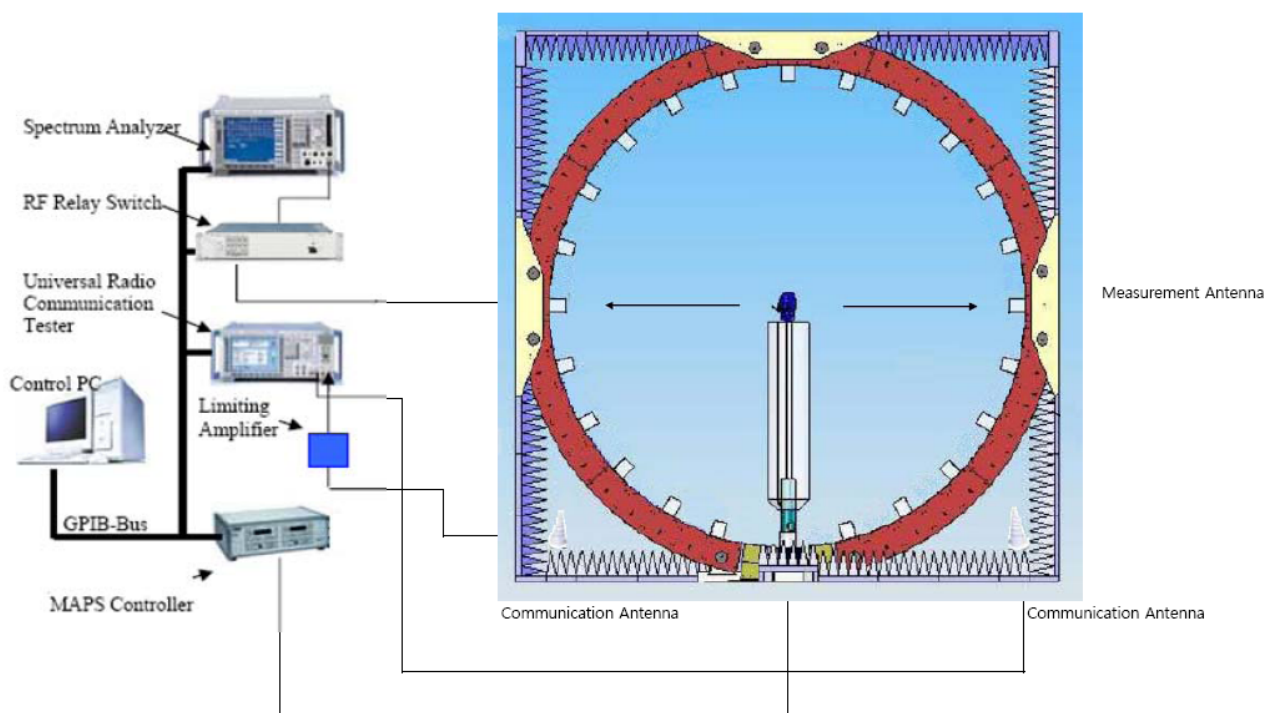

Antenna Dimensions

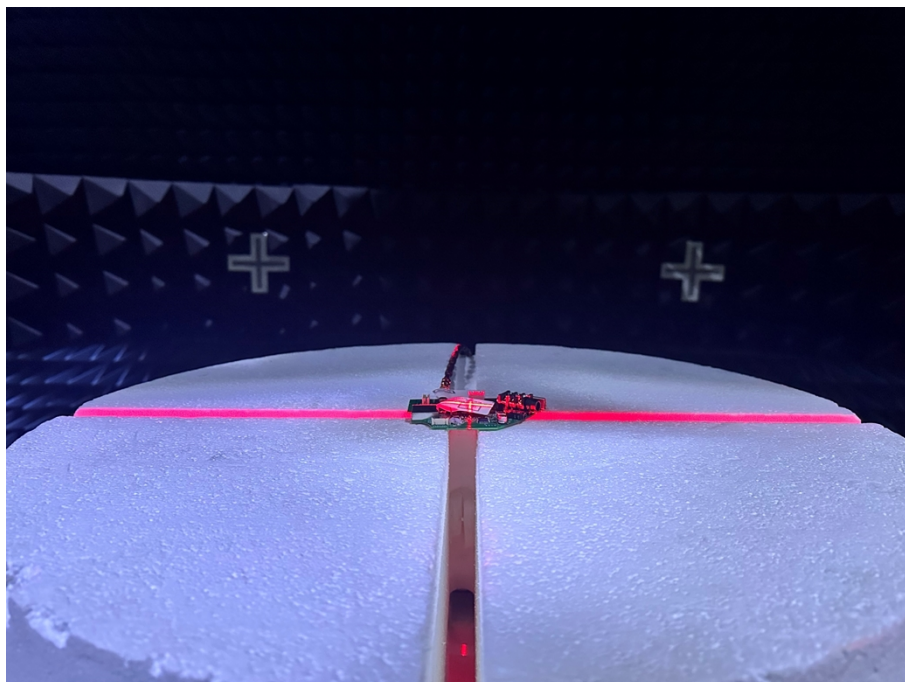

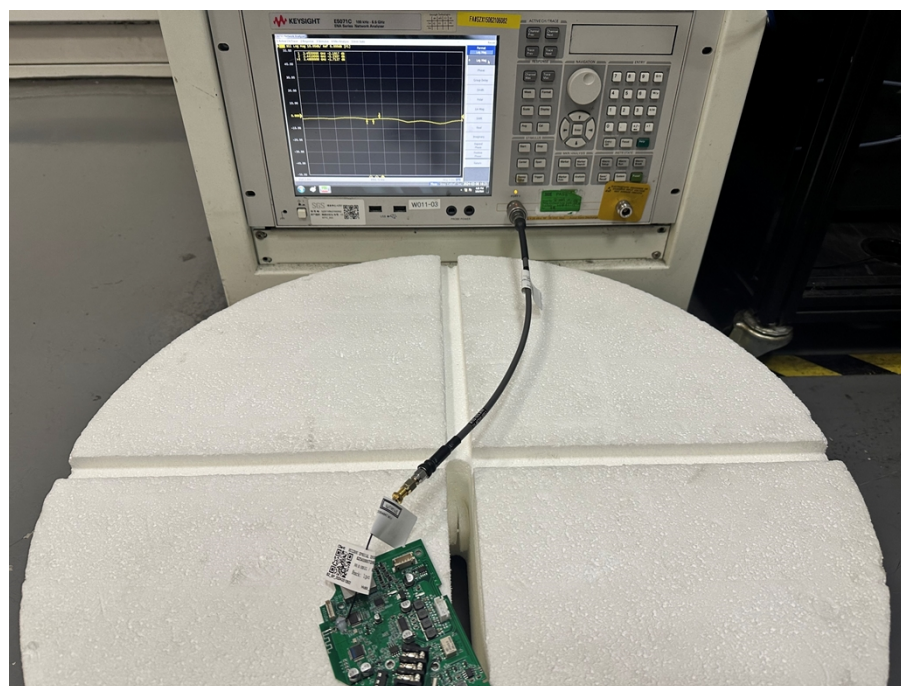
