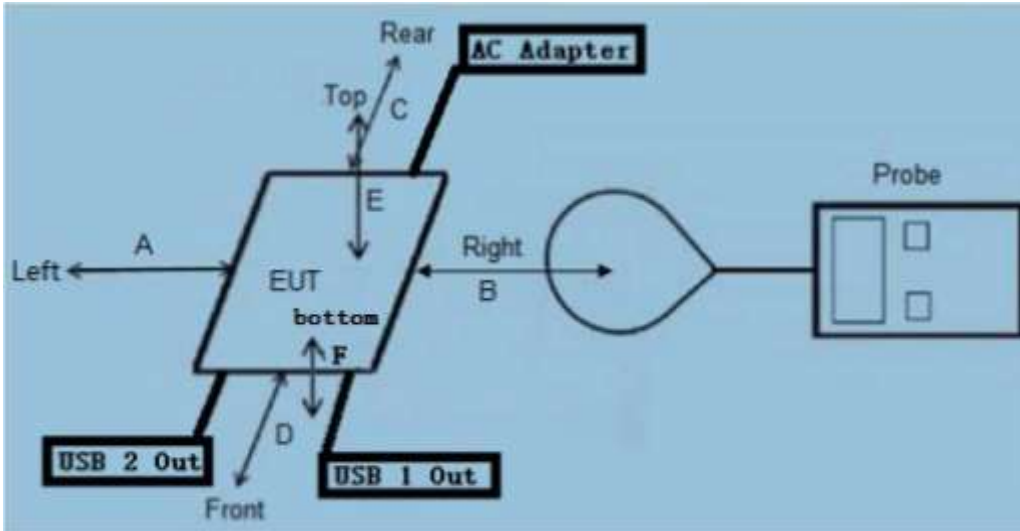

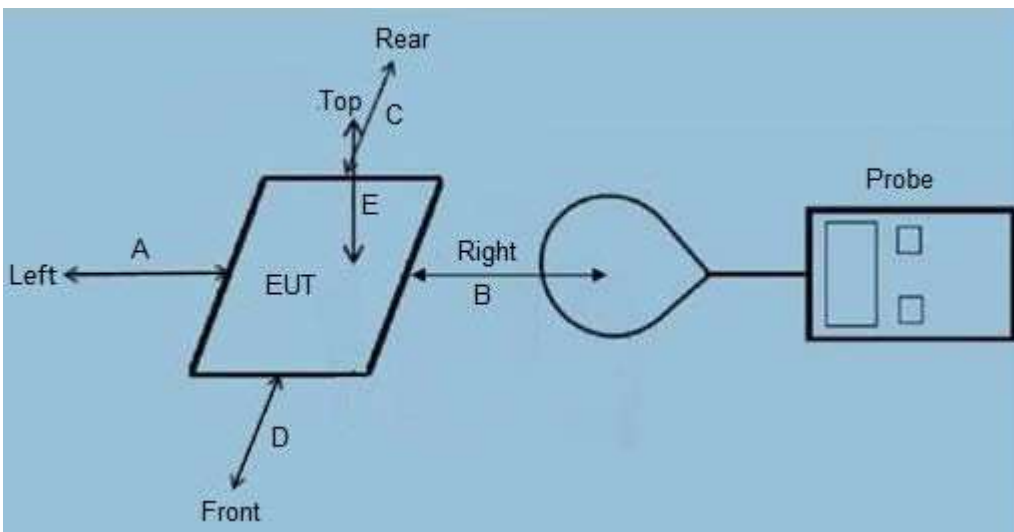

6.4 MEASUREMENT PROCEDURE

For mobile RF exposure:

- The RF exposure test was performed on 360 degree turn table in anechoic chamber.
- The measurement probe was placed at test distance (15cm) which is between the edge
- The charger and the geometric center of probe. And a test distance (20cm) which is between the Top of the charger and the geometric center of probe.
- The highest emission level was recorded and compared with limit as soon as measurement of each points (A, B, C, D, E) were completed.
- The EUT were measured according to the dictates of KDB 680106 D01v03r01.

For portable RF exposure:

- The RF exposure test was performed on 360 degree turn table in anechoic chamber.
- The measurement probe was placed at test distance (from 0 cm to 20 cm, in 2 cm maximum increment) which is between the edge of the charger and the geometric center of probe.
- The highest emission level was recorded and compared with limit as soon as measurement of each points (A, B, C, D, E, F,) were completed.
- The EUT were measured according to the dictates of KDB 680106 D01v03r01

Remark: The diameter size of the probe is 11.5cm.
