





Product schematic description


Product operating instructions

1. Power on
Method 1: Remove from the charging compartment, the headset automatically turns on.
Method 2: Press and hold the touch button on the earphone for 3 seconds to turn on the earphone.

2. Power off
Method 1: Put the headphones into the charging case directly and close the case to turn off.
Method 2: When both the left and right earphones are in the powered-on state, press and hold the touch button on the earphones for 5 seconds to turn off the earphones.

3. Pairing to the BT device
Step 1: Open the upper cover of the charging compartment to remove the headphones, binaural automatic pairing.
Step 2: open the BT list of smart devices, search "OpenAir Pro" and Connect (single ear use is supported).

- Previous track: Three-click any headset function key
- Next track: Double click any headset function key
- Pause/Play: Click on any headphone function key


■ Left/ Right headphone operating (incoming call)
