

# Product diagram







#### Operation method

- 1. When the device has a low battery, the power key indicator lamp turns yellow from blue, accompanied by a voice prompt: "low battery". At this time, you may charge the device by connecting the USB cable to an adapter that meets the standards of household appliances (output range:5V 1-2A) or to a computer USB port. While charging, the yellow lamp flashes; when the massager is fully charged, the blue lamp is always on. It takes around 4 hours for the device to be fully charged, after which, the device can be used for 3-4 hours.
- 2. Before use, first wet the skin of the cervical spine with a wet towel, and then wear the product on the neck, so that the electrode is attached the skin of the cervical spine. Then, adjust the position of the product, turn on the device and adjust the appropriate massage intensity and mode. 3. Press and hold "①" for two seconds to power on the device (with voice prompt: Hi, SKG.).
- 4. Enter "smart mode" with default level 0. When the device is on, each time you press the "① "you switch one mode in cycle among four modes (the voice prompts "Smart mode", "Relax mode", "Active mode", "Physical therapy mode" when the mode is switched). Every time when you switch the mode, the intensity returns to the default level 0. When the device is on, you may press and hold for two seconds to turn off the device, accompanied by a voice prompt "Bye".
- 5. "+" is the intensity increase button and Voice ON key. For each short-press, the voice prompts corresponding levels such as "level 1", "level 2" ......to increase one level. The intensity includes 15 levels (0, 1, 2 ... 15). Press "+" when the intensity reaches 14 and the voice prompts: "max.". Then press "+" again and the voice still prompts "max." with unchanged intensity. A long-press "+" turn on voice function. Press "+" for two seconds to turn on the voice, and voice prompt "audio mode" is given.

- 6. "-" is the intensity decrease button and Voice Off key. For each short-press, the voice prompts corresponding levels such as "level 14", "level 13" .....to increase one level. The intensity includes 15 levels (15, 14, 13..... 0). Press "-" when the intensity reaches 1 and the voice prompts: "min." Then press "-" again and the voice still prompts "min." with unchanged intensity. A long-press "-" turn on voice function. Press "-" for two seconds to turn off the voice, and voice prompt "mute mode" is given.
- 7. " \$\}\" " is the heating adjusting button. Press once to start heating and the voice prompts: "Low-level hot compress". The electrode is heated while its temperature is kept at  $38\pm2^{\circ}$ C; Press twice, the medium level is activated, when the voice prompt "Medium heat" is given while the electrode temperature is kept at  $40\pm2^{\circ}$ C; Press three times, the high level is activated, when the voice prompt "high level hot compress" is given, while the electrode is kept at  $42\pm2^{\circ}$ C; Press again to turn off the heating, and the voice prompt: "Stop heating".
- 8. When the product is properly worn and used, the main machine is in power-on state; when both heating and massage is not in service, the product will automatically be turned off in about 120s, while the voice prompt "Bye" is given; Once the product is not properly worn, it will get automatically turned off in about 120s, while the voice prompt "Bye" is given.
- 9. Where the battery is too low, the main machine is powered off automatically while the voice prompt "Bye" is given.
- It is recommended to use the APP for control, There are more massage modes to select and download. The operating mode of the APP is as follows:
- Scan the QR code of the APP on the right. Search for "SKG" in the mobile application market to download and install the software.
- Registration and login. Enter the email number, and get the email verification code to complete registration.
- 3 Add device. Enter the email number, and get the email verification code to complete registration.



Make sure that the Bluetooth of the mobile phone is turned on, turn on the massager device, and click "Add Device" on the "Device" page of the APP.

# Tips

- Appropriate massage is recommended; it is recommended to use no more than half an hour a day.
- Store the device in a well-ventilated and dry place after use.
- Don't put other heavy items on the device.

#### Routine maintenance

- When cleaning and maintaining the device, turn it off and clean the electrode with wet tissue paper. When it's especially dirty, use a small amount of medical alcohol (alcohol concentration of 75%) to wide and disinfect.
- During daily maintenance, use neutral cleanser and soft cloth to wipe.
   Don't use corrosive cleanser and don't soak or rinse it in water. Don't wash it with water.
- During cleaning process, prevent water or other liquid from entering the device to avoid short circuit and electric shock.

#### FAO

- If you have problems using the product, please refer to the following tips and solutions.
- If the product is still in a fault condition or cannot be used, turn off the power.
- Users should not attempt to disassemble or repair the product by themselves.
  - Dismantling or repairing by themselves will cause damage to the product and void the manufacturer's warranty. The company will not be held responsible for any consequences caused thereby.

Problems	Possible cause/treatment
Unable to start	Whether the internal rechargeable battery runs low.     Please confirm the product power switch is on.
Failure to charge or no charge light	Please check if the USB cable and host and phone power adapter are connected.
Problems	Possible cause/treatment
Normal display but no stimulation	<ul> <li>Does the pad contact the skin directly? Adjust the position so that it is close to the skin.</li> <li>Is there hair or clothing, jewelry, etc. between the pads and the skin? Move away or remove items.</li> <li>Is the intensity level too low? Increase the massage intensity.</li> </ul>
Tingling sensation	<ul> <li>Is the massager's electrode and neck skin closely contacted? Adjust the position so that it's stick to the skin.</li> <li>Is the massage time too long? It is recommended to massage for 15 minutes at a time, twice a day.</li> <li>Is the massage intensity too high? Adjust to a low level</li> <li>Is the skin allergic to the electrode? Those with severe allergies need to be desensitized first.</li> <li>Is the climate cold and the skin dry? Use a wet towel to moisten the skin area, prior to using.</li> <li>Does the skin have a wound? Do not place the electrodes on the wound during use.</li> </ul>
Weak stimulation	<ul> <li>Is the massager's electrode in good contact with the skin area? Try adjusting the position of the electrode onto the skin surface, to improve skin contact, and adjust the massager's intensity.</li> <li>Is the electrode dirty or oily? Clean the electrode surface.</li> <li>Is the battery running low? Please charge if the battery is low.</li> <li>Is massage intensity level too low? Increase massage intensity.</li> </ul>

#### **Precautions**



#### ∧ Danger

- Please never use the product together with the following medical electronic devices:
  - 1. Pacemaker and other implantable medical electronic devices;
  - Medical electronic devices such as ECMO that sustain life:
  - 3. Electrocardiograph and other medical electronic devices;
  - \* It may cause malfunction of these medical electronic devices, which may be life-threatening.
  - 4. It's not allowed in gas stations, workshops with excessive dusts, gas and other places of flammable and explosive material.



# ⚠ Warning

- When the high-frequency surgical equipment and the massager are applied on a patient at the same time, the electrode of the massager may cause burns or damage the massager.
- When the product is applied close to (1M) a short-wave or microwave treatment device, the output of the massager may be unstable.
- During massage, don't contact wounds and scars with the electrode.
- During massage, don't place the electrode near the heart. Otherwise it will increase the risk of heart fibrillation.
- The product is recommended to be used by one user. In case it's used by two or more users, the electrode should be cleaned before use.
- When using the product, the electrode should be tightly attached to the skin in uniform contact.
- The electrode of the massager has the heating function. Hot compress on the same part for a long time (more than 15 minutes) may cause low-temperature burns.
- In case of discomfort during or after usage, stop using it and seek medical attention.
- This product contains a lithium battery. Don't disassemble, modify, immerse the product or throw it into fire, otherwise it may cause product damage or explosion.
- Please consult your doctor for the following situations. Failure to do so may cause an accident or discomfort.
  - 1. Patients who are receiving medical treatment and feel unwell.

- 2. Patients suffering from abnormal cardiac conditions and brain nerves.
- 3. Patients whose temperature exceeds 38 degrees (fever).
- 4. Patients suffering from infectious diseases.
- 5. Patients subject to skin perceptual disorder or skin abnormalities.
- 6. Patients on medication.
- 7. Patients with abnormal blood pressure.
- 8. Patients who cannot express themselves freely.
- Patients suffering from sensory disorder due to peripheral circulation disorder caused by diabetes, etc.
- 10. Patients with skin allergies to stainless steel electrode.
- Usage is prohibited in the following circumstances
  - 1.Patients with malignant tumors
  - 2. Patients with hemorrhagic tendency
  - 3. Pregnant and Iving-in woman
  - 4. Patients with acute suppurative inflammation
  - 5. Pacemaker users
  - 6. Patients with metal implants
  - 7. Near the human heart
- Don't apply the product near the heart, above the neck, head, mouth, private parts, or parts with skin diseases and don't massage the soles of both feet at the same time. In addition, don't compress the internal organs when using. Failure to do so may cause an accident or discomfort.
- Don't apply it with other medical devices or use more than two sets of the product at the same time. Otherwise it may cause nausea or discomfort.
- Don't apply it for purposes other than massage as described in the user manual. Otherwise accidents and malfunctions may occur.
- Don't use the electrode with missing or damaged surfaces. Otherwise, accidents or malfunctions may occur.
- Don't disassemble, repair and modify this product without permission.
   Otherwise it may cause malfunction or electric shock.

# ⚠ Note

- In case of discomfort due to product abnormality, stop using it immediately.
- In case of a strange feeling on your body or skin, consult your doctor and follow your doctor's advice.

- During the massage, to move the electrode or place it on other people, make sure to cut off the power before moving. Otherwise you may get a strong electric shock.
- Don's massage with electronic equipment. Otherwise, it may cause malfunction of electronic devices (such as messy electronic watch time).
- In the event of an abnormal operation, please cut off the power immediately and remove it. Otherwise high temperature or short circuit may occur, leading to an accident. At the same time, contact after-sales service.
- Don't plug or unplug the USB charging cable with wet hands. Otherwise it may cause electric shock or accident.
- Don't allow children or people not capable of expressing consciously to use. Otherwise it may cause accidents or physical discomfort.
- Don't use the product in a place with high humidity, such as a bathroom, or use the product while bathing. Otherwise, you may receive a strong electric shock and damage the product.
- Don't use the product when you are in bed. Otherwise, the device may malfunction. In addition, the electrode may be moved to other parts and cause discomfort.
- Don't use the product when driving. Otherwise it may cause discomfort due to excessive stimulation, resulting in an accident.
- Don't stick the electrode to the affected area for a long time.
   Otherwise it may cause skin inflammation.
- When massaging, don't touch the electrode with the metal parts of the belt, necklace, etc. Otherwise you may get a strong electric shock.
- Don't apply the product on the same part for a long time (more than 30 minutes). Otherwise it may cause muscle fatigue in the massaged part and discomfort.
- Wear this product correctly. It is used on the cervical spine and is worn symmetrically. Otherwise, accidents or discomfort may occur.
- When disconnecting the USB charging cable from the product, don't pull
  the cable, but hold the plug to pull. Otherwise it may cause electric
  shock or damage the product.
- The electrode of the massager has the heating function. Users who are not sensitive to heat or too sensitive to heat should consult a doctor before use.
- When the product is in use for a long time, the surface will be hot, which is normal.



# **△** Suggestion

- Make sure that the buttons on the device function normally before use.
- When the device is used for the first time or not in use for a long time. please charge it according to the user manual to ensure that it can function normally.
- When disposing of this product, please dispose of it in accordance with the relevant environmental protection regulations of the city. Otherwise it may cause environmental pollution.
- This product's target users are people aged 16 or above.
- Don't use or store this product in the following places:


