4.3 RF Exposure Estimation (MPE Estimation)

Having available the source based average output power and peak antenna gain or the ERP/EIRP of the specified device and for a known minimum distance of its radiating structures from the body of persons according to its use cases (at least 20cm) the power density at that distance can be estimated by the following formula for plane-wave equivalent conditions (far-field conditions), when ground reflection is neglected.

$$S = \frac{PG}{4\pi R^2}$$

where: $S = power density (mW/cm^2 or W/m^2)$

P = power input to the antenna (mW or W)

G = power gain of the antenna in the direction of interest relative to an isotropic radiator

R = distance to the center of radiation of the antenna (cm or m)



5 Evaluations

5.1 Analysis of RF Exposure

- Evaluations are based on worst case power density limits for US and Canada.
- Calculations are made for 20cm.
- Evaluations are based on ERP/EIRP measured or calculated from known gain and conducted output power.

FCC:

LoRa

Operating frequency < 1.5GHz, ERP20cm Limit = 2040 x 0.907 = 1850.28mW = 1.85W Actual ERP = 0.0015W < 1.85W; Excluded.

IC:

LoRa

EIRP Limit = $0.0131 \text{ x f (MHz)} \cdot 0.6834 = 1.38W$ Actual EIRP = 0.0024W < 1.38W; Excluded.

5.2 Conclusion:

The equipment is passing RF exposure requirements for 20cm distance.
