### Pairing

- 1、 Turn on the controller to enter pairing mode
  - 2、 Press PAIR button on adapter to enter pairing mode
  - 3、 LED will be solid blue when connection is successful
- 6 Button3 Button: Press and hold SELECT button for 3 seconds, and the light will flash twice

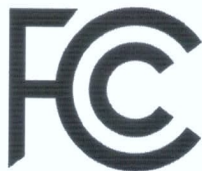
