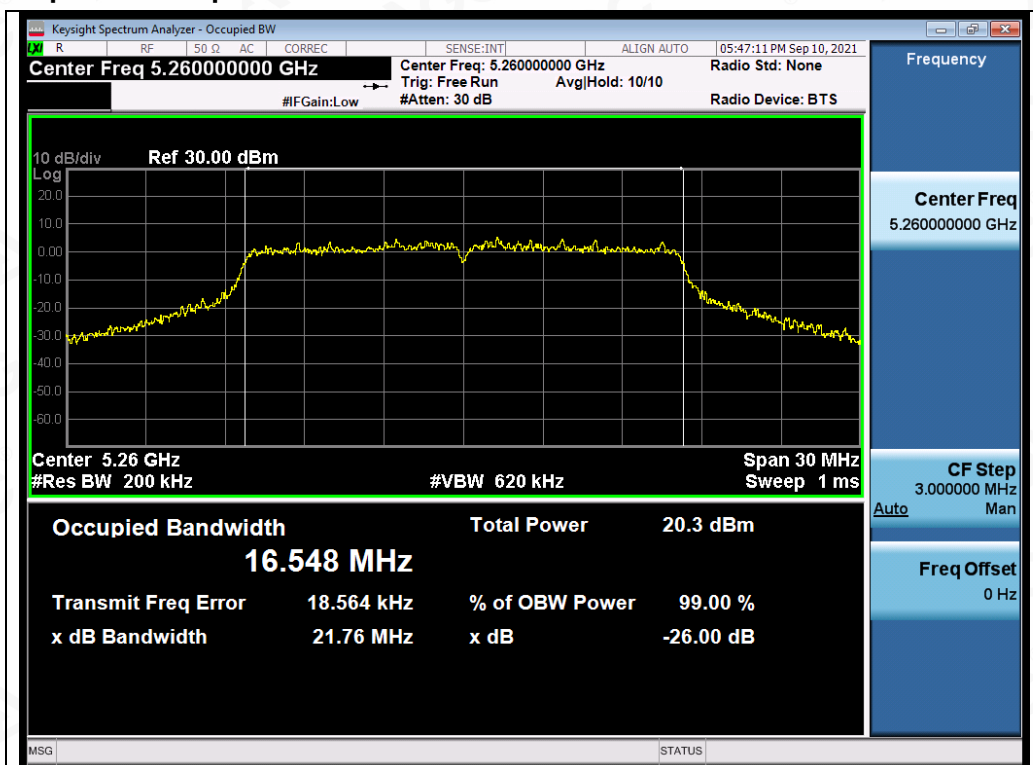

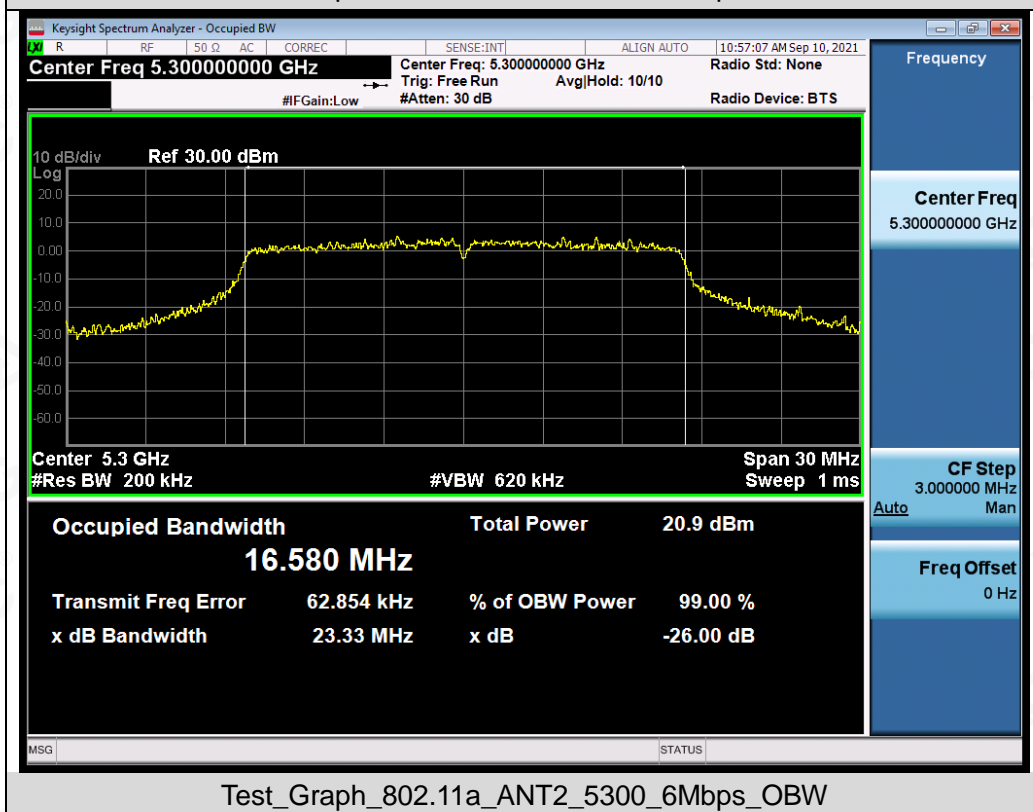




## Test Graphs of Occupied Bandwidth and -26dB Bandwidth for band 5.25-5.35 GHz-ANT 2

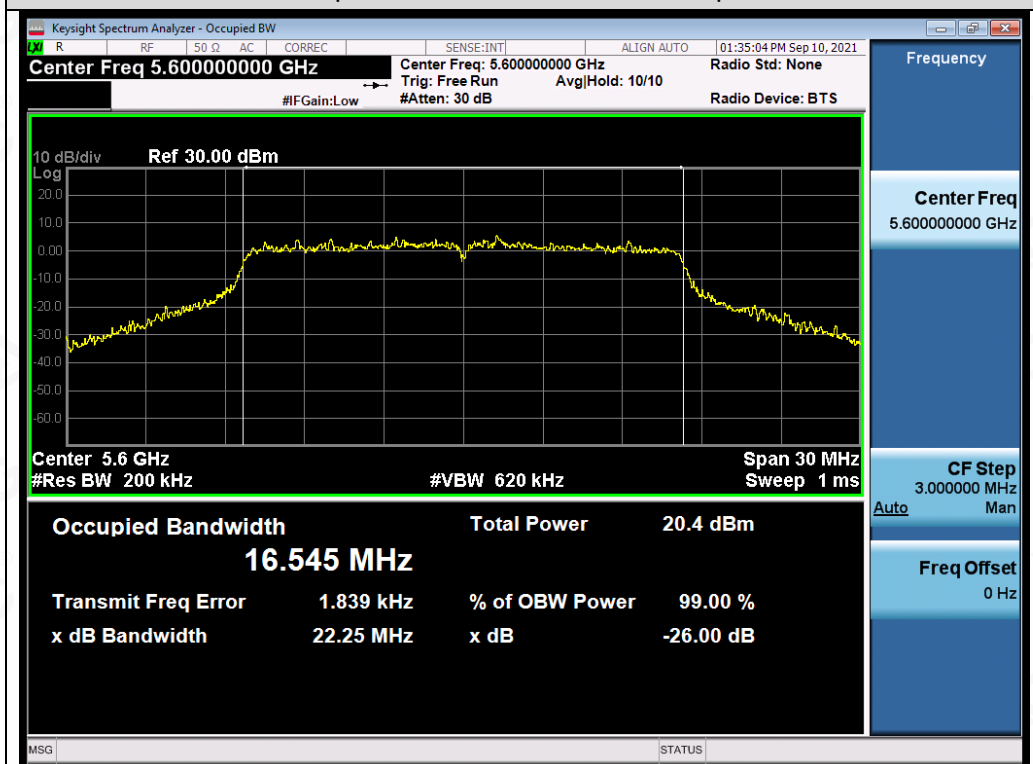
