#### 3.2 Requirement

Systems operating under the provisions of FCC 47 CFR section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy level in excess of the Commission's guidelines. Spatial averaging does not apply when MPE is estimated using simple calculations based on far-field planewave equivalent conditions.
