Paring

Find the Bluetooth name ' **GEARit ANC PRO** ' in the search list to connect it to your mobile or other Bluetooth devices.

Key Operating Instructions:

(1). Power key

Long press the button for 3 seconds to power on.

Long press the button for 3 seconds to power off.



During the music playing:

click power button once to play/pause music.

In Bluetooth connection mode, incoming call:

Short press to answer/end the call, long press to refuse incoming call.

Quick double press to activate the voice assistant.

(2). + key:

Long press :next song Short press: volume +

(3). - key:

Long press: previous song Short press: volume -

(4) ANC Key

Short press:Switch the noise reduction mode

(5) ULT

Short press: Switch between multiple sound effects (Note: switch freely only in normal mode)

Quick double click: 3D surround sound

(6) You can also insert in 3.5mm cable and connect your mobile with the headphone and listen to the music from your mobile or computer.
