

Install the Battery / バッテリーの取り付け

To install the battery / バッテリーの取り付け方法:

Step 1:
Insert the battery from the lower edge of the battery into the battery compartment.





Step 2:
Press down on the upper edge of the battery while holding the release latches on both sides.

手順2:
バッテリーの上部端を押しながら、両側のリリースレバーを押さえてください。

Step 3:
Firmly press down on the battery until a click is heard, ensuring the battery release latches are fully engaged with the RS38.



手順3:
バッテリーを確実に押し下げ、クリック音が聞こえるまで押し続け、バッテリーリリースレバーがRS38と完全に嵌合していることを確認してください。



Remove the Battery / バッテリーを取り外します

To remove the battery / バッテリーを取り外すには:

Press and hold the release latches on both sides to release the battery, and simultaneously lift the battery out to remove it.
両側のリリースレバーを押しながらバッテリーを持ち上げて、バッテリーを外してください。



Install SIM & SD Cards / SIM、SDカードの装着


To install the SIM and SD cards / SIMカードとSDカードを取り付けるには:

Step 1:
Pull out the SIM and SD card tray holder from the battery compartment.

手順1:
バッテリーコンパートメントからSIMカードおよびSDカードトレイホルダーを引き出してください。

Step 2:
Securely place the SIM card and SD card on the tray in the correct orientation.

手順2:
SIMカードとSDカードを正しい向きでトレイに置いてください。



Step 3:
Gently push the tray back into the slot until it fits into place.

手順3:
優しくトレイをスロットに戻し、しっかりとはまるまで押してください。

Note:
RS38 Mobile Computer only supports Nano SIM card, and the Wi-Fi only model does not support SIM card.


Charging & Communication / 充電と通信

By USB Type-C Cable :

Insert a USB Type-C Cable into the port at the bottom of the RS38 mobile computer. Connect the plug either to an approved adapter for external power connection, or to a PC/Laptop for charging or data transmission.
