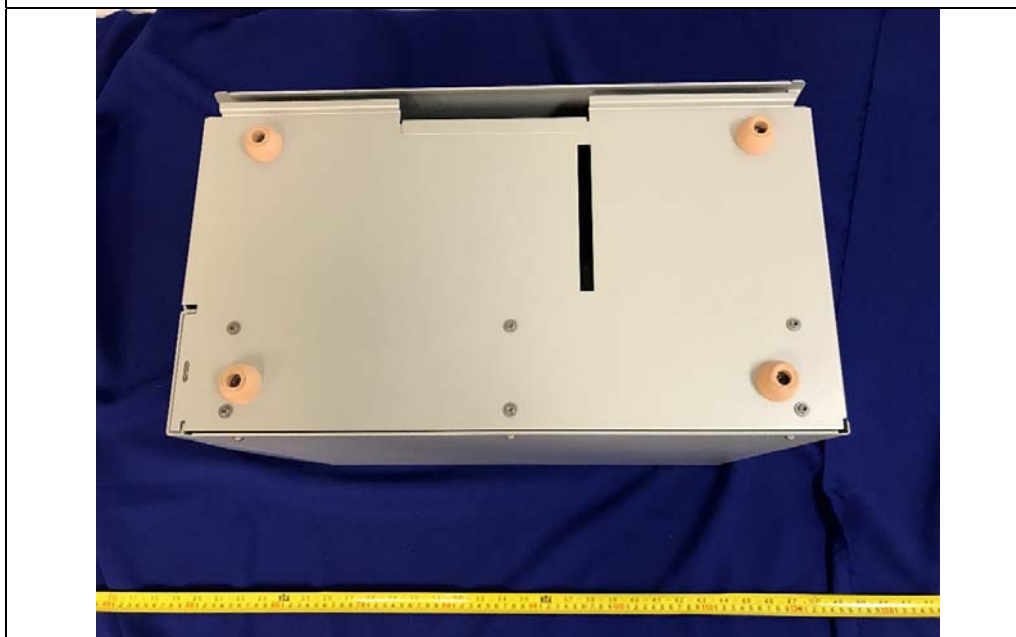

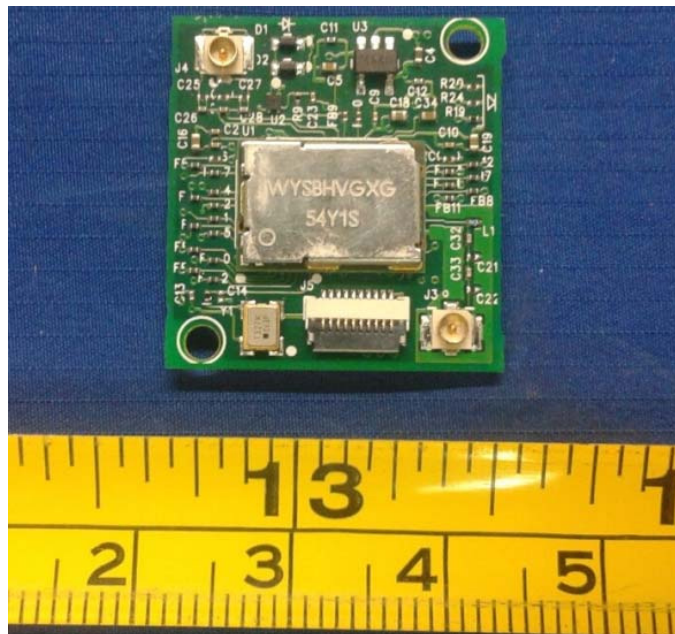

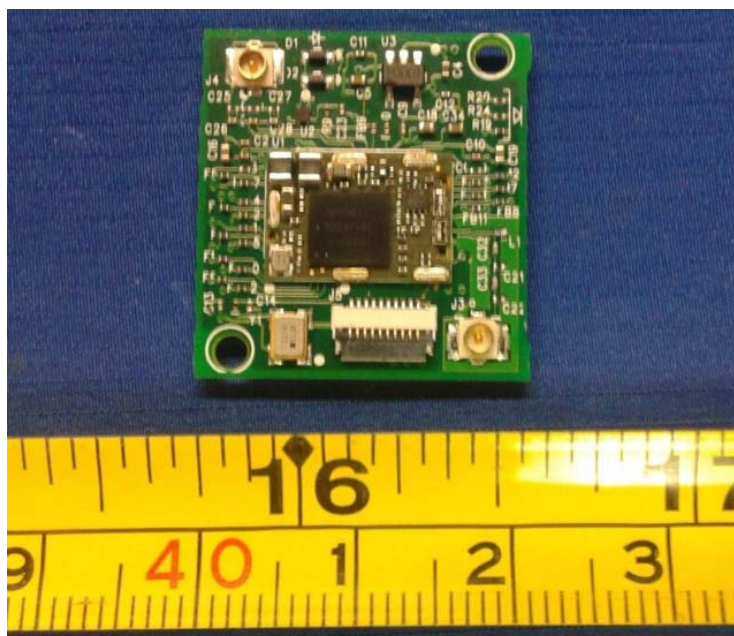

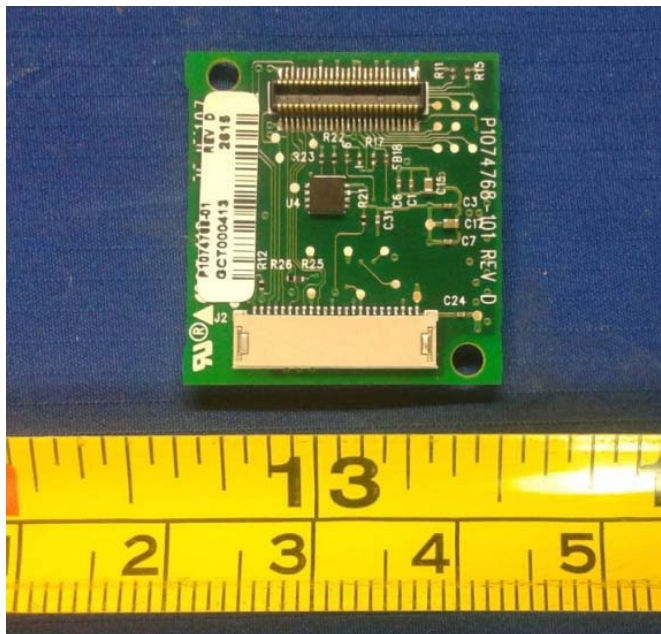
BLE module - Chip

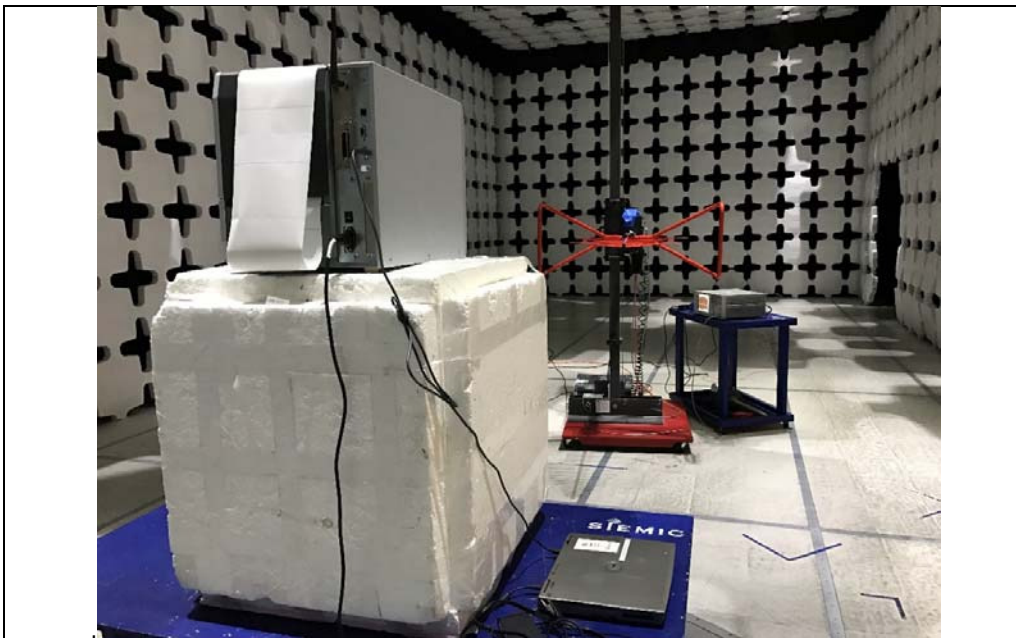


EUT Radio without Shielding Top View

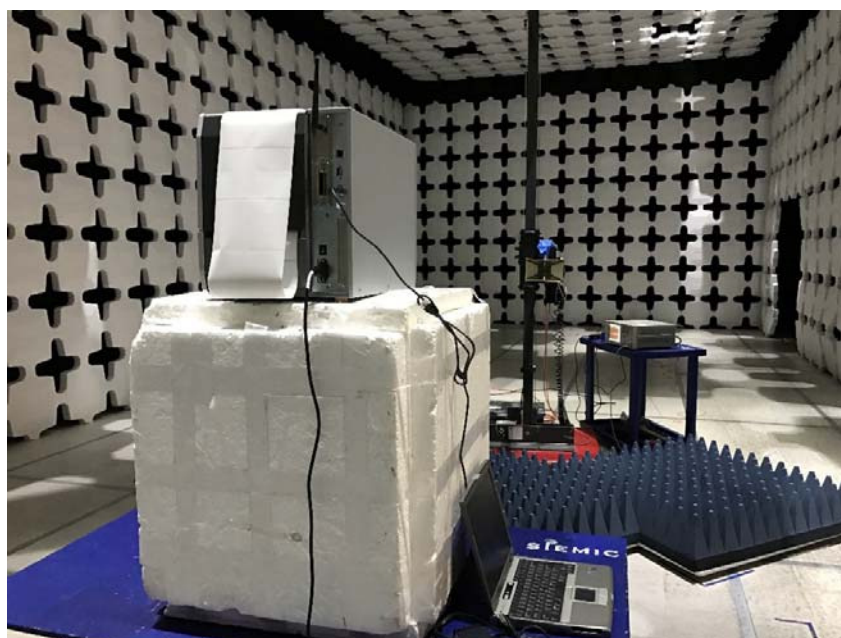
