



Series model: HKB1541-100C has a leather housing relative to the main model, HKB1551-100C has a lens and cloth shell relative to the main model, and HKB1561-100C has a cloth shell relative to the main model and a split aluminum bracket. 81092 is exactly the same as the main model but the name is different. The circuits and modules of these four models are the same as those of the series model and the main model. After differential testing, the main model has the worst test data, and only the worst test data is reflected in the test report.

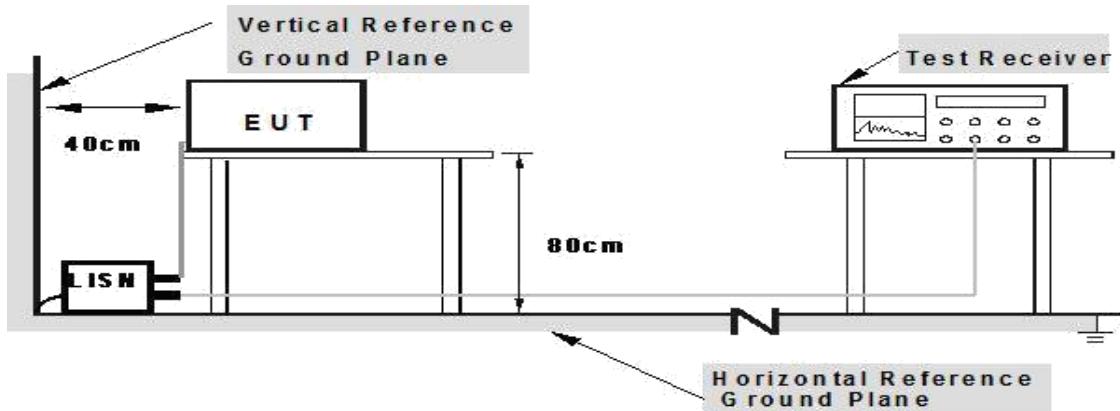

5.2.2 Test Procedures


- a) The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipment powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b) Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c) I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d) LISN is at least 80 cm from nearest part of EUT chassis.
- e) For the actual test configuration, please refer to the related Item – photographs of the test setup.





5.3.2 Test Procedures

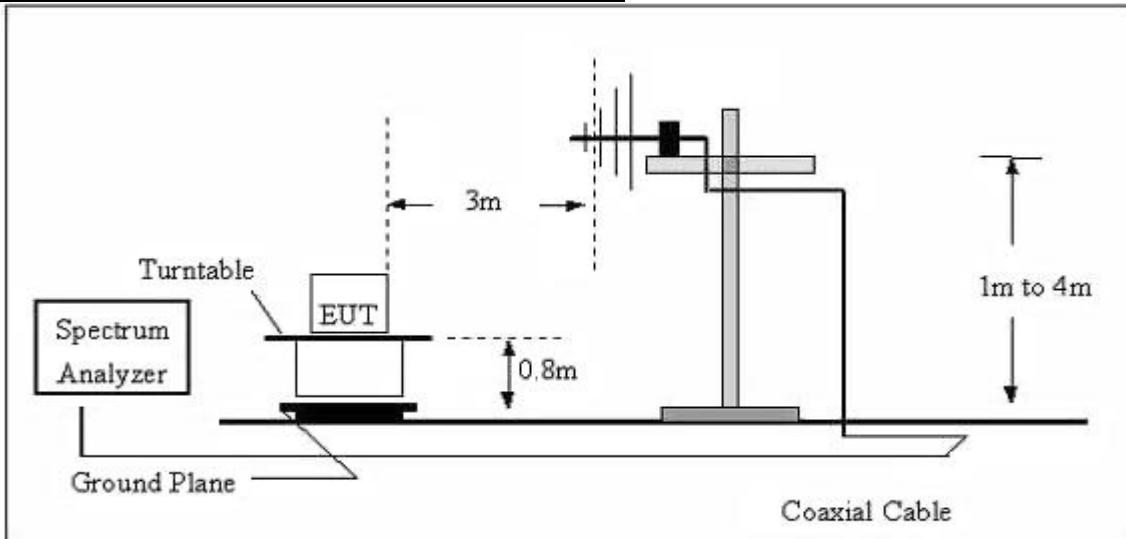
- a) The radiated emission tests were performed in the 3 meters.
- b) The EUT was placed on the top of a rotating table 0.8 meters above the ground. The table was rotated 360 degrees to determine the position of the highest radiation.
- c) The height of the test antenna shall vary between 1m to 4m. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d) If the peak mode measured value compliance with and lower than quasi peak mode limit, the EUT shall be deemed to meet QP limits and then no additional QP mode measurement performed.
- e) If the peak mode measured value compliance with and lower than average mode limit, the EUT shall be deemed to meet average limits and then no additional average mode measurement performed.
- f) For the actual test configuration, please refer to the related item – EUT test photos.

Radiated Emission Test-Up Frequency Below 30MHz




Radiated Emission Test-Up Frequency 30MHz~1GHz





5.4 Occupied Bandwidth

5.4.1 Test method

Use the following spectrum analyzer settings:

Span = approximately 2 to 3 times the 20 dB bandwidth, centered on a hopping channel

RBW \geq 1% of the 20 dB bandwidth

VBW \geq RBW

Sweep = auto

Detector function = peak


Trace = max hold

The EUT should be transmitting at its maximum data rate. Allow the trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. Use the marker-delta function to measure 20 dB down one side of the emission. Reset the marker-delta function, and move the marker to the other side of the emission, until it is (as close as possible to) even with the reference marker level. The marker-delta reading at this point is the 20 dB bandwidth and 99% occupied bandwidth of the emission.




