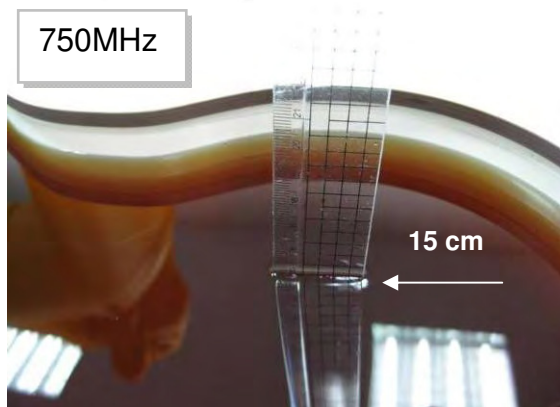

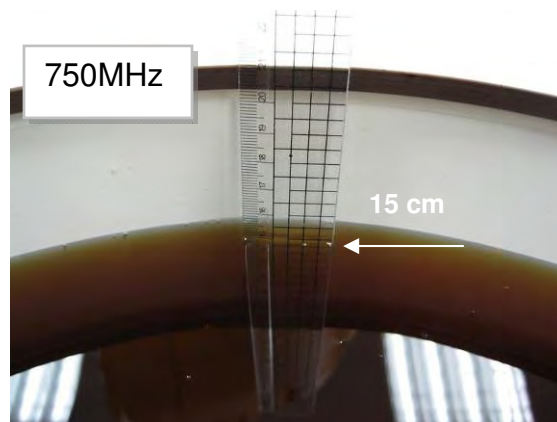

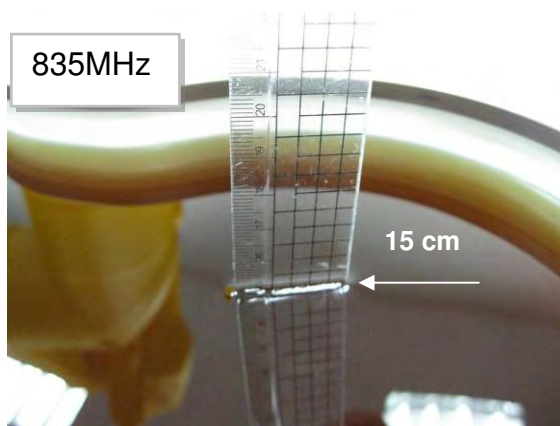

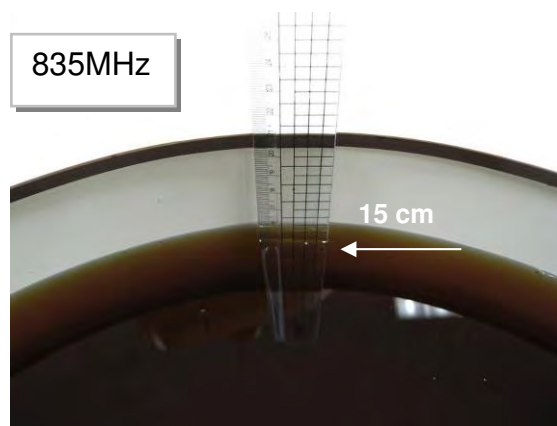

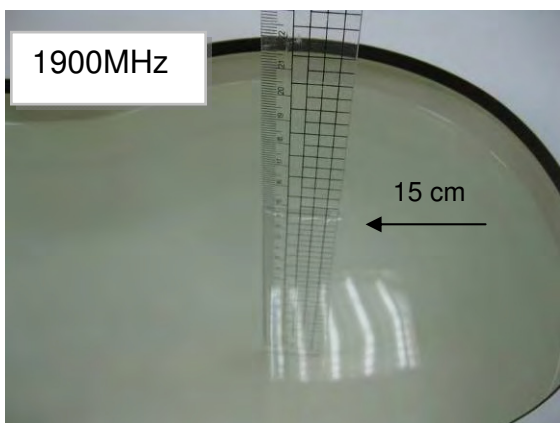

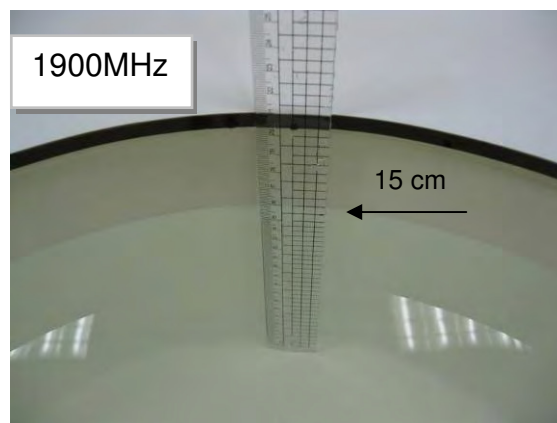

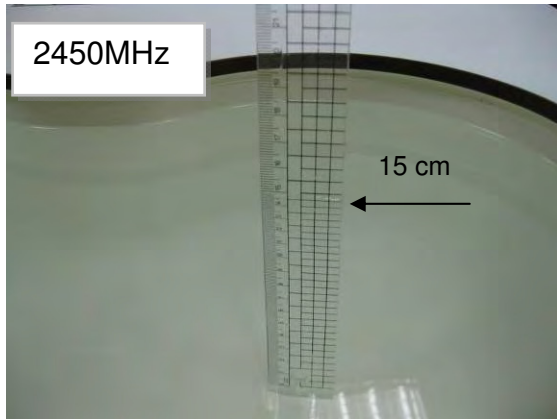

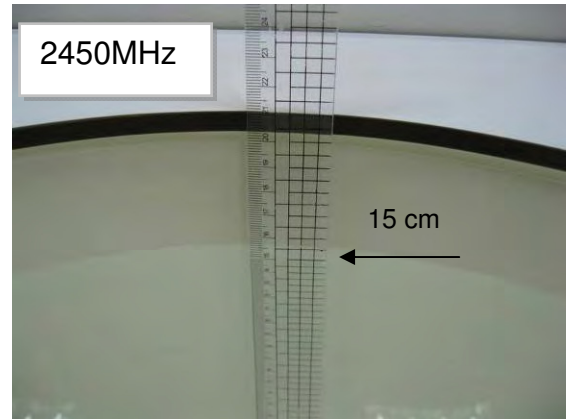

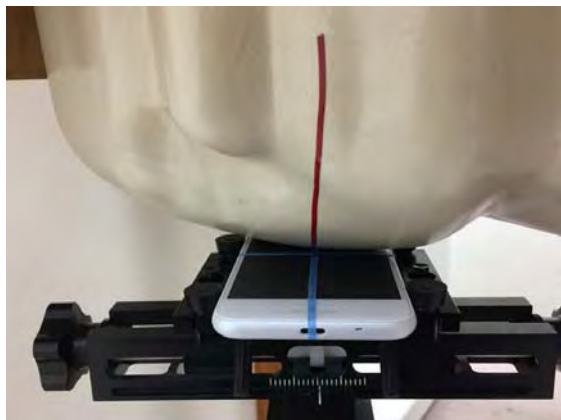


Fig.3 Right Head Section / Cheek-Touch Position

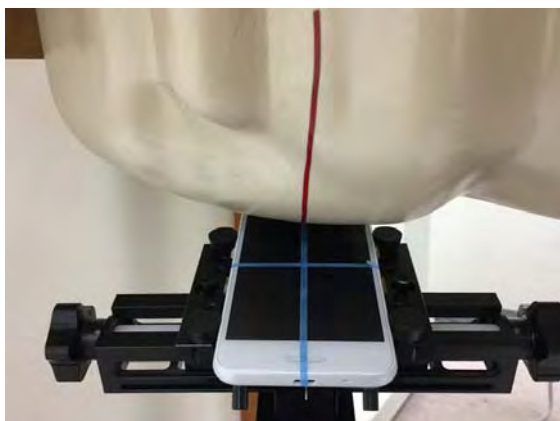
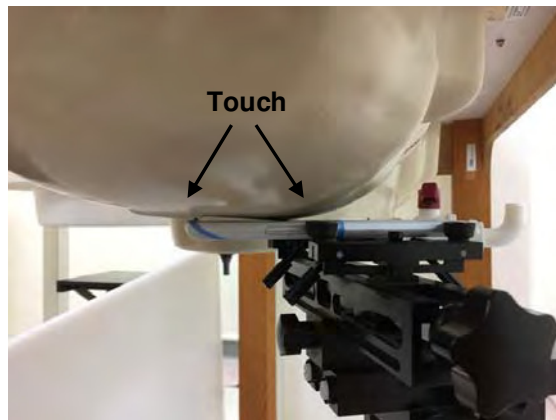


Fig.4 Right Head Section / Ear-Tilt Position(15°)

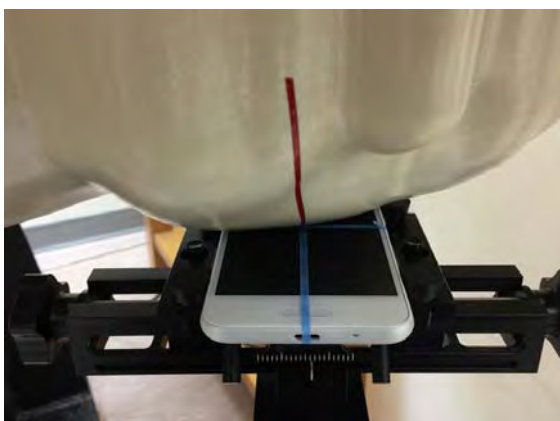
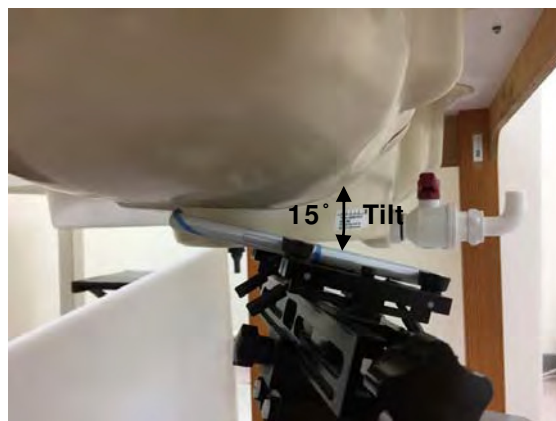
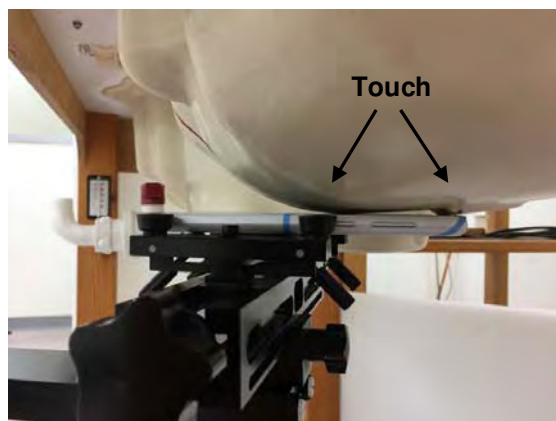


Fig.5 Left Head Section / Cheek-Touch Position

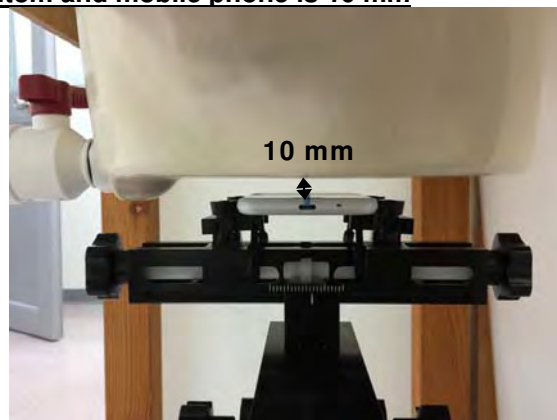

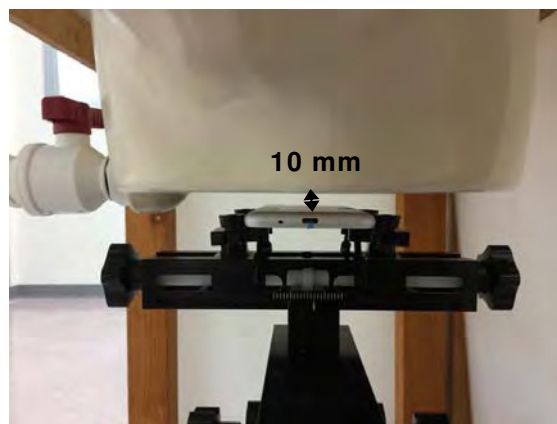

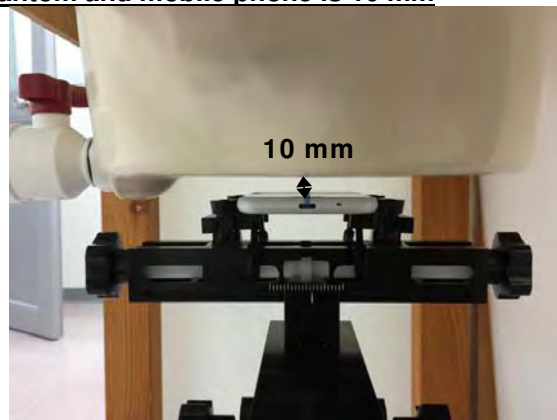

**Hotspot mode - distance between flat phantom and mobile phone is 10 mm**



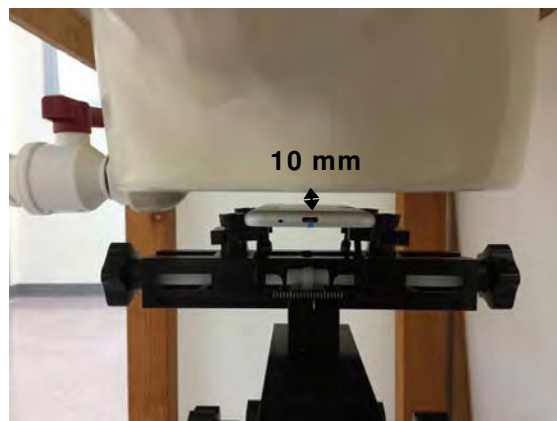
**Fig.9 EUT Front side to flat phantom**

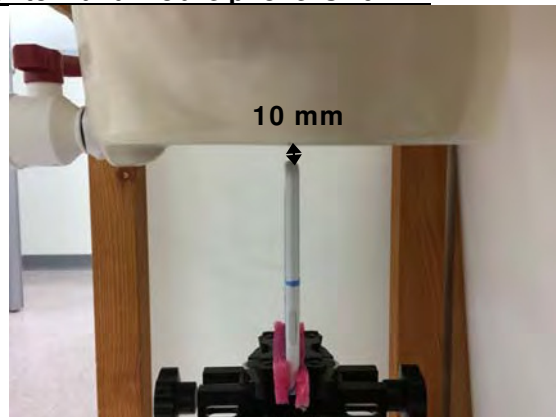

**Hotspot mode- distance between flat phantom and mobile phone is 10 mm**



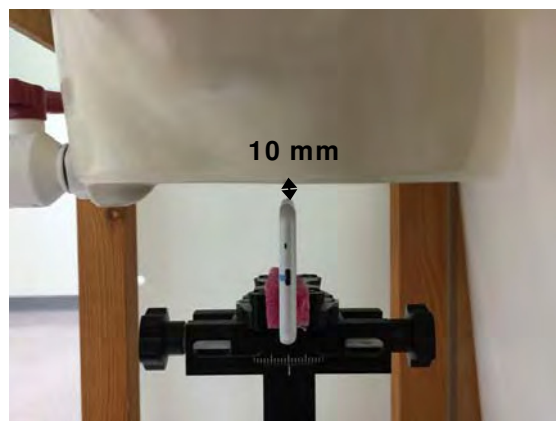
**Fig.12 EUT Bottom side to flat phantom**

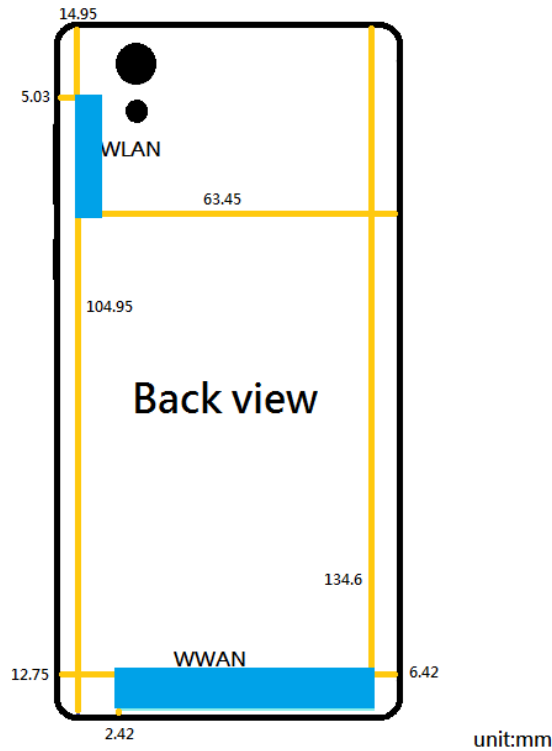


Fig.17 Antenna position of EUT
