


Hold mobile phone and push up against upper pull hook



1. First to use: The default mode is the Smart Frequency Conversion mode. Notice: 5V 2A or higher charger output is required.



2. Power Switch: Click can control the cooling fan on and off

### **Smart Frequency Conversion**

Cooling fan will auto adjust cooling power for safe use of your phone. It is recommended to use a 20W or above power charger, otherwise the maximum power cannot be activated

#### Fixed power

Cooling fan will auto adjust cooling power for safe use of your phone. It is recommended to use a 20W or above power charger, otherwise the maximum power can not be activated

#### Q&A

Q1: Is it necessary to pair with a charger without power of 27W and above?

A1: In order to active maximum power, we recommend to pair with.

Q2: Why does the Cooling fan suddenly stop working?

A2: When the temperature of the product is too high, the automatic protection mechanism will be

triggered, which will automatically stop working. Please put it in a cool place and make sure before

restarting.

Q3:Does B7 have battery inside?

Flydigi Mobile Cooling Fan B7 doesn't have battery inside does not support battery charging
