Chapter 1

Overview

EdgeHub

The Senceive EdgeHub is a multi-functional IP66/IP67 IoT Gateway product.

The EdgeHub contains the following radio products,

- cellular modem (2G/3G/4G), and
- FlatMesh (proprietary, 802.15.4 compliant).

Whilst running a custom flavour of embedded Linux on an agile, yet low powerful processor and platform, the EdgeHub enables operation with various sensors including Senceive FlexiMeasure and FlatMesh 4G Camera.

Complete with a 4G modem, a plethora of communications and power interfaces, and an on-board battery with optional PV panel, the unit connects to the closest 2G/3G/4G network out-of-the-box for off-site configuration during or after installation.

The EdgeHub also supports both traditional 2G networks (GSM) and 3G networks (UMTS).

This device has an internal Lithium-Ion battery, which will operate for 5 days when charged.

Your EdgeHub will be provided with either a power supply or solar panel to keep the internal battery charged.

Chapter 2

Installation

The EdgeHub will be delivered to you pre-configured. Simply affix the EdgeHub device to a structure and connect the sensor, (FlatMesh 4G Camera, FlexiMeasure via CAN, , IPI via RS485).

Mounting

The EdgeHub is supplied with a back-plate, fixing bracket which can be fixed to a wall or strapped onto a pole.



WARNING:

**The EdgeHub has a total approximate mass of 1.2kg.
Please ensure that the object you are fixing to can support this load.
Ensure that the appropriate methods and materials are used when
affixing equipment to a wall.**

The EdgeHub should be installed with the antennas uppermost. This is key to ensuring the best radio performance for both the FlatMesh network and for the cellular connection.

Wall Bracket

The tags at the top and bottom of the bracket may be used to affix the EdgeHub to a wall with screws (not supplied). The slots in the middle of the bracket may be used in conjunction with hose clamps (sometimes known as Jubilee clips) to secure the gateway to a horizontal or vertical pole.

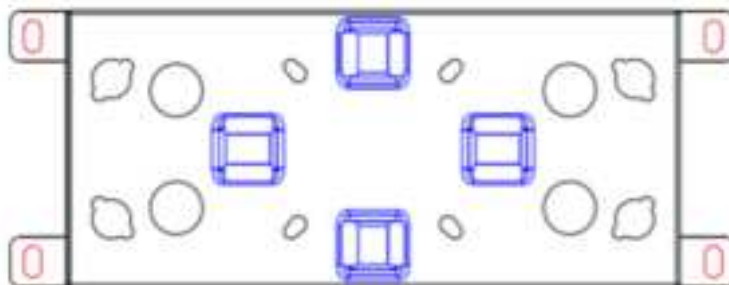


Figure 2.1: Wall Bracket

Earthing

The enclosure must be earthed if installed outdoors and powered from a mains power supply, or if the solar panel is publicly accessible after installation. Connect the earthing point on the rear of the enclosure to a grounded metal braid using an M4x0.7 screw.



NOTE

When selecting a screw for the earthing point, be aware that the hole on the enclosure is only 6mm deep. Fitting a screw which is too long may damage the device.

Power

The EdgeHub FM3H-LTE has an internal Lithium-Ion battery which when fully charged will allow the device to operate for 5 days.

For continued operation, you will have been supplied with either a solar panel or mains power supply.

The three-pin power input connector can be found at the bottom side of the unit, to the left of the human interface port.

Engage the power connector and turn the collar to lock in place.

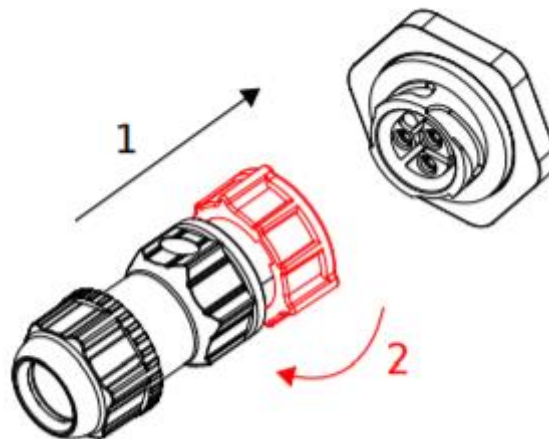


Figure 2.5: Power Connector

Antennae

There are two distinct antennae which must be connected to the correct N-type socket on the device.

The antenna/socket pairs are labelled **FlatMesh** and **Cellular**.

Check

It is very easy to accidentally cross-thread the antenna connection. Be sure to align the connectors properly before screwing together

The Antenna types for use with this device are as described below:

- The maximum gain of an FlatMesh antenna that is permitted to be used with the device is a 4dBi, 50ohm dipole for the 2.4 GHz radio.
- The 2.4GHz FlatMesh radio PCB will be used with the supplied:
 - OS-ISMDB-0507-C0 antenna.
- The cellular module shall be used with the supplied:
 - OS-LTE-11-C0 antenna.

Access Port

The multi-pin sensor interface port is located on the bottom of the gateway next to the power connector

The various sensors connect to the Data Port located on the bottom of the EdgeHub next to the power connector.

The standard to the 18-way EdgeHub connector enables connection of sensors using either a Serial (RS232 or RS485) connection; a CAN connection for Senceive FlexiMeasure, a USB connection for the FlatMesh 4G Camera or an ethernet connection for connecting to an Ethernet network or directly to a Laptop.

Chapter 3

Maintenance

The product should not require any maintenance after installation.

If the need to clean the product should arise, use only a damp cloth and mild detergent.

Do not use any solvents as this may damage the enclosure.

Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.
