


Figure 3.6-1: Setup diagram

## Section 8. Testing data

## 8.1 FCC 15.407(b) and RSS-247 6.2.1.2 Undesirable (unwanted) emissions

#### 8.1.1 Definitions and limits

### FCC §15.407 (b):

- (1) For transmitters operating in the 5.15–5.25 GHz band: all emissions outside of the 5.15–5.35 GHz band shall not exceed an EIRP of –27 dBm/MHz.
- (5) The emission measurements shall be performed using a minimum resolution bandwidth of 1 MHz. A lower resolution bandwidth may be employed near the band edge, when necessary, provided the measured energy is integrated to show the total power over 1 MHz.
- (6) Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in § 15.209.
- (7) The provisions of § 15.205 apply to intentional radiators operating under this section.
- (8) When measuring the emission limits, the nominal carrier frequency shall be adjusted as close to the upper and lower frequency block edges as the design of the equipment permits.

#### RSS-247 Section 6.2.1.2:

For transmitters operating in the band 5150–5250 MHz, all emissions outside the band 5150–5350 MHz shall not exceed –27 dBm/MHz e.i.r.p. However, any unwanted emissions that fall into the band 5250–5350 MHz must be 26 dBc, when measured using a resolution bandwidth between 1 and 5% of the occupied bandwidth, above 5.25 GHz. Otherwise, the transmission is considered as intentional and the devices shall implement dynamic frequency selection (DFS) and transmitter power control (TPC) as per the requirements for the band 5250–5350 MHz.

#### RSS-Gen Section 8.10:

Restricted bands, identified in table 6 of RSS-Gen Section 8.10, are designated primarily for safety-of-life services (distress calling and certain aeronautical bands), certain satellite downlinks, radio astronomy and some government uses. Except where otherwise indicated, the following restrictions apply:

- a. fundamental components of modulation of licence-exempt radio apparatus shall not fall within the restricted bands of below;
- b. unwanted emissions falling into restricted bands of below shall comply with the limits specified in RSS-Gen;
- c. unwanted emissions not falling within restricted frequency bands shall either comply with the limits specified in the applicable RSS, or with those specified in RSS-Gen.






Figure 8.1-1: Radiated – Undesirable (unwanted) emissions within restricted band at 5.15 GHz, peak (Channel 36 – 5180 MHz)




Figure 8.1-3: Radiated – Undesirable (unwanted) emissions at upper band edge, peak (Channel 48 – 5240 MHz)




Figure 8.1-4: Radiated – Undesirable (unwanted) emissions below 1 GHz, Channel 36 – 5180 MHz




Figure 8.1-5: Radiated – Undesirable (unwanted) emissions below 1 GHz, Channel 44 – 5220 MHz




Figure 8.1-6: Radiated – Undesirable (unwanted) emissions below 1 GHz, Channel 48 – 5240 MHz




Figure 8.1-7: Radiated – Undesirable (unwanted) emissions 1 to 18 GHz, Channel 36 – 5180 MHz




Figure 8.1-8: Radiated – Undesirable (unwanted) emissions 1 to 18 GHz, Channel 44 – 5220 MHz




Figure 8.1-9: Radiated – Undesirable (unwanted) emissions 1 to 18 GHz, Channel 48 – 5240 MHz




Figure 8.1-10: Radiated – Undesirable (unwanted) emissions 18 to 26 GHz, Channel 36 – 5180 MHz





Figure 8.1-11: Radiated – Undesirable (unwanted) emissions 18 to 26 GHz, Channel 44 – 5220 MHz



Figure 8.1-14: Radiated – Undesirable (unwanted) emissions 26 to 40 GHz, Channel 44 – 5220 MHz




Figure 8.1-15: Radiated – Undesirable (unwanted) emissions 26 to 40 GHz, Channel 48 – 5240 MHz




Figure 8.1-18: Radiated – Undesirable (unwanted) emissions setup photo – above 1 GHz

## 8.2 FCC 15.407(a)(1)(ii) and RSS-247 6.2.1.1 Power limits

#### 8.2.1 Definitions and limits

#### FCC §15.407:

- (a) Power limits:
  - (1) For the band 5.15-5.25 GHz.
    - (ii) For an indoor access point operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6 dBi. In addition, the maximum power spectral density shall not exceed 17 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

#### RSS-247 Section 6.2.1.1:

For OEM devices installed in vehicles, the maximum e.i.r.p. shall not exceed 30 mW or 1.76 + 10 log<sub>10</sub>B, dBm, whichever is less. Devices shall implement transmitter power control (TPC) in order to have the capability to operate at least 3 dB below the maximum permitted e.i.r.p. of 30 mW.

For other devices, the maximum e.i.r.p. shall not exceed 200 mW or 10 + 10 log<sub>10</sub>B, dBm, whichever power is less. B is the 99% emission bandwidth in megahertz. The e.i.r.p. spectral density shall not exceed 10 dBm in any 1.0 MHz band.


