### 1. Reference

### 3. MPE Calculation Method

Predication of MPE limit at a given distance

Equation from page 18 of OET Bulletin 65, Edition 97-01

$$S = \frac{PG}{4\pi R^2}$$

Where: S=power density

P=power input to antenna

G=power gain of the antenna in the direction of interest relative to an isotropic radiator

R=distance to the center of radiation of the antenna

### 4. Result

As declared by the Applicant, The device does not support using 2.4G WiFi and 5G transmission at the same time. the EUT is a wireless device used in a fix application, at least 20 cm from any body part of the user or nearby persons; from the maximum EUT RF output power, the minimum separation distance,  $r = 20\text{cm}$ , as well as the gain of the used antenna

2.4G WIFI is -0.62dBi, 5G WIFI 1.98dBi the RF power density can be obtained.
