2 SYSTEM TEST CONFIGURATION

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The Transmitter was operated in the normal operating mode. The Tx frequency was fixed which was for the purpose of the measurements.

2.3 Test Procedure

2.3.1 Conducted Emissions

The EUT is placed on a table which is 0.8 m above ground plane. Conducted emissions from the EUT measured in the frequency range between 9kHz and 30MHz. The CISPR Quasi-Peak and Average detector mode is employed. The two LISNs provide 50uH/50 ohm of coupling impedance for the measuring instrument. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.

2.3.2 Radiated Emissions

The EUT is placed on a turn table. For emissions testing at or below 1 GHz, the table height shall be 0.8 m above the reference ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for radiated emissions, measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.

2.3.3 Radiated Emission Test Sites For Measurements From 9 kHz To 30 MHz

Radiated emission below 30MHz is measured in a 9m*9m*6m semi-anechoic chamber,

the measurements correspond to those obtained at an open-field test site.

There is a comparison data of both open-field test site and semi-Anechoic chamber, and the result came out very similar.

The EUT stay in continuous transmitting mode. The frequency is the default channel to test, where it is the only manipulative channel as this application supports.

The field strength of radiation emission was measured as EUT three orthogonal plans, E1 / E2 / H, are positioned to pre-scan the emission generating the highest one. The worst position is tested, and recorded.

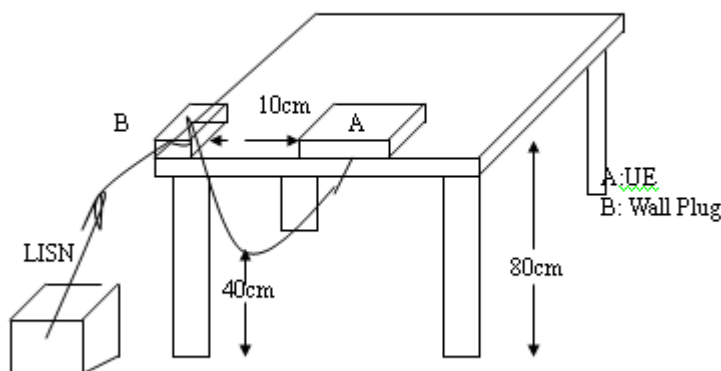

3. The LISN was connected with 120Vac/60Hz power source.

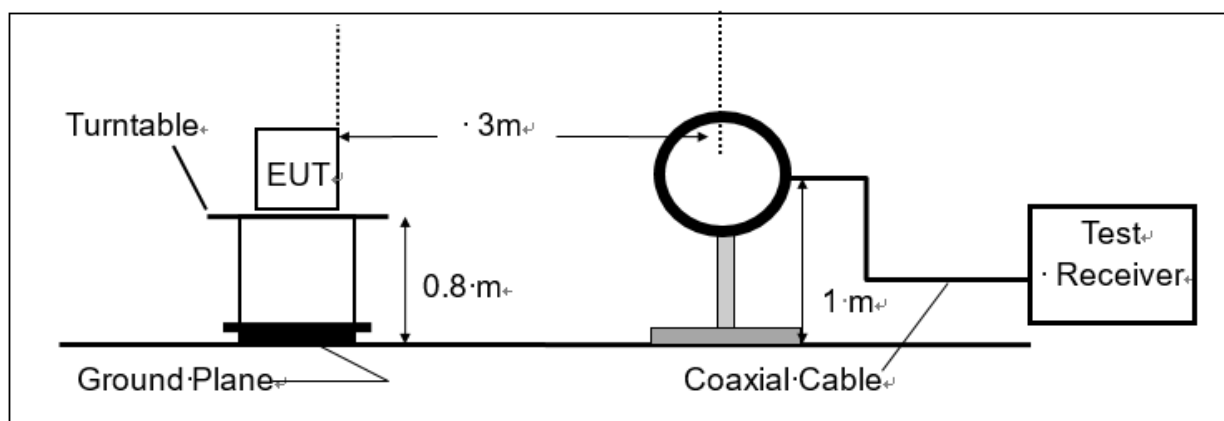

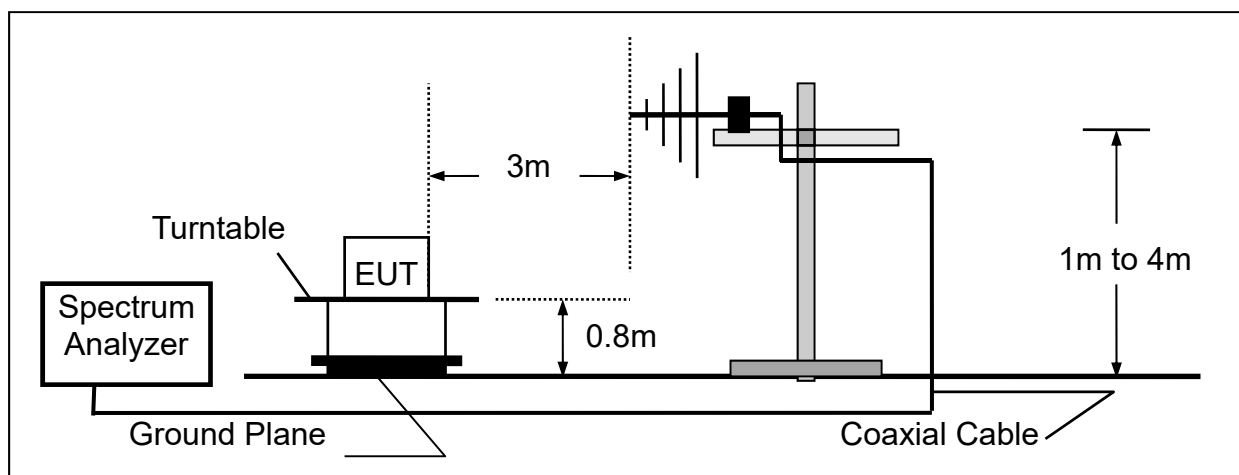
