#### **GENERAL INFORMATION**

#### **Product Description for Equipment under Test (EUT)**

The *Telecell Mobile (H.K) Ltd.*'s product, model number: F50G (FCC ID: 2ADX3F50G) or the "EUT" in this report was a *Mobile phone*, which was measured approximately:  $145.2 \text{ mm (L)} \times 73.2 \text{ mm (W)} \times 9.7 \text{ mm (H)}$ , rated with input voltage: DC 3.85V rechargeable Li-ion battery or DC 5.0V from adapter. The highest operating frequency is 2690 MHz.

#### **Objective**

This test report is prepared on behalf of *Telecell Mobile (H.K) Ltd.* in accordance with Part 2-Subpart J, Part 15-Subparts A and B of the Federal Communication Commissions rules.

The objective of the manufacturer is to determine the compliance of the EUT with FCC Part 15 B.

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.81 dB for 30MHz-1GHz, and 4.88 dB for above 1GHz, 1.95dB for conducted measurement.





The Corrected factor is calculated by adding LISN/ISN VDF (Voltage Division Factor), Cable Loss and Transient Limiter Attenuation. The basic equation is as follows:

Correction Factor = LISN VDF + Cable Loss + Transient Limiter Attenuation





## **Measurement Uncertainty**

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.



Based on CISPR 16-4-2:2011, the expended combined standard uncertainty of radiation emissions at Bay Area Compliance Laboratories Corp. (Shenzhen) is 5.81 dB for 30MHz-1GHz and 4.88 dB for above 1GHz, 1.95dB for conducted measurement at antenna port. 

The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2014. The specification used was the FCC Part 15.109 Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

#### **EMI Test Receiver Setup**

The system was investigated from 30 MHz to 13.45 GHz.

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.

#### **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain
