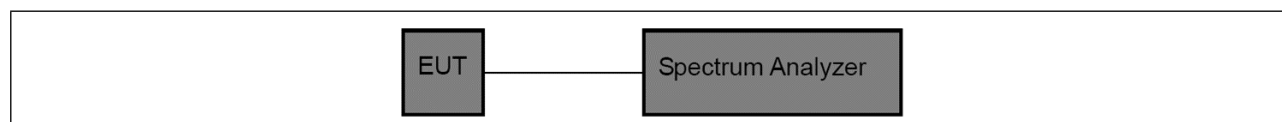
## 7. Number of Hopping Frequencies

Test Requirement:	47 CFR 15.247(a)(1)(iii)
