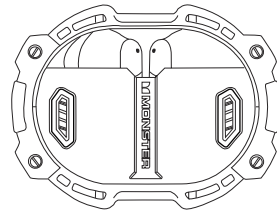

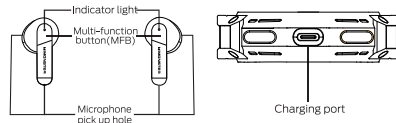

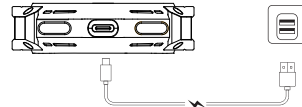

Charge the charging case

Connect the charging case to the 5V power adapter with Type-C charging cable.



Rated input:5V = 30mA(Headphone)Rated input:5V = 300mA(charging case)

Tips: When the ice blue indicator flashes while closing the cover, please charge in time,

Indicator guide

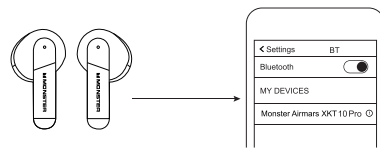
Mode	Description	Voice prompt
Power on	Headphone ice blue indicator flash for 1 second	"Power on"
Power off	Headphone red indicator flash 3 times	"Power off"
Pairing	The earphone flashes red and blue alternately	"Pairing"
Connected	Headphone indicator off	"Connected"
Disconnected	The earphone flashes red and blue alternately	"Disconnected"
Low Battery	The red light flashes once every 5 seconds	"Low Battery"
Headphones placed in charging case	The red light of the earphone is always on, but it goes out when it is full	—
Charging case low power	Ice blue indicator flashing	—
Charging case charged	Yellow light flashing	—
Charging case fully charged	The yellow light is permanently on	—

Product operating instructions

- Power on
Method 1:Take out the headphones from charging case, the headphones will turn on automatically.
Method 2: Long press MFB for 3 seconds.
- Power off
Method 1: Put the headphones into the charging case and close the cover.
Method 2: After disconnected from the bluetooth device for 3 minutes.

- Pairing
Method 1:Take out the headphones from the charging case, the headphones will start pairing automatically.
Method 2: Search and click for "Monster Airmars XKT 10 Pro" on the bluetooth list of the smart device, and when connection is successful, "Connected" will be heard.

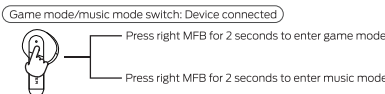
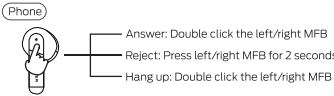
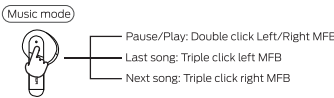
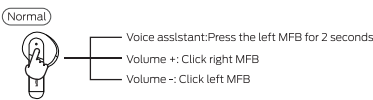
* If the distance is exceeded, return to the effective distance within 3 minutes after disconnection, and automatically connect the device.

- * After charging, please pull out the charging cable to avoid equipment damage caused by long-time charging.

Key functions

Either headphones is not connected to the bluetooth device when turned on, click the MFB 5 times to clear the previous pairing information and turn off,

Precautions

- 1.Headphones will turn on automatically (needless to press any button) pair and connect the device when the charging case is opened, After placing the headphones in the charging case, they will turn off and automatic charging will start when the cover is closed.
 - 2,Charging every 15 days will extend battery life when not in use often, Cleaning off dirt on the charging contacts by cotton swabs with alcohol will maintain a good contact for charging.
 - 3,Keep battery (battery pack) away from inflammables or excessive heat such as direct sunlight.
 - 4, Due to the wireless connection mode of this product, in the daily use process, influenced by the environment, mobile phone brand, usage behavior and other factors, it is normal that there may be a brief and slight sound delay in the process of playing music.
- #### Warnings
- 1, Do not use headphones at high volume for an extended period of time.
 - 2, Keep the headphones away from dust and water.
 - 3, Do not disassemble the headphones and accessories, otherwise warranty will be voided
 - 4, Keep headphones away from any impact or vibration,
