

### **Charging Mode**



① Make sure the wireless charger dock connect to the power supply.

② Put the smartphone/Airpods/Apple Watch properly on the transmitter.

#### Notes

- 1. Do not squeeze or collisions.
- 2. Do not disassemble or throw into fire or water, to avoid causing a short
- 3. Do not use wireless charger in severely hot, humid or corrosive environments, to avoid circuit damage and occurs leakage phenomnon. 4. Do not place too close with magnetic stripe or chip card (ID card, bank cards, etc. ) to avoid magnetic failure.
- 5. Please keep the distance at least 20cm between implantable medical devices ( pacemakers, implantable cochlear, etc. ) and the wireless charger, to avoid potential interference with the medical device.
- 6. To take care of the children, to ensure that they won't play the wireless charger as a toy, to avoid unnecessary accidents.
