Warranty Conditions

This product is guaranteed for 2 years against defects in manufacturing or assembly.

This guarantee only applies to the primary purchase by the end user. It does not cover issues related to improper handling by the user. Proof of purchase is required in order to render the warranty valid.

The warranty does not cover problems associated with improper use, whether it is a result of negligence, processing, failure to store properly (excessive heat or humidity), improper installation or unauthorized repairs.

The manufacturer is contractually required to repair or replace the defective product. ALTEC LANSING is under no financial obligation to pay any amount in excess of that paid by the end user.

Reasons for warranty exclusions:

SAFETY PRECAUTIONS

Read these safety instructions before using your device and store them for possible future reference.

- The device is not intended for use by persons (including children) with reduced physical, sensory or mental capacity. Persons who have not read the manual, unless they have received explanations by a person responsible for their safety and supervision should not use this unit.

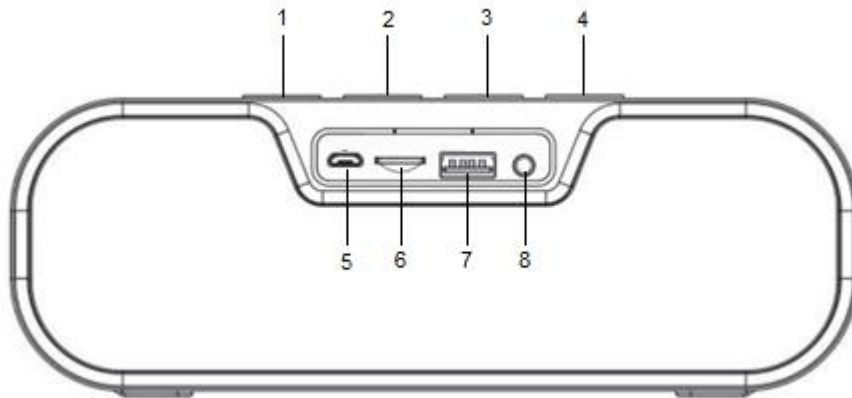

Charging

Connect the supplied micro USB cable into the input “5”. Speaker can be charged either by connecting to a computer’s USB port or a standalone 5V/1A charger. During charging the LED will glow red, when it is fully charged the LED will go off.

NOTICE: To maintain maximum resistance against splashing water, make sure that the silicone sealing cap is firmly pushed into the body of the speaker.

On/Off

- To turn the speaker on and off, press and hold the “1” button.

Pairing (connection with the device)

- Make sure the battery is fully charged and press “1”. The LED will flash blue.
- Activate the “Bluetooth” function on your phone and make sure that your phone is visible to the nearby Bluetooth devices.
- Select “Search” and then choose “HydroBeast” from the available list. If a PIN code is required, enter the code “0000”.
- Successful pairing is notified by an audible signal and the LED glows blue steadily.

Switching between modes: Bluetooth/Music playback from a micro memory card / AUX output

- Press the “1” button to switch between individual modes.

Hands Free, “3” button

- Press to: Accepting an incoming call
- Press and hold to: Rejecting an incoming call
- Double press to: Redial the last called phone number

Music Playback

- Press to: Play / Pause

AUX output

You can also listen to music when the 3.5” audio cable (included) is connected. In this mode, you cannot control the tracks with the speaker buttons.

Buttons I< / >I “2” a “4”

- Press to: Next / Previous
- Press and hold to: Increase / decrease the volume

Power Bank - charging external devices

- Press 2 seconds the “3” button twice (speaker may not be on) when you 1st use.
- Connect for example a mobile phone into the slot “7” with a micro USB cable.
- It will automatically start to charge the phone.
