3.4. Test Procedure

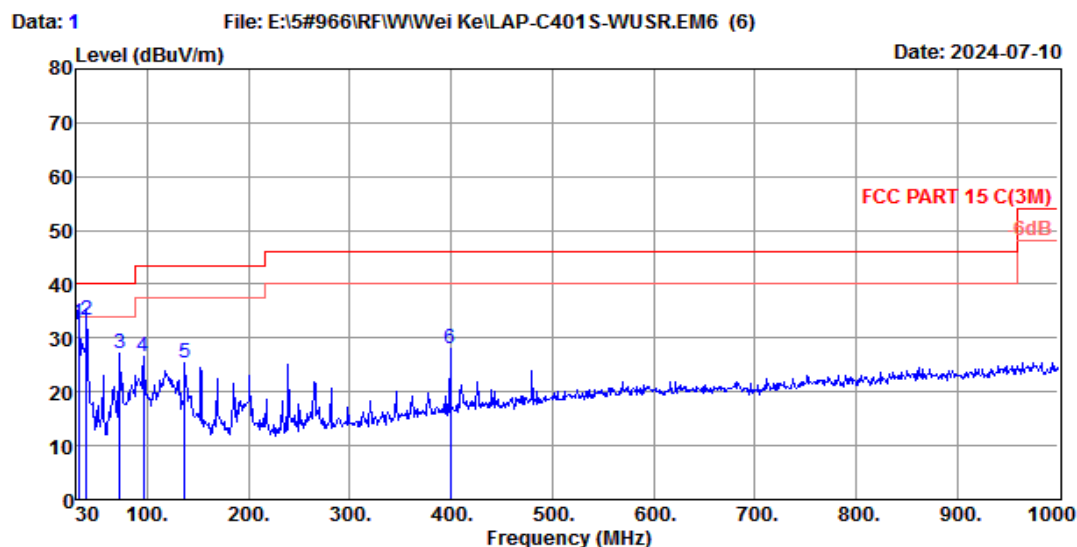
- EUT was placed on a turn table, which is 0.8 meter high above ground for below 1GHz test.
- EUT is set 3 meters away from the receiving antenna, which is mounted on a antenna tower.
- Set the EUT transmit continuously with maximum output power.
- The turn table can rotate 360 degrees to determine the position of the maximum emission level.
- The antenna can be moved up and down between 1 meter and 4 meters to find out the maximum emission level. Both horizontal and vertical polarization of the antenna are set on test.
- Spectrum analyzer setting parameters in accordance with section 3.3.
- Repeat above procedures until all channels and test modes were measured.
- Record the results in the test report.

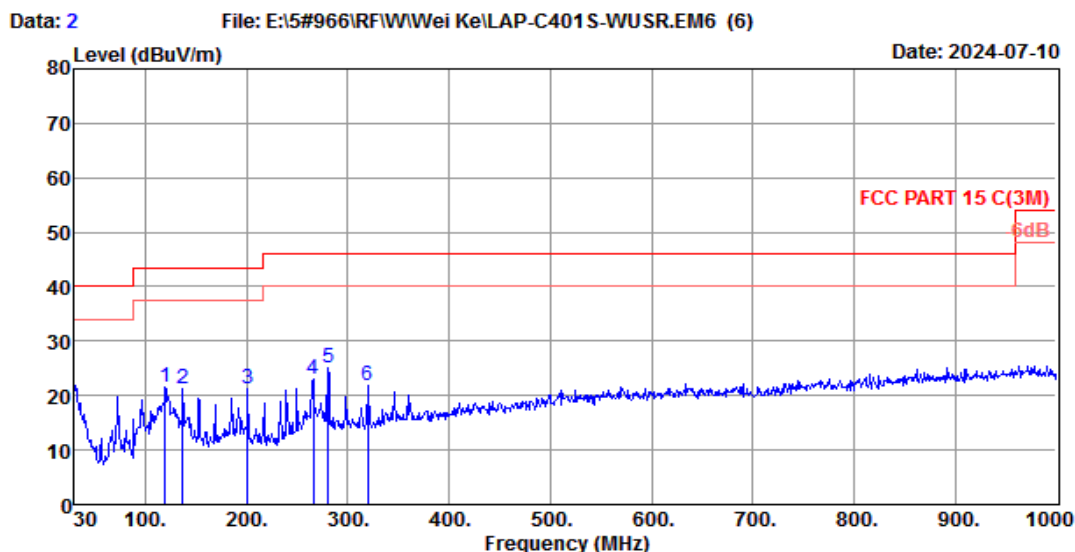

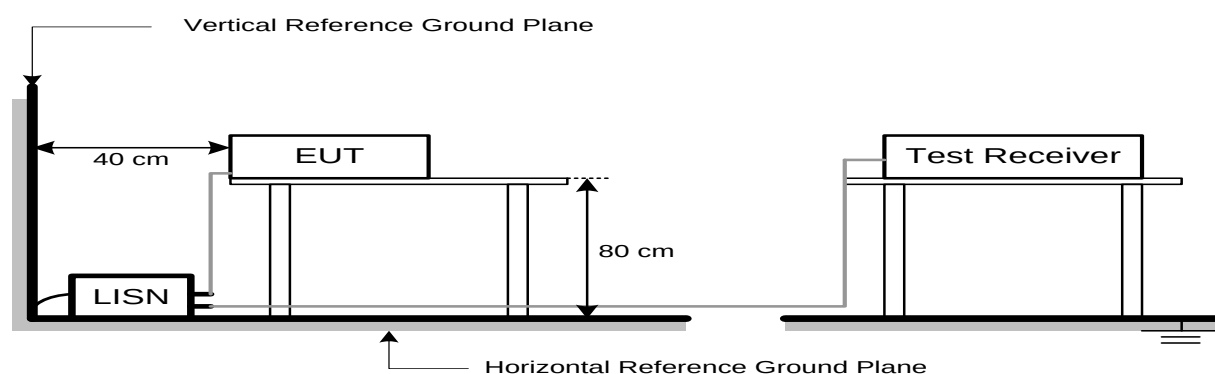

- a. The EUT was placed on a non-metallic table, 80cm above the ground plane.
- b. The EUT Power connected to the power mains through a line impedance stabilization network.
- c. Provides a 50 ohm coupling impedance for the EUT (Please refer the block diagram of the test setup and photographs).
- d. Set the EUT transmit continuously with maximum output power.
- e. Spectrum analyzer setting parameters in accordance with section 4.3.
- f. The AC line are checked to find out the maximum conducted emission. In order to find the



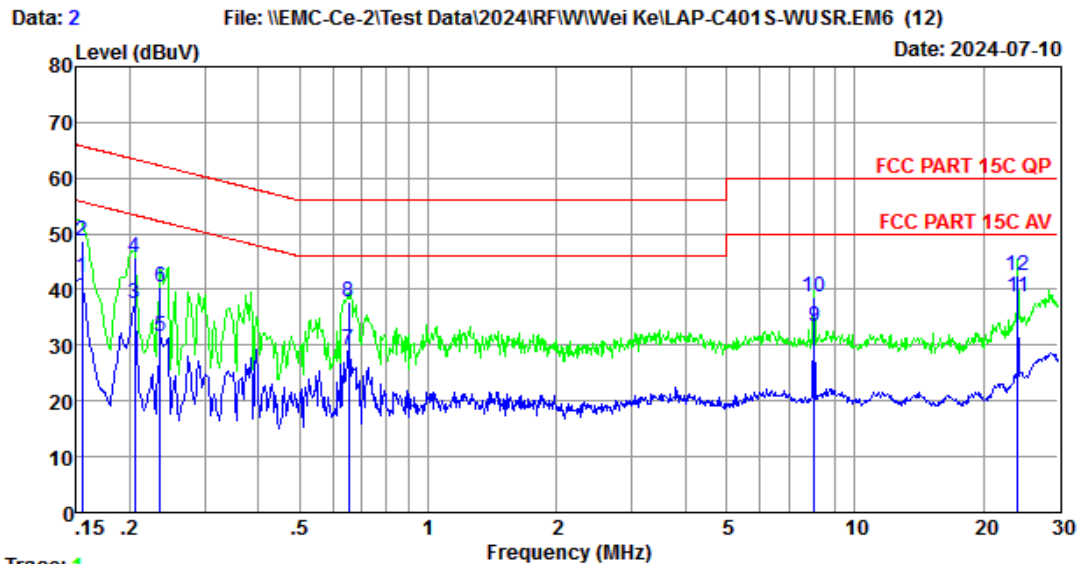
maximum emission levels, the relative positions of equipment and all of the interface cables shall be changed according to ANSI C63.10: 2013 on Conducted Emission Test.

- g. Record the results in the test report.

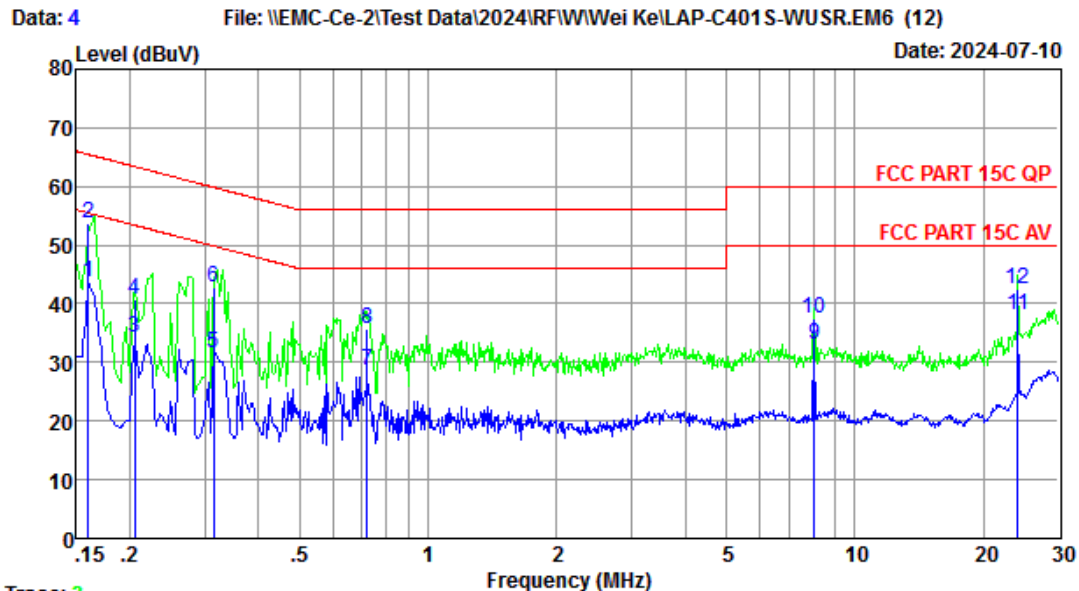

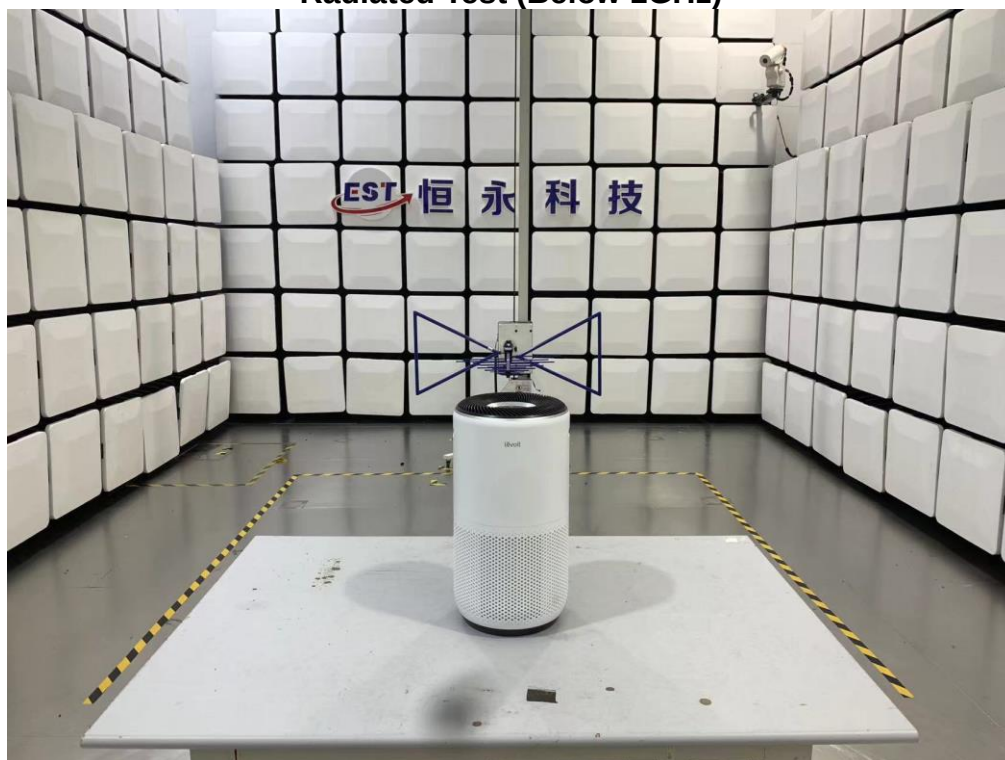

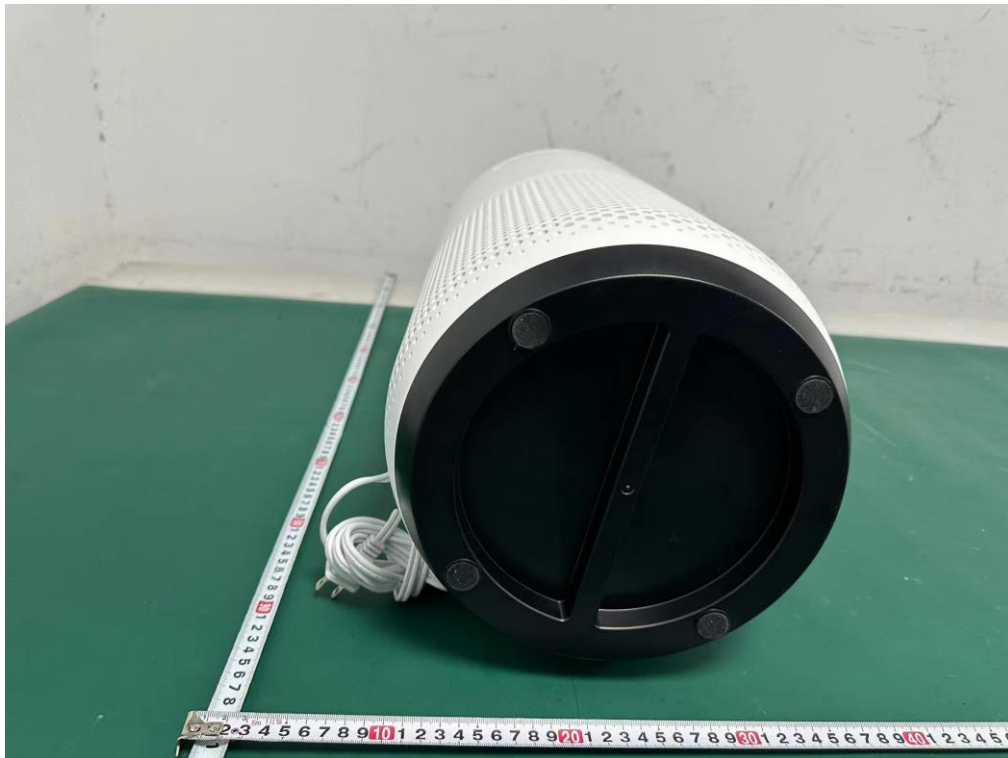


Radiated Test (Below 1GHz)
