







4.1.1. Limit

For a Low-power Radio-frequency Device which is designed to be connected to the AC power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed below limits table.



4.1.3. Test Procedures

- Configure the EUT according to ANSI C63.4. The EUT or host of EUT has to be placed 0.4 meter far
 from the conducting wall of the shielding room and at least 80 centimeters from any other
 grounded conducting surface.
- 2. Connect EUT or host of EUT to the power mains through a line impedance stabilization network (LISN).
- 3. All the support units are connected to the other LISNs. The LISN should provide 50uH/50ohms coupling impedance.
- 4. The frequency range from 150 KHz to 30 MHz was searched.
- 5. Set the test-receiver system to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- 6. The measurement has to be done between each power line and ground at the power terminal.

- If cables, which hang closer than 40 cm to the horizontal metal groundplane, cannot be shortened to appropriate length, the excess shall be folded back and forth forming a bundle 30 cm to 40 cm long.
- 2. Excess mains cord shall be bundled in the centre or shortened to appropriate length.
- 3. EUT is connected to one artificial mains network (AMN). All AMNs and ISNs may alternatively be connected to a vertical reference plane or metal wall.
- 4. All other units of a system are powered from a second AMN. A multiple outlet strip can be used for multiple mains cords.
- 5. AMN and ISN are 80 cm from the EUT and at least 80 cm from other units and other metal planes.
- 6. Mains cords and signal cables shall be positioned for their entire lengths, as far as possible, at 40 cm from the vertical reference plane.

- 10. The end of the I/O signal cables which are not connected to an AE may be terminated, if required, using correct terminating impedance.
- 11. If used, the current probe shall be placed at 0,1 m from the ISN.





4.2. Maximum Peak Output Power Measurement

4.2.1. Limit

For frequency hopping systems operating in the 2400-2483.5 MHz band employing at least 75 non-overlapping hopping channels, the limit for peak output power is 30dBm. The limited has to be reduced by the amount in dB that the gain of the antenna exceed 6dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.



4.3. Hopping Channel Separation Measurement

4.3.1. Limit

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater.








20 dB Bandwidth Plot on Channel 0 / 2402 MHz

20 dB Bandwidth Plot on Channel 39 / 2441 MHz






20 dB Bandwidth Plot on Channel 78 / 2480 MHz



Channel Separation Plot on Channel $0\sim1$ / 2402 MHz ~2403 MHz






Channel Separation Plot on Channel $39\sim40$ / 2441 MHz ~2442 MHz





Frequency hopping systems in the 2400-2483.5 MHz band shall use at least 15 channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed.


4.5.3. Test Procedures

- 1. The transmitter output (antenna port) was connected to the spectrum analyser
- 2. Set RBW of spectrum analyzer to 1000kHz and VBW to 1000kHz.
- 3. Use a video trigger with the trigger level set to enable triggering only on full pulses.
- 4. Sweep Time is more than once pulse time.
- Set the center frequency on any frequency would be measure and set the frequency span to zero span.
- 6. Measure the maximum time duration of one single pulse.
- 7. Set the EUT for DH5, DH3 and DH1 packet transmitting.
- 8. Measure the maximum time duration of one single pulse.
- 9. DH5 Packet permit maximum 1600/79/6 = 3.37 hops per second in each channel (5 time slots RX, 1 time slot TX). So, the dwell time is the time duration of the pulse times $3.37 \times 31.6 = 106.6$ within 31.6 seconds
- 10. DH3 Packet permit maximum 1600 / 79 / 4 = 5.06 hops per second in each channel (3 time slots RX, 1 time slot TX). So, the dwell time is the time duration of the pulse times $5.06 \times 31.6 = 160$ within 31.6 seconds.
- 11. DH1 Packet permit maximum 1600 / 79 / 2 = 10.12 hops per second in each channel (1 time slot RX, 1 time slot TX). So, the dwell time is the time duration of the pulse times $10.12 \times 31.6 = 320$ within 31.6 seconds.








DH5 Dwell Time Plot on Channel 0 / 2402 MHz








DH1 Dwell Time Plot on Channel 0 / 2402 MHz



DH5 Dwell Time Plot on Channel 39 / 2441 MHz






DH3 Dwell Time Plot on Channel 39 / 2441 MHz



DH1 Dwell Time Plot on Channel 39 / 2441 MHz






DH5 Dwell Time Plot on Channel 78 / 2480 MHz


DH3 Dwell Time Plot on Channel 78 / 2480 MHz


Configure the EUT according to ANSI C63.4. The EUT was placed on the top of the turntable 0.8
meter above ground. The phase center of the receiving antenna mounted on the top of a
height-variable antenna tower was placed 3 meters far away from the turntable.

- 2. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
- 3. The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
- 4. For each suspected emissions, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
- 5. Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
- 6. For emissions above 1GHz, use 1MHz VBW and RBW for peak reading. Then 1MHz RBW and 10Hz VBW for average reading in spectrum analyzer.
- 7. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. As an alternative (provided the transmitter operates for longer than 0.1 seconds) or in cases where the pulse train exceeds 0.1 seconds, the measured field strength shall be determined from the average absolute voltage during a 0.1 second interval during which the field strength is at its maximum value.
- 8. If the emissions level of the EUT in peak mode was 3 dB lower than the average limit specified, then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions which do not have 3 dB margin will be repeated one by one using the quasi-peak method for below 1GHz.
- 9. For testing above 1GHz, the emissions level of the EUT in peak mode was lower than average limit (that means the emissions level in peak mode also complies with the limit in average mode), then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.
- 10. In case the emission is lower than 30MHz, loop antenna has to be used for measurement and the recorded data should be QP measured by receiver. High Low scan is not required in this case.


