一、看家宝如何重置(Reset)?

How to reset your Snowman? 在摄像机通电的情况下,按压一下主机背面的重置按键,此时主机正面指示灯会变为蓝灯,约30s 后听到摄像机发

出"等待安装"提示音,则重置完成。 Plug the reset pin(which is contained in the package) into the reset hole that is on the rear side of the Snowman.Then, press the reset key and wait for about 30 seconds for the snowman to reset and prompt "Ready for installation"
