The antenna is a Monopole Antenna which permanently attached, and the best case gain of the antenna is -7.1 dBi. It complies with the standard requirement.

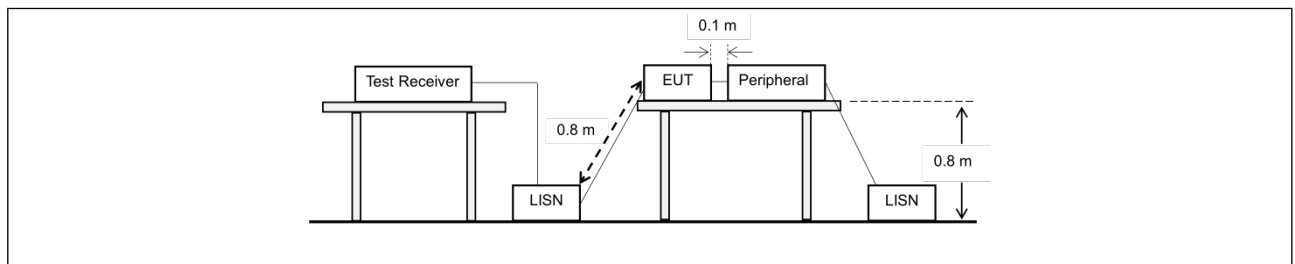

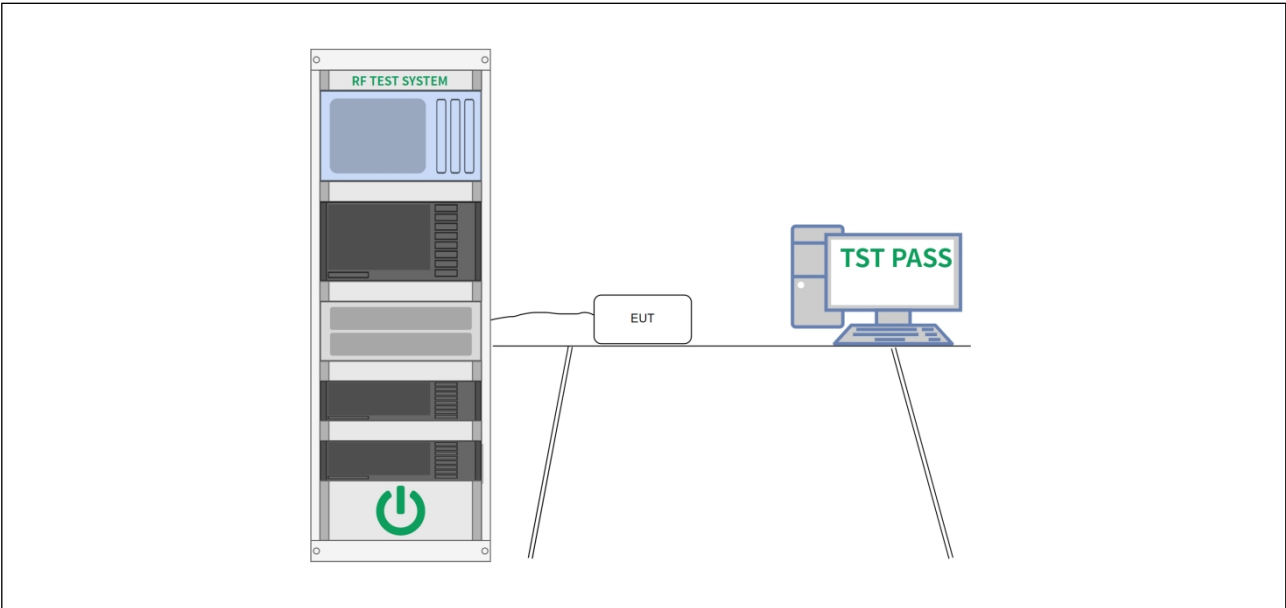
4. 20dB Bandwidth
