### 4 MEASUREMENT METHOD

The IEEE 1528, OET 65 Bulletin C and CEI/IEC 62209 standards provide requirements for reference dipoles used for system validation measurements. The following measurements were performed to verify that the product complies with the fore mentioned standards.

## 4.1 RETURN LOSS REQUIREMENTS

The dipole used for SAR system validation measurements and checks must have a return loss of -20 dB or better. The return loss measurement shall be performed against a liquid filled flat phantom, with the phantom constucted as outlined in the fore mentioned standards.

## 4.2 MECHANICAL REQUIREMENTS

The IEEE Std. 1528 and CEI/IEC 62209 standards specify the mechanical components and dimensions of the validation dipoles, with the dimensions frequency and phantom shell thickness dependent. The COMOSAR test bench employs a 2 mm phantom shell thickness therefore the dipoles sold for use with the COMOSAR test bench comply with the requirements set forth for a 2 mm phantom shell thickness.




Figure 1: Validation Waveguide Dimensions


## SAR MEASUREMENT PLOTS @ 5400 MHz







## SAR MEASUREMENT PLOTS @ 5600 MHz



## BODY SAR MEASUREMENT PLOTS @ 5200 MHz









## BODY SAR MEASUREMENT PLOTS @ 5400 MHz







## BODY SAR MEASUREMENT PLOTS @ 5600 MHz
