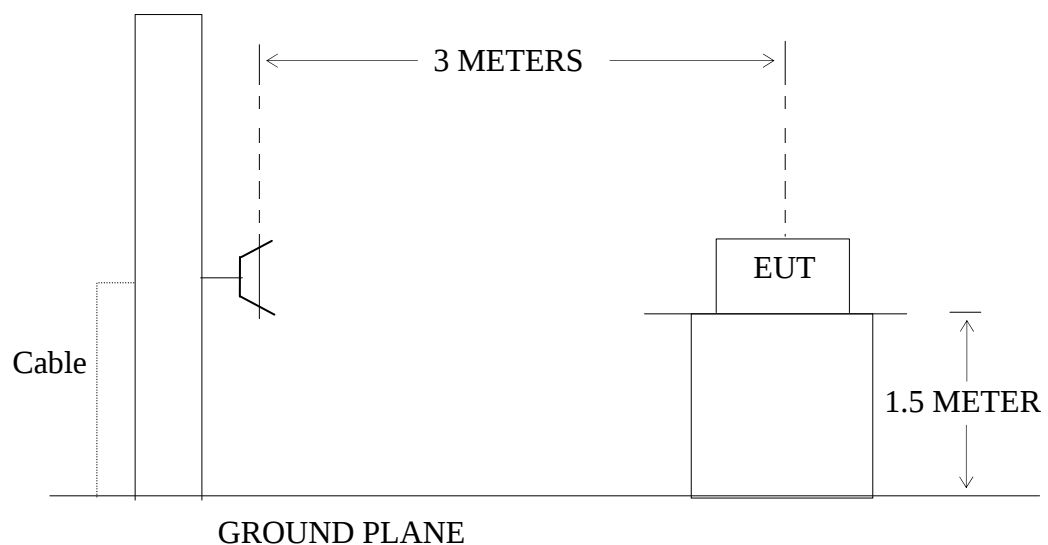
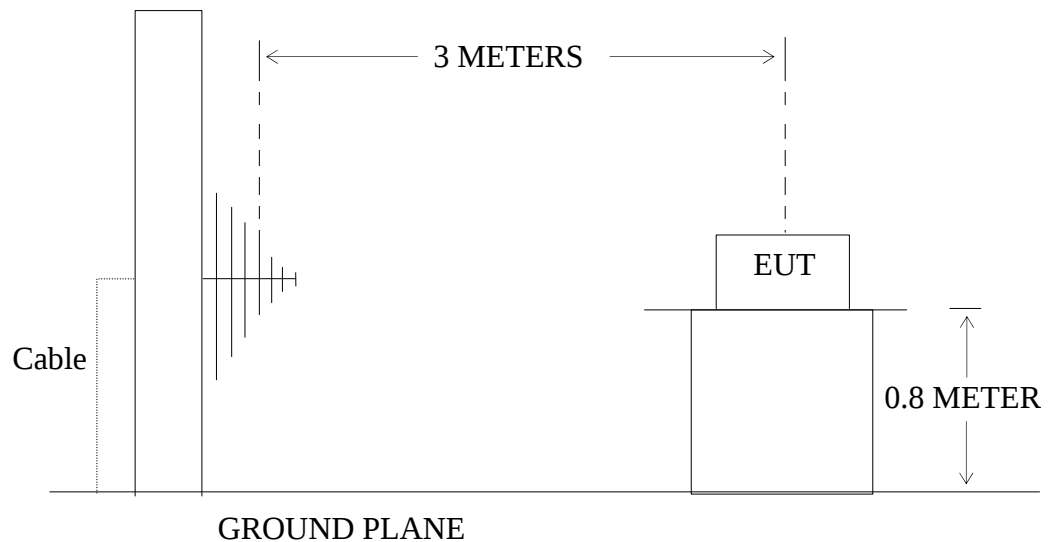

Where F is the frequency in MHz, the formulas for calculating the maximum permitted fundamental field strengths are as follows: for the band 130-174 MHz, $\mu\text{V/m}$ at 3 meters = $56.81818(F) - 6136.3636$; for the band 260-470 MHz, $\mu\text{V/m}$ at 3 meters = $41.6667(F) - 7083.3333$. The maximum permitted unwanted emission level is 20 dB below the maximum permitted fundamental level.

4.5. Test Procedure

The EUT and its simulators are placed on a turntable, which is 0.8 meter high above ground. The turntable can rotate 360 degrees to determine the position of the maximum emission level. EUT is set 3.0 meters away from the receiving antenna, which is mounted on an antenna tower. The antenna can be moved up and down between 1.0 meter and 4 meters to find out the maximum emission level. Broadband antenna (calibrated bilog antenna) is used as receiving antenna.

For emission measurements above 1 GHz, the EUT shall be placed at a height of 1.5 m above the floor on a support that is RF transparent for the frequencies of interest. The turntable can rotate 360 degrees to determine the position of the maximum emission level. EUT is set 3.0 meters away from the receiving antenna, which is mounted on an antenna tower. The antenna can be moved up and down between 1.0 meter and 4 meters to find out the maximum emission level. Both horizontal and vertical polarizations of the antenna are set on measurement. In order to find the maximum emission levels, all of the interface cables must be manipulated according to ANSI C63.10: 2013 on radiated emission measurement. The EUT was tested in 3 orthogonal planes.

The bandwidth of test receiver is set at 120 kHz in 30-1000 MHz, and 1 MHz in 1000-4000 MHz.

The frequency range from 30 MHz to 4000 MHz is checked.

1. Emissions attenuated more than 20 dB below the permissible value are not reported.
2. The field strength is calculated by adding the antenna factor, high pass filter loss(if used) and cable loss, and subtracting the amplifier gain(if any)from the measured reading. The basic equation calculation is as follows:
Result = Reading + Corrected Factor
Where Corrected Factor = Antenna Factor + Cable Loss + High Pass Filter Loss – Amplifier Gain

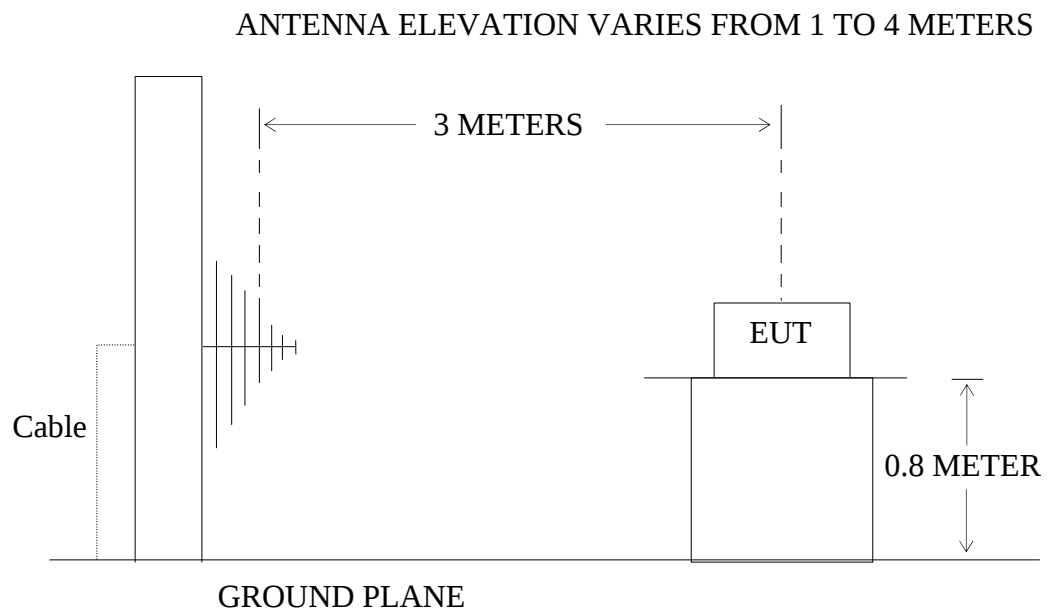

The bandwidth of emission shall be no wider than 0.25% of the center frequency. Therefore, the bandwidth of the emission limit is $315 \text{ MHz} \times 0.25\% = 787.5 \text{ kHz}$. Bandwidth is determined at the two points 20 dB down from the top of modulated carrier.

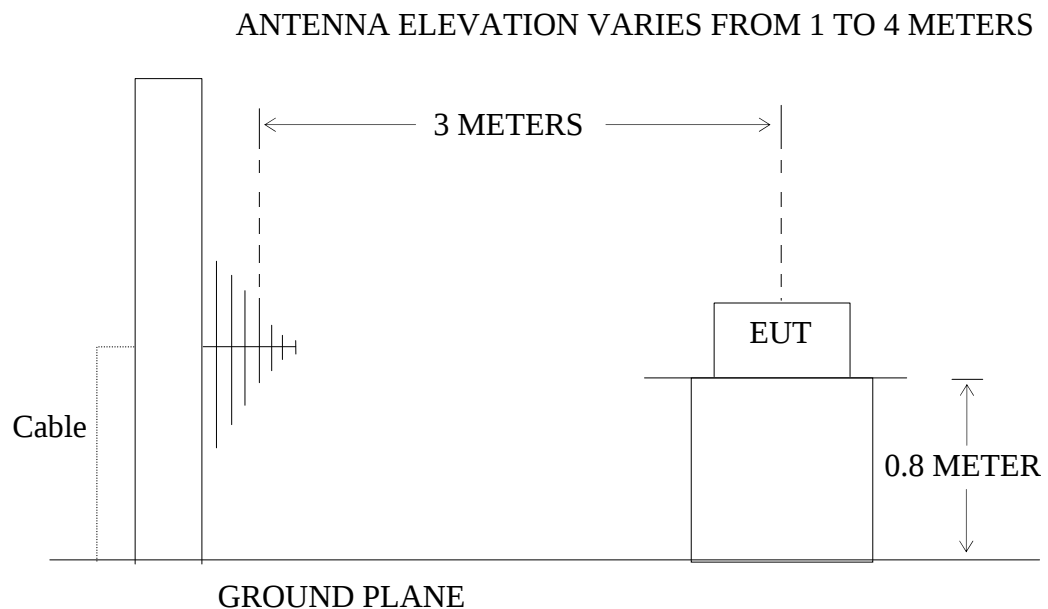

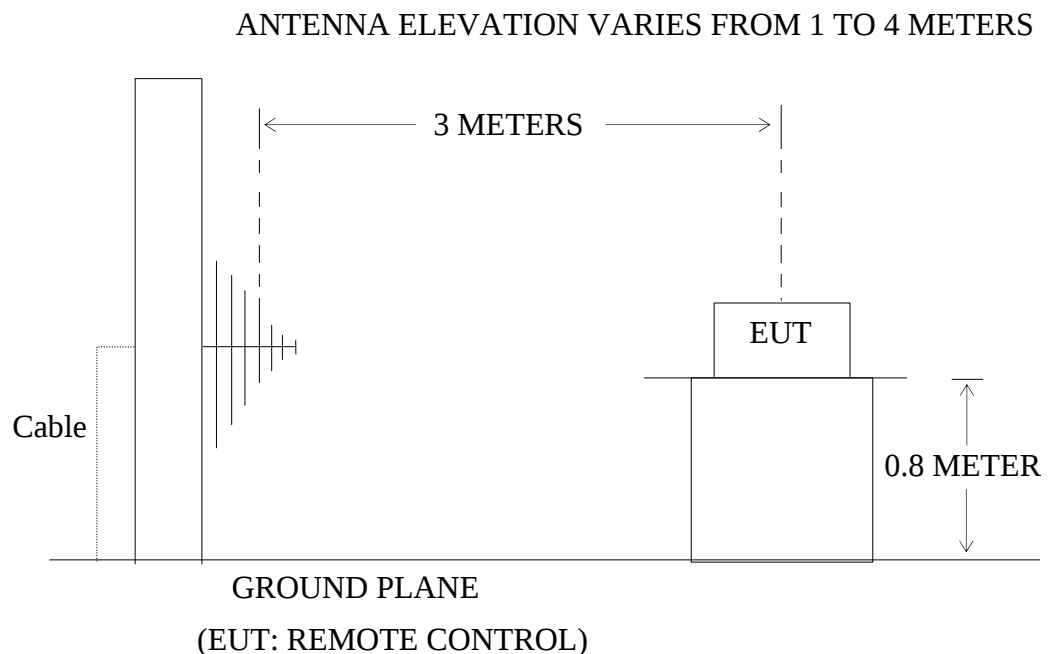

7.2. Average factor Measurement according to ANSI C63.10-2013

ANSI C63.10-2013 Section 13.4.2 Devices transmitting pulsed emissions and subject to a limit requiring an average detector function for radiated emissions shall initially be measured with an instrument that uses a peak detector. A radiated emission measured with a peak detector may then be corrected to a true average using the appropriate factor for emission duty cycle. This correction factor relates the measured peak level to the average limit and is derived by averaging absolute field strength over one complete pulse train that is 0.1 s, or less, in length. If the pulse train is longer than 0.1 s, the average shall be determined from the average absolute field strength during the 0.1 s interval in which the field strength is at a maximum.

Average factor in dB = $20 \log (\text{duty cycle})$

Effective period of the cycle = $(0.391 \times 23) + (0.768 \times 3)$ ms = 11.297 ms

DC = $11.297\text{ms} / 31.884\text{ms} = 0.354$

Therefore, the average factor is found by $20\log 0.354 = -9.01\text{dB}$

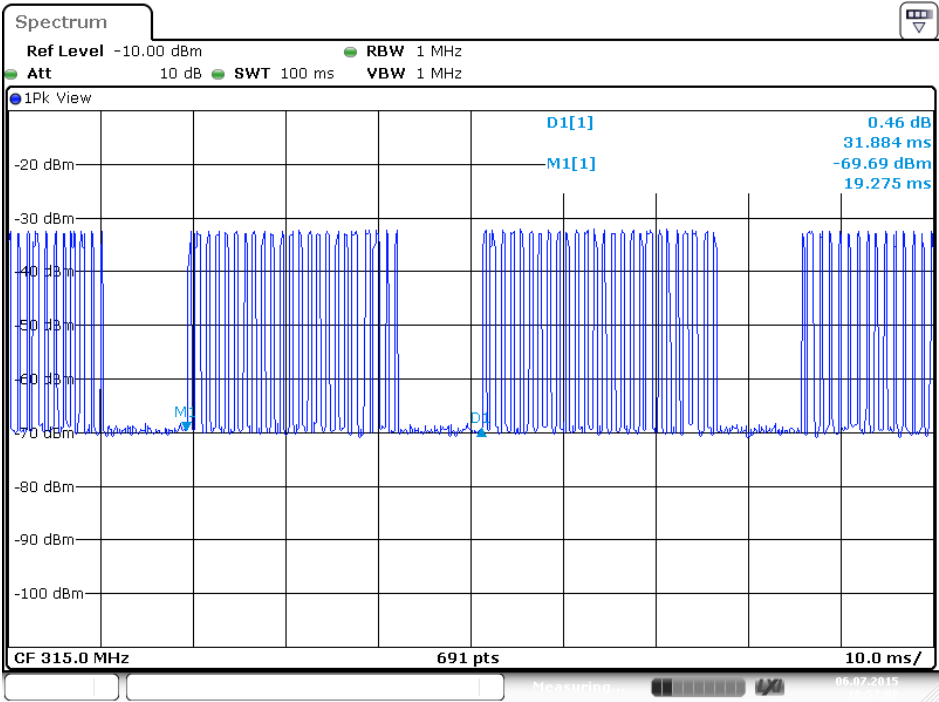

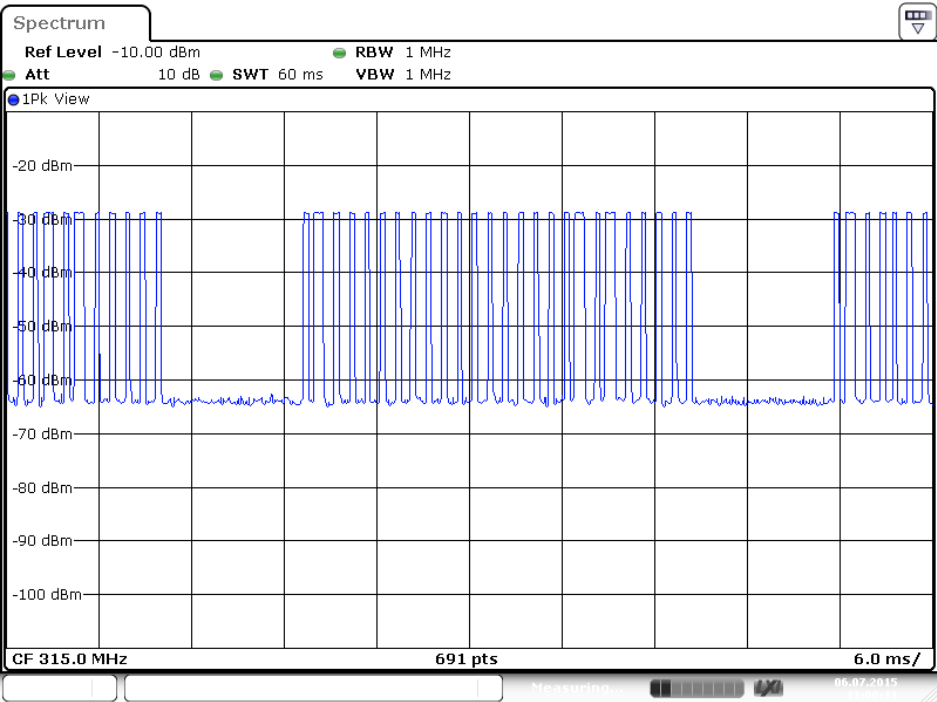

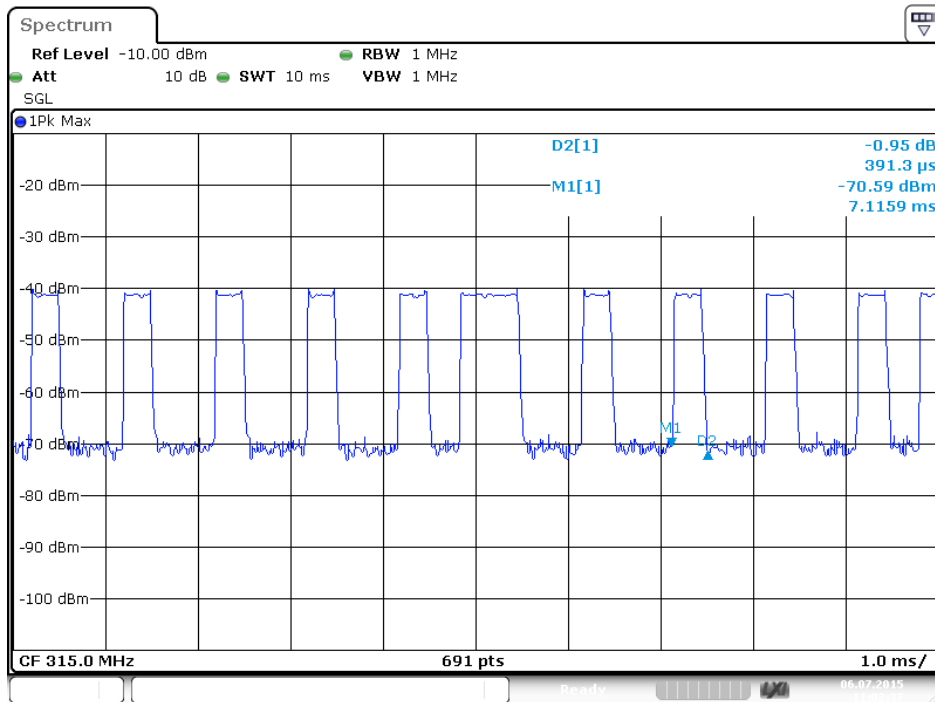

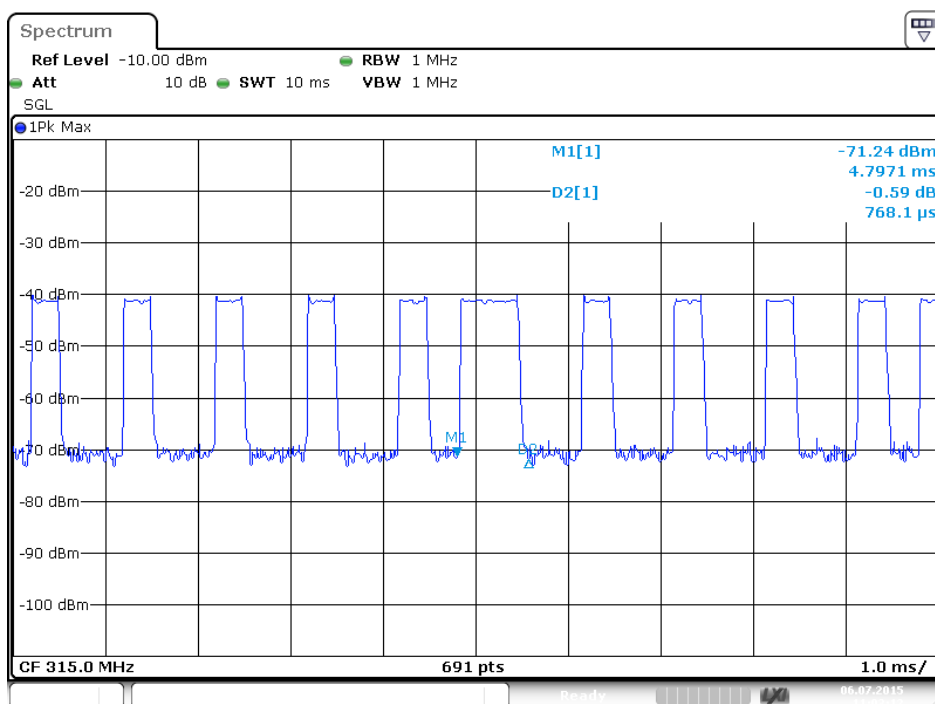
