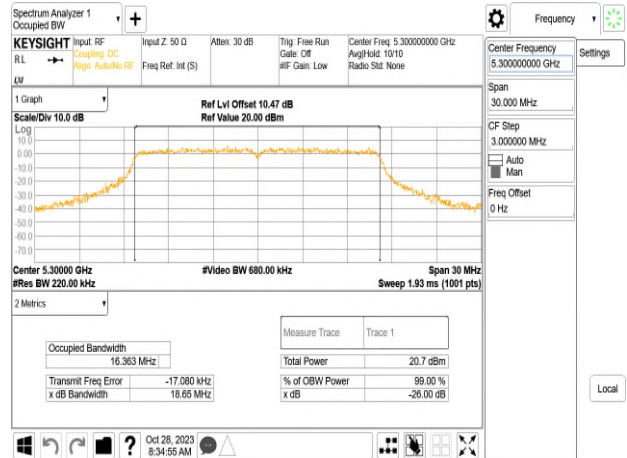
802.11a_20MHz_Chain0_5260MHz



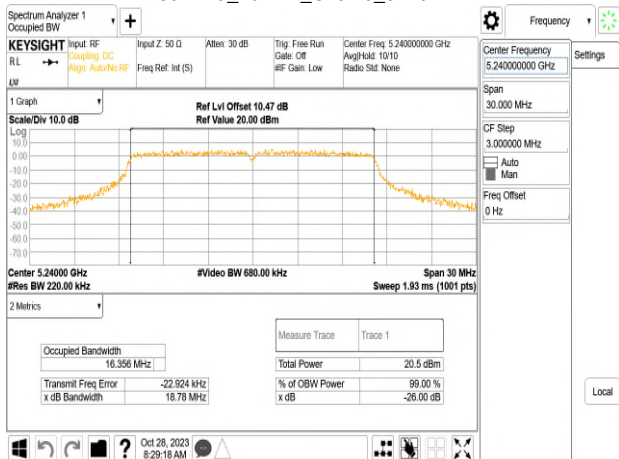
