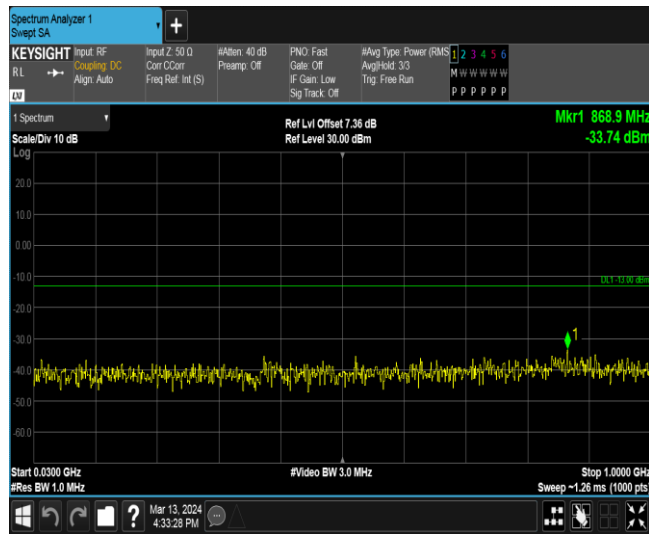

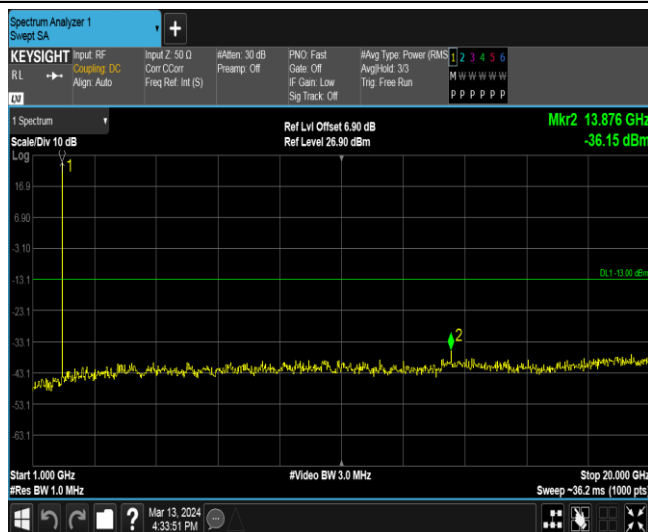


Band2-1.4MHz-QPSK-19193-1RB#0-Range1:30~1000MHz

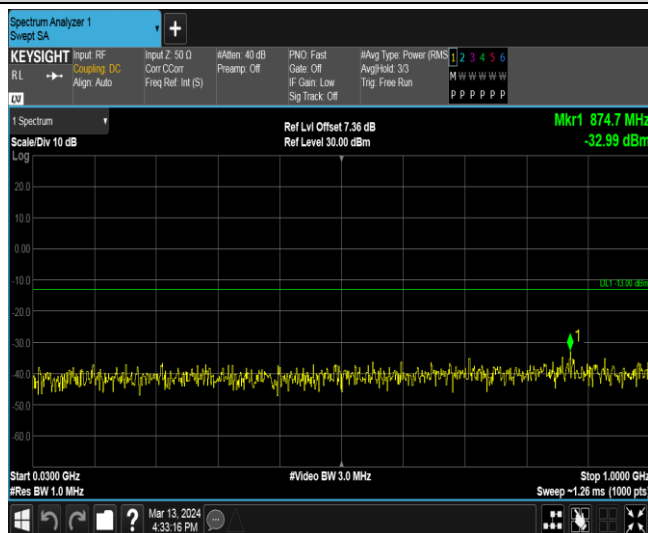
