#### 5.2 MPE Calculation

The Max Conducted Peak Output Power is 113.76mW(0.11376W) in Middle channel of 802.11b; The best case gain of the antenna is 2.4dBi. 2.4dB logarithmic terms convert to numeric result is nearly 1.738.

For FCC:

According to the formula  $S = \frac{PG}{4R^2\pi}$ , we can calculate S which is MPE.

Note:

1) P (Watts) =Power Input to antenna =  $10^{10}$  / 1000

- 2) G (Antenna gain in numeric) = 10<sup>^</sup> (Antenna gain in dBi /10)
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm<sup>2</sup>

$$S = \frac{PG}{4R^2\pi} = \frac{113.76 \times 1.738}{4 \times 400 \times 3.14} = 0.0394 \text{ mW/cm}^2$$

So the device is exclusion from SAR test.
