




Aroma Container

Sleep-aid Mode

Press the power button to start sleep-aid mode.



turn on the night lamp.

Press the rotary knob to turn on the night lamp.



Volume

Control the volume by spinning the rotary knob. Counterclockwise rotation is to turn down/off.

04 Setup

Step 1: Insert the aroma container

Step 2: Connect the power supply

Step 3: Installation of APP & Registration

Search "Sleepace" in   for download.

You will need a smart phone with Bluetooth 4.0 that supports IOS7.1 or later or Android 4.3 or later.

Step 4: Registration and Binding

Open the Sleepace APP, then register, bind device, set alarm and lights as per the APP prompts.

05 Functions

- **Sleep Monitoring**
Open the Sleepace App, tap the "Start Sleep" button and place your phone next to your pillow. Tap the "Get Up" button when you wake up and the App will generate your sleep report.
- **Sleep-aid function**
The sleep aroma, soothing sound and red light help you fall asleep easier. The Sleep aroma, light and sound will stop automatically once you fall asleep.
- **Smart Wake-Up Mode**
Click **【Smart Alarm】** to set the alarm. Nox aroma supports various wake-up modes including sound effects, light and aroma. When you use app to monitor your sleep, the smart alarm will wake you up at your lightest sleep stage.
- **Woke with Amazon Alexa**
