

7.5.4 Measurement Procedure and Data

- a. For below 1GHz, the EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.

Otherwise the emissions that did not have 10dB margin would be re-tested one by one using quasi-peak method as specified and then reported in a data sheet.
- g. Test the EUT in the lowest channel, the middle channel, the Highest channel.
- h. The radiation measurements are performed in X, Y, Z axis positioning for Transmitting mode, and found the X axis positioning which it is the worst case.
- i. Repeat above procedures until all frequencies measured was complete. Remark:
- 1. Level= Read Level+ Cable Loss+ Antenna Factor- Preamp Factor
- 2. Scan from 9kHz to 30MHz, the disturbance below 30MHz was very low.
