Band2-20MHz-16QAM-18700-100RB#0

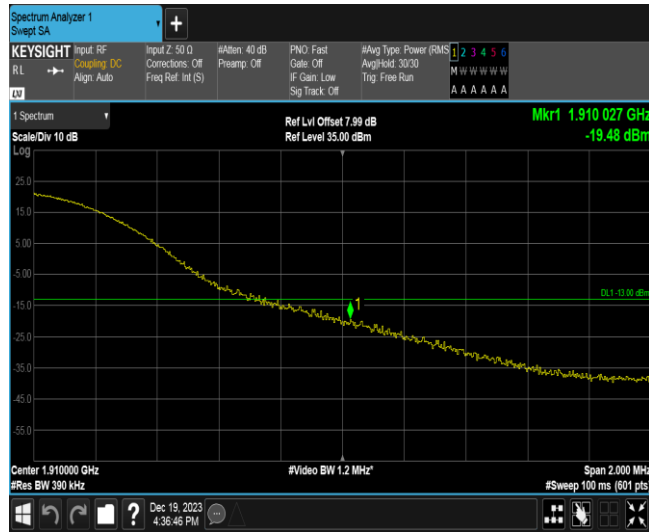


Band2-20MHz-16QAM-19100-1RB#0

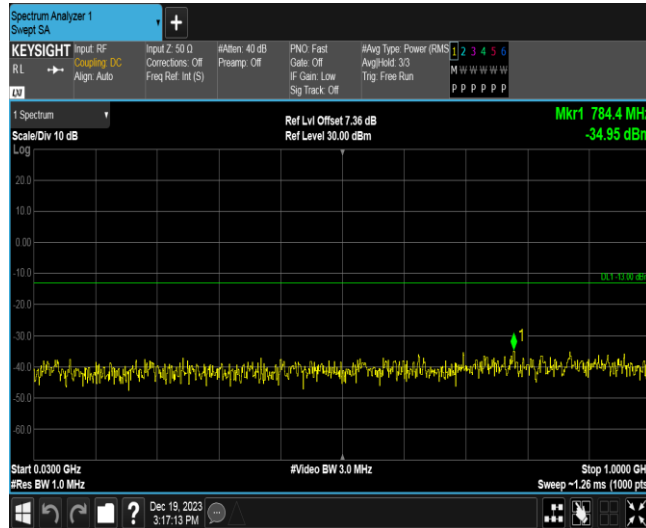

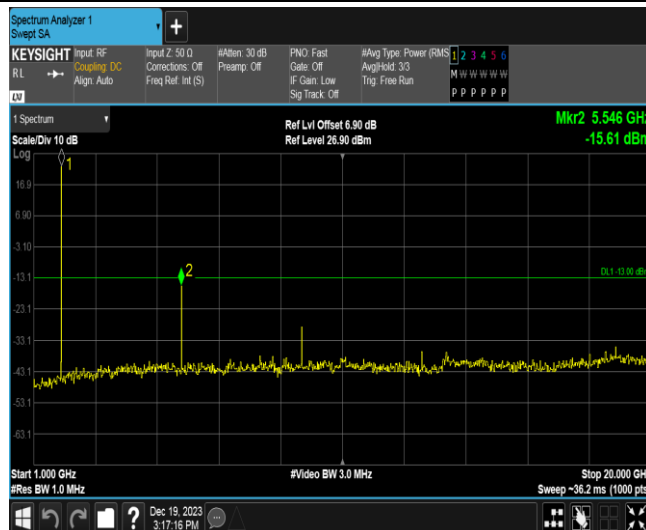

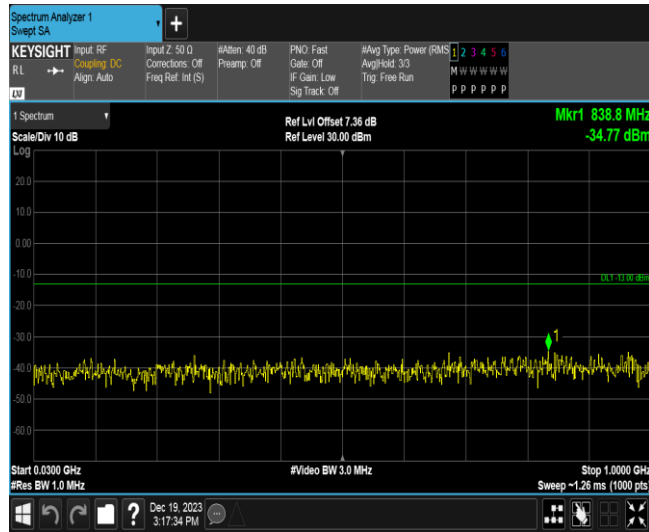
Band2-1.4MHz-QPSK-18607-1RB#0-Range2:1000~20000MHz



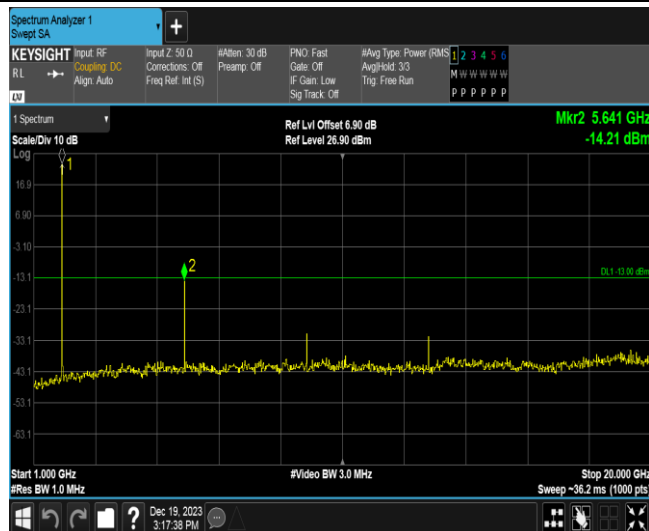

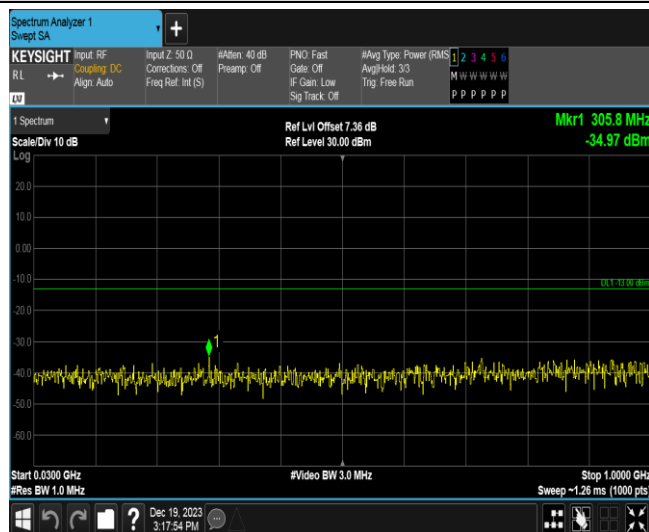

Band2-1.4MHz-QPSK-18900-1RB#0-Range2:1000~20000MHz

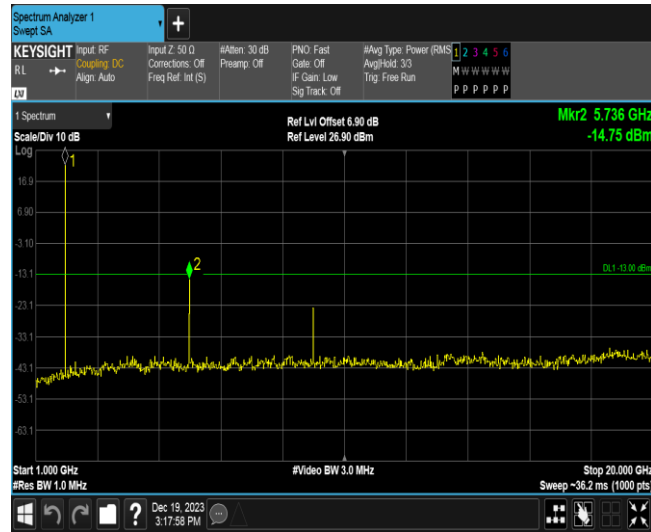


Band2-1.4MHz-QPSK-19193-1RB#0-Range1:30~1000MHz

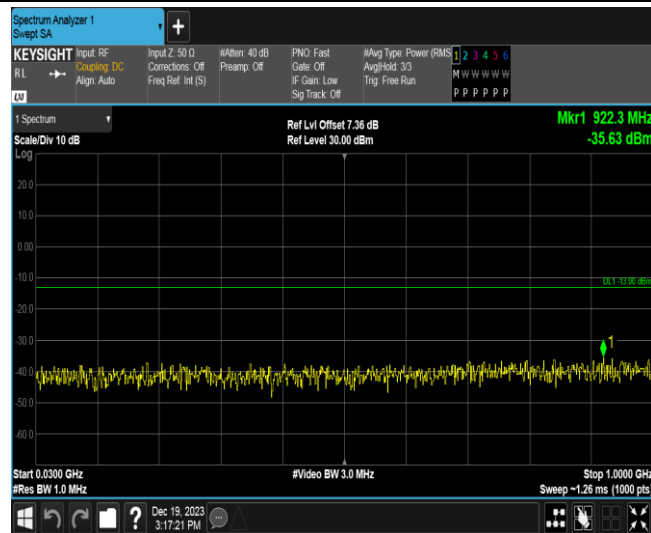

Band2-1.4MHz-16QAM-18900-1RB#0-Range1:30~1000MHz

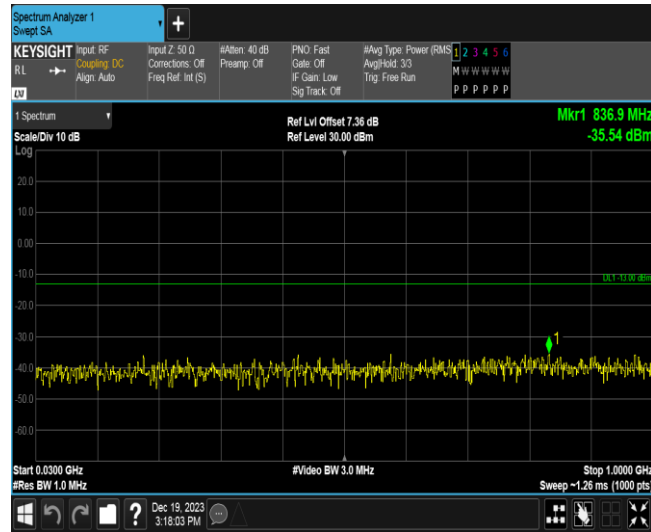


Band2-1.4MHz-16QAM-18900-1RB#0-Range2:1000~20000MHz

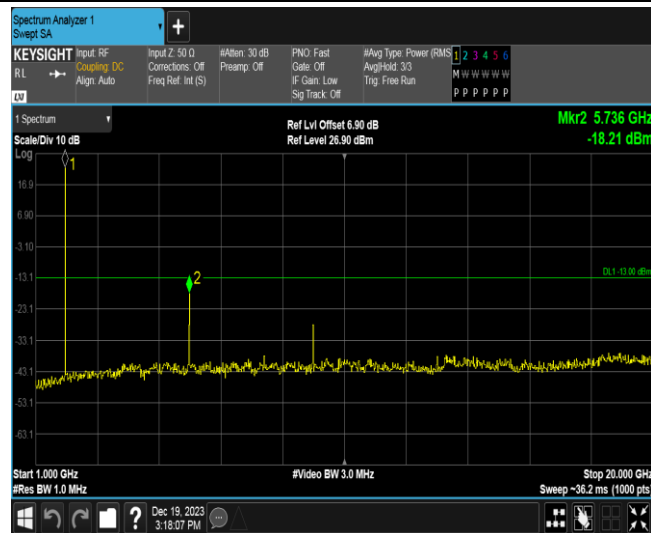

Band2-3MHz-16QAM-19185-1RB#0-Range2:1000~20000MHz

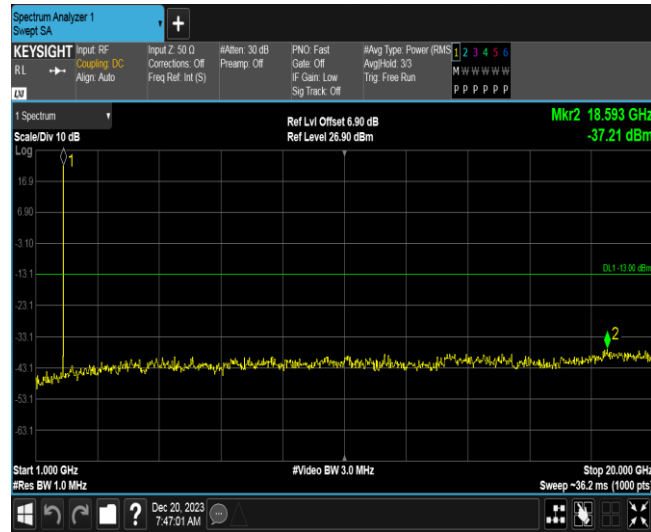


Band2-5MHz-QPSK-18625-1RB#0-Range1:30~1000MHz

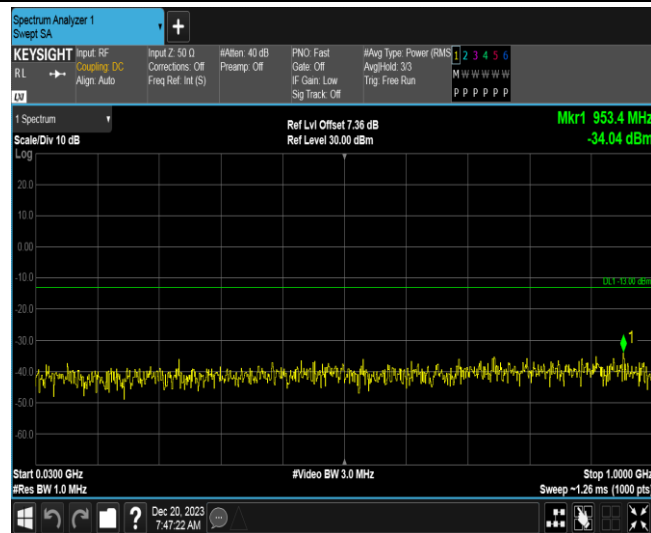

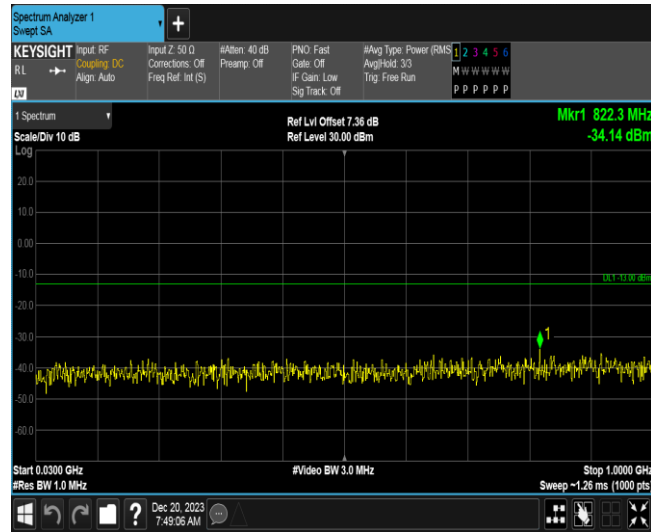


Band2-10MHz-QPSK-18900-1RB#0-Range2:1000~20000MHz

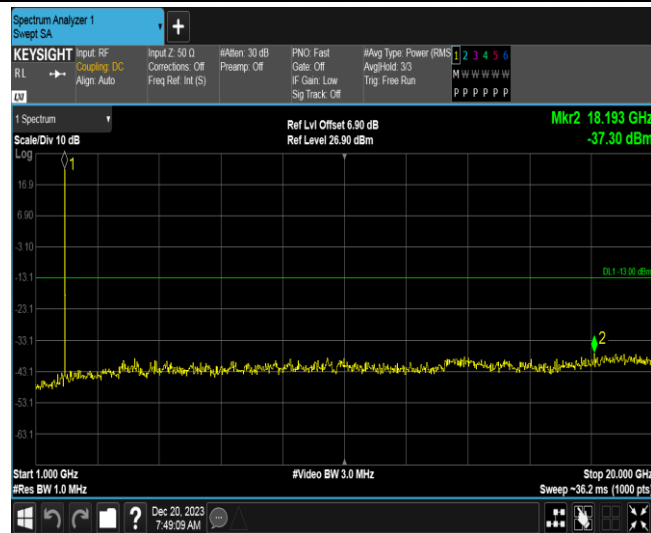

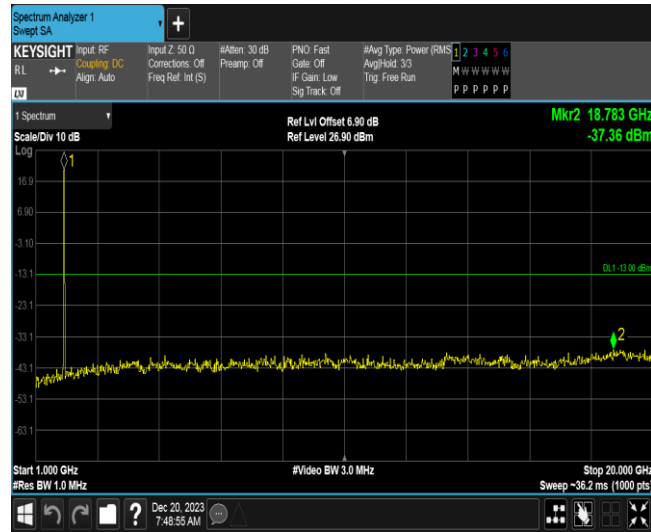


Band2-10MHz-16QAM-18900-1RB#0-Range1:30~1000MHz

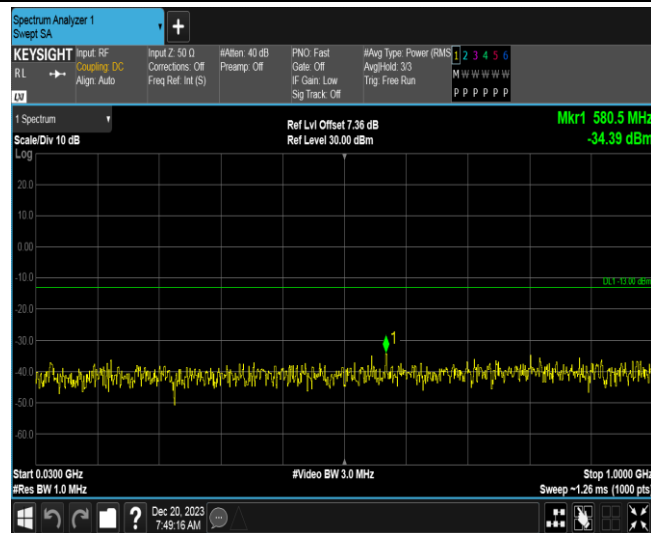
