- There are a total of 8 to 20 Bursts in the 12 second period, with the number of Bursts being randomly chosen.
   This number is Burst Count.
- Each Burst consists of 1 to 3 pulses, with the number of pulses being randomly chosen. Each Burst within the 12 second sequence may have a different number of pulses.
- The pulse width is between 50 and 100 microseconds, with the pulse width being randomly chosen. Each pulse within a Burst will have the same pulse width. Pulses in different Bursts may have different pulse widths.


The FCC Type 6 waveform uses a static waveform with 100 bursts in the instruments ARB. In addition, the RF list mode is operated with a list containing 100 frequencies from a randomly generated list and it had be ensured that at least one of the random frequencies falls into the UNII Detection Bandwidth of the DUT. Each burst from the waveform file initiates a trigger pulse at the beginning that switches the RF list from one item to the next one.



#### 3.2.6 Radar Waveform calibration Plot








#### 3.2.8 Data traffic Plot
