3.5. Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain and Duty Cycle Correction Factor (if any) from the measured reading. The basic equation with a sample calculation is as follows:

FS (dBuV/m) = RA (dBuV) + AF (dB/m) + CL (dB) - AG (dB)

Where FS = Field Strength	CL = Cable Attenuation Factor (Cable Loss)
RA = Reading Amplitude	AG = Amplifier Gain
AF = Antenna Factor	

3.6. DISTURBANCE Calculation

The AC mains conducted disturbance is calculated by adding the 10dB Pulse Limiter and Cable Factor and Duty Cycle Correction Factor (if any) from the measured reading. The basic equation with a sample calculation is as follows:

5. TEST CONDITIONS AND RESULTS

5.1. Antenna Requirement

Standard Applicable:

FCC CFR Title 47 Part 15 Subpart C Section 15.203:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the response-ble party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

FCC CFR Title 47 Part 15 Subpart C Section 15.247(c) (1) (I):

(i) Systems operating in the 2400-2483.5 MHz band that is used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

Description

The EUT antenna is PCB Antenna (2.3dBi), the directional gain of the antenna less than 6dBi. It comply with the standard requirement. In case of replacement of broken antenna the same antenna type must be used. Antenna structure please refer to the EUT internal photographs antenna photo.



Test procedure:

- 1. The EUT was setup according to ANSI C63.10 requirements.
- The EUT was placed on a platform of nominal size, 1 m by 1.5 m, raised 80 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 80 cm from any other grounded conducting surface.
- 3. The EUT and simulators are connected to the main power through a line impedances stabilization network (LISN). The LISN provides a 50 ohm /50uH coupling impedance for the measuring equipment.
- 4. The peripheral devices are also connected to the main power through a LISN. (Refer to the block diagram of the test setup and photographs)
- 5. Each current-carrying conductor of the EUT power cord, except the ground (safety) conductor, was individually connected through a LISN to the input power source.
- 6. The excess length of the power cord between the EUT and the LISN receptacle were folded back and forth at the center of the lead to form a bundle not exceeding 40 cm in length.
- 7. Conducted emissions were investigated over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9 kHz.
- 8. During the above scans, the emissions were maximized by cable manipulation.


5.3. Peak Output Power

Limit:

FCC CFR Title 47 Part 15 Subpart C Section 15.247 (b)(3):

For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is de ned as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

Test procedure:

- 1. The transmitter output was connected to the spectrum analyzer through an attenuator, the path loss was compensated to the results for each measurement.
- 2. Set to the maximum power setting and enable the EUT transmit continuously
- 3. Use the following spectrum analyzer settings:

Span ≥ 1.5*DTS Bandwidth

Peak Detector:RBW ≥ DTS Bandwidth, VBW≥3*RBW

Sweep = auto, Detector function = peak, Trace = max hold



5.4. 6 dB Bandwidth

Test procedure:

- Connect EUT RF Output port to the Spectrum Analyzer through an RF attenuator.
- 2. The 6dB bandwidth is defined as the total spectrum the power of which is higher than peak power minus 6dB.
- 3. The occupied bandwidth is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers are each equal to 0.5% of the total mean power of the given emission.
- 4. Spectrum Setting:

6dB bandwidth:

- (1) Set RBW = 100 kHz.
- (2) Set the video bandwidth (VBW) ≥ 3 RBW.
- (3) Detector = Peak.
- (4) Trace mode = Max hold.
- (5) Sweep = Auto couple.
- (6) Allow the trace to stabilize.
- $\stackrel{\textstyle (7)}{}$ Measure the maximum width of the emission that is constrained by the frequencies associated

with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.






5.6. Power spectral density

Limit:

Test configuration:

For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3 kHz band during any time interval of continuous transmission.



Test procedure:

- 1. Use this procedure when the maximum peak conducted output power in the fundamental emission is used to demonstrate compliance.
- 2. Set the RBW \geq 3 kHz.
- 3. Set the VBW \geq 3× RBW.
- 4. Set the span to 1.5 times the DTS channel bandwidth.
- 5. Detector = peak.
- 6. Sweep time = auto couple.
- 7. Trace mode = max hold.
- 8. Allow trace to fully stabilize.
- 9. Use the peak marker function to determine the maximum power level.
- 10. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.
- 11. The resulting peak less than 8dBm.


5.7. Conducted Band edge and Spurious Emission

Limit:

FCC CFR Title 47 Part 15 Subpart C Section15.247 (d):

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

Test configuration:



Test procedure:

- 1. Connect the antenna port(s) to the spectrum analyzer input.
- 2. Emission level measurement

Set the center frequency and span to encompass frequency range to be measured

RBW = 100 kHz, VBW \geq 3 x RBW

Detector = peak, Sweep time = auto couple, Trace mode = max hold Allow trace to fully stabilize

Use the peak marker function to determine the maximum amplitude level.

- 3. Place the radio in continuous transmit mode, allow the trace to stabilize, view the transmitter waveform on the spectrum analyzer.
- 4. Ensure that the amplitude of all unwanted emission outside of the authorized frequency band excluding restricted frequency bands) are attenuated by at least the minimum requirements specified (at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz). Report the three highest emission relative to the limit.


5.8. Radiated Band edge Emission

Limit:

FCC CFR Title 47 Part 15 Subpart C Section 15.247 (d):

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, Radiated Emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the Radiated Emissions limits specified in §15.209(a) (see §15.205(c)).

Test configuration:



Test procedure:

- 1. The EUT was setup and tested according to ANSI C63.10.
- 2. The EUT is placed on a turn table which is 1.5 meter above ground. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
- 3. The EUT waspositioned such that the distance from antenna to the EUT was 3 meters.
- 4. The antenna is scanned from 1 meter to 4 meters to find out the maximum emission level. Thisis repeated for both horizontal and vertical polarization of the antenna. In order to find themaximum emission, all of the interface cables were manipulated according to ANSI C63.10 on radiated measurement.
- 5. Use the following spectrum analyzer settings:
 - a) Span shall wide enough to fully capture the emission being measured
 - b) Set RBW=100kHz for <1GHz, VBW=3*RBW, Sweep time=auto, Detector=peak, Trace=max hold
 - c) Set RBW=1MHz, VBW=3MHz for >1GHz, Sweep time=auto, Detector=peak, Trace=max hold for Peak measurement
 - d) Set RBW=1MHz, VBW=3MHz for >1GHz, Sweep time=auto, Detector=Average, Trace=RMS for Average measurement







Test procedure:

- 1. The EUT was setup and tested according to ANSI C63.10.
- 2. The EUT is placed on a turn table which is 0.8 meter above ground for below 1 GHz, and 1.5 m for above 1 GHz. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
- 3. The EUT was set 3 meters from the receiving antenna, which was mounted on the top of a variable height antenna tower.
- 4. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
- 5. Set to the maximum power setting and enable the EUT transmit continuously.
- 6. Use the following spectrum analyzer settings
 - a) Span shall wide enough to fully capture the emission being measured;
 - b) Below 1 GHz:

RBW=120 kHz, VBW=300 kHz, Sweep=auto, Detector function=peak, Trace=max hold;

If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.

- c) Set RBW=1MHz, VBW=3MHz for >1GHz, Sweep time=auto, Detector=peak, Trace=max hold for Peak measurement
- d) Set RBW=1MHz, VBW=3MHz for >1GHz, Sweep time=auto, Detector=Average, Trace=RMS for Average measurement




