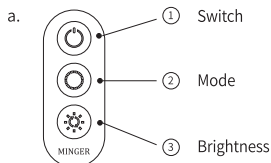
## Instructions

### 1.Installation

- Open the package and spread the strip straight. Please check whether the strip light appearance and all parts are in good condition. Then power the strip light to test whether it could light normal.
- Clean the surface of the object where the strip needs to be installed and keep it dry.
- Tear off the adhesive tape, paste the strip on the correct place at once time. Install the clips at the beginning and the end of the strip. If there is a corner, place the clips on each side of the right angle. (Notice: Do not move the strip light to other place after it is attached. )
- Press the strip firmly from the beginning to the end to remove the air from the strip and the surface of the object.

- The installation is over, please provide the power for it. Enjoy the wonderful light.

### 2.Usage Method



- Download APP**  
Search and download the APP "Govee Home" in APP store (IOS) or Google Play (Android). When enter home page, click the icon "+" in the top right corner to enter Govee device list. Select H6163, follow the APP prompt to add the device.
- Link with Alexa**
