


### **TEST PROCEDURE**

- 1. The EUT was setup and tested according to ANSI C63.10:2013 for compliance to FCC 47CFR 15.247 requirements.
- 2. The EUT was placed on a platform of nominal size, 1 m by 1.5 m, raised 80 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 80 cm from any other grounded conducting surface.
- 3. The EUT and simulators are connected to the main power through a line impedancestabilization network (LISN). The LISN provides a 50 ohm /50uH coupling impedance for themeasuring equipment.
- 4. The peripheral devices are also connected to the main power through aLISN. (Please refer to the block diagram of the test setup and photographs)
- 5. Each current-carrying conductor of the EUT power cord, except the ground (safety) conductor,was individually connected through a LISN to the input power source.
- 6. The excess length of the power cord between the EUT and the LISN receptacle were foldedback and forth at the center of the lead to form a bundle not exceeding 40 cm in length.
- 7. Conducted emissions were investigated over the frequency range from 0.15MHz to 30MHzusing a receiver bandwidth of 9 kHz.


### 4.7. Band edge and Spurious Emission (conducted)

### **LIMIT**

FCC CFR Title 47 Part 15 Subpart C Section 15.247 (d):

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.



Report the three highest emissions relative to the limit.


