2. "The modular transmitter must have buffered modulation/data inputs." The EUT has buffered data inputs, it is integrated in chip **PN7150**.
3. "The modular transmitter must have its own power supply regulation." The part number of this regulator is **PN7150**.
4. "The modular transmitter must comply with the antenna requirements of section 15.203 and 15.204(C)." The EUT meets the FCC antenna requirements. The spurious emission, unique antenna connector and photo of antennas are shown in the test report.
