## 3.3 Transmitter Requirements

## 3.3.1 Antenna Requirement

According to §15.203 An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

Accoding to §15.247(b)(4) e conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6  $\,\mathrm{dBi}$ . Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6  $\,\mathrm{dBi}$  are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in  $\,\mathrm{dB}$  that the directional gain of the antenna exceeds 6  $\,\mathrm{dBi}$ .

#### 3.3.1.1 Result

(The transmitter has a PCB Pattern Antenna. The directional peak gain of the antenna is -1.79 dBi.)



#### 3.3.2 6 dB Bandwidth

#### 3.3.2.1 Test Setup

#### 3.3.2.2 Limit

The minimum permissible 6  $\,\mathrm{dB}\,$  bandwidth is 500  $\,\mathrm{klz}.$ 

#### 3.3.2.3 Test Procedure

The bandwidth at  $6~\mathrm{dB}$  down from the highest in-band spectral density is measured with a spectrum analyzer connected to the EUT's antenna terminal while the EUT is operating in transmission mode at the appropriate frequencies.

- 1. Set resolution bandwidth (RBW) = 100 kHz
- 2. Set the video bandwidth (VBW)  $\geq$  3 x RBW.
- 3. Detector = Peak.
- 4. Trace mode = Max Hold.
- 5. Sweep = Auto
- 6. Allow the trace to stabilize.
- 7. Option 1 Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.
  - Option 2 The automatic bandwidth measurement capability of an instrument may be employed using the X  $\,\mathrm{dB}$  bandwidth mode with X set to 6  $\,\mathrm{dB}$ , if the functionality described above (i.e., RBW = 100  $\,\mathrm{kdz}$ , VBW  $\geq$  3 x RBW, peak detector with maximum hold) is implemented by the instrumentation function. When using this capability, care shall be taken so that the bandwidth measurement is not influenced by any intermediate power nulls in the fundamental emission that might be  $\geq$  6  $\,\mathrm{dB}$ .




## BLE \_ Low frequency

#### 6 dB Bandwidth






## **BLE \_ High frequency**

## 6 dB Bandwidth




## **BLE \_ Low frequency**

## Occupied Bandwidth



## 3.3.3 Maximum Peak Output Power

#### 3.3.3.1 Test Setup

Refer to the APPENDIX I.

#### 3.3.3.2 Limit

The maximum permissible conducted output power is 1 Watt.

#### 3.3.3.3 Test Procedure

A transmitter antenna terminal of EUT is connected to the input of a spectrum analyzer. Measurement is made while the EUT is operating in transmission mode at the appropriate frequencies.

- 1. Set the RBW ≥ DTS bandwidth
- 2. Set VBW ≥ 3 x RBW
- 3. Set span ≥  $3 \times RBW$ .
- 4. Sweep time = auto couple
- 5. Detector = peak
- 6. Trace mode = max hold
- 7. Allow trace to fully stabilize
- 8. Use peak search function to determine the peak amplitude level.





## 3.3.4 Peak Power Spectral Density

#### **3.3.4.1 Test Setup**

Refer to the APPENDIX I.

#### 3.3.4.2 Limit

The power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission

#### 3.3.4.3 Test Procedure

The peak power density is measured with a spectrum analyzer connected to the antenna terminal while the EUT is operating in transmission mode at the appropriate frequencies.







## 3.3.5 TX Radiated Spurious Emission and Conducted Spurious Emission

#### 3.3.5.1 Test Setup

Refer to the APPENDIX I.

#### 3.3.5.2 Limit

According to §15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph(b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in section §15.209(a) is not required. In addition, radiated emission which in the restricted band, as define in section §15.205(a), must also comply the radiated emission limits specified in section §15.209(a) (see section §15.205(c))

According to § 15.209(a), except as provided elsewhere in this Subpart, the emissions from an intentional

radiator shall not exceed the field strength levels specified in the following table

The field strength of emissions appearing within these frequency bands shall not exceed the limits shown in §15.209. At frequencies equal to or less than 1000 Mb, compliance with the limits in §15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 Mb, compliance with the emission limits in §15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in §15.35 apply to these measurements.



#### 3.3.5.3 Test Procedure for Radiated Spurious Emission

- 1. The EUT is placed on a non-conductive table. For emission measurements at or below 1 Glz, the table height is 80 cm. For emission measurements above 1 Glz, the table height is 1.5 m. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. During performing radiated emission below 1 GHz, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 GHz, the EUT was set 1 or 3 meter away from the interference-receiving antenna.
- 3. For measurements above 1 @ absorbers are placed on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections. For measurements below 1 @ the absorbers are removed.
- 4. The antenna is a Broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- 5. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.

(The EUT was pre-tested with three axes (X, Y, Z) and the final test was performed at the worst case.)

6. Repeat above procedures until the measurements for all frequencies are complete.

#### **Measurement Instrument Setting**

1. Frequency Range: Below 1 @z

RBW = 100 or 120 kHz, VBW = 3 x RBW, Detector = Peak or Quasi Peak

2. Frequency Range: Above 1 @

#### Peak Measurement

RBW = 1 Mb, VBW = 3 Mb, Detector = Peak, Sweep time = Auto,

Trace mode = Max Hold until the trace stabilizes

#### Average Measurement

RBW = 1 Mb, VBW = 3 Mb, Detector = RMS (Number of points  $\geq$  2 x Span / RBW), Trace Mode = Average (Averaging type = power(i.e. RMS)), Sweep Time = Auto, Sweep Count = at least 100 traces

A correction factor shall be added to the measurement results prior to comparing to the emission limit in order to compute the emission level that would have been measured had the test been performed at 100 percent duty cycle. The correction factor is computed as follows:

- 1) If power averaging (RMS) mode was used in step 4, then the applicable correction factor is  $10 \log(1/x)$ , where x is the duty cycle.
- 2) If linear voltage averaging mode was used in step 4, then the applicable correction factor is  $20 \log(1/x)$ , where x is the duty cycle.
- 3) If a specific emission is demonstrated to be continuous ( $\geq$  98 percent duty cycle) rather than tuming on and off with the transmit cycle, then no duty cycle correction is required for that emission.



## 3.3.5.4 Test Procedure for Conducted Spurious Emission

- 1. The transmitter output was connected to the spectrum analyzer.
- 2. The reference level of the fundamental frequency was measured with the spectrum analyzer using RBW = 100  $\, \text{kHz}$ , VBW = 300  $\, \text{kHz}$ .
- 3. The conducted spurious emission was tested each ranges were set as below.

Frequency range: 30 Mb ~ 26.5 Gb

RBW = 100 kHz, VBW = 300 kHz, Sweep Time = Auto, Detector = Peak,

Trace = Max Hold

LIMIT LINE = 20 dB below of the reference level of above measurement procedure Step 2. (RBW = 100 kHz, VBW = 300 kHz)

#### 3.3.6 Conducted Emission

#### 3.3.6.1 Test Setup

#### 3.3.6.2 Limit

According to §15.207(a) for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 klb to 30 Mb, shall not exceed the limits in the following table, as measured using a 50 uH/50 ohm line impedance stabilization network (LISN).

Compliance with the provision of this paragraph shall on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower applies at the boundary between the frequency ranges.

#### 3.3.6.3 Test Procedure

Conducted emissions from the EUT were measured according to the ANSI C63.10.

- 1. The test procedure is performed in a 6.5 m × 3.5 m × 3.5 m (L × W × H) shielded room. The EUT along with its peripherals were placed on a 1.0 m (W) × 1.5 m (L) and 0.8 m in height wooden table and the EUT was adjusted to maintain a 0.4 meter space from a vertical reference plane.
- 2. The EUT was connected to power mains through a line impedance stabilization network (LISN) which provides 50 ohm coupling impedance for measuring instrument and the chassis ground was bounded to the horizontal ground plane of shielded room.
- 3. All peripherals were connected to the second LISN and the chassis ground also bounded to the horizontal ground plane of shielded room.
- 4. The excess power cable between the EUT and the LISN was bundled. The power cables of peripherals were unbundled. All connecting cables of EUT and peripherals were moved to find the maximum emission.




