1: Instruction:

Before using this product pls carefully read the instruction first, to avoid any confused.

- 1): Firstly please press the swich on/off button of this product. Then open your smart devices to connect the Bluetooth name"RSSIDOL H08", successfully connected you will hearing the "Connected" voice prompt for paring.
- 2): After connected the bluetooth, you can play any music on your smart devices anytime anywhere then.

2: How to using:

Follows picture for the product buttons instruction.





1: Volume down/Previous song button.

- 1) Long press will be change to previous song.
- 2) Short press will be volume down.

2: Volume up/Next song button.

- 1) Long press will be change to next song.
- 2) Short press will be volume up.

3: Switch On/Off button.

- 1) Long press of 3 second for Switch on/off.
- 2) Short press for Play/Pause. Short press for answer/hang up calls for phone.
- 3) Dual press for connect/disconnect previous connected smart devices.
- 4) Long press 1 second for reject coming calls.
- 5) Long press 8 second to get reset speaker.

4: Mode button.

- 1) Short press for mode change(Bluetooth, FM mode, TF card, USB mode).
- 2) Dual press for clear pairing devices.
- 3) Triple press for awake Google/Siri.
- 4) Long press for swich on/off orginal sound.

5: Lights button.

- 1) Long press for switch on/off RGB light.
- 2) Short press for switching different RGB lights effect.

6: Type-c port/DC 5V charging port.

1) Plug in USB-C cable to get charging.


7: LED light indicator.

1) There is red light on when you plug into charging, the red light will be off once full charged.

8: TF card slot.

9: USB slot.

10: AUX/3.5mm port



1: Switch On/Off button.

- 1) Long press of 3 second for Switch on/off.
- 2) Short press for reverb volume mode, mic volume mode, speaker volume mode, the user can increase of decrease the volume accordingly.
- 3) Dual press for Play/Pause.

2: Volume up/Next song button.

- 1) Long press will be change to next song.
- 2) Short press will be volume up (reverb, microphone, speaker mode).

3: Volume down/Previous song button.

- 1) Long press will be change to previous song.
- 2) Short press will be volume down (reverb, microphone, speaker mode).

4: Microphone button.

- 1) Short press for magic sound effect(There is totally 4 difference sound options)
- 2) Long press for original sound on/off.

5: LED light indicator.

1) There is red light on when you plug into charging, the red light will be off once full charged.
