FULLY CHARGE THE SMARTWATCH AND EARBUDS

Before initiating the setup process, ensure that your smartwatch and earbuds are fully charged-avoid overcharging.






CHARGING THE SMARTWATCH

Align the gold pins on the charging cable with the gold contacts on the back of the smartwatch; they will magnetically connect. If you encounter resistance, flip the cable around. Plug into a UL-certified wall charger or a computer USB port; the smartwatch screen will

display "charging."



CHARGING THE EARBUDS

Insert the charging cable into the charging port. The charging indicator light will blink red to show that the earbuds are charging. Once the light is illuminated blue, the earbuds are fully charged.

SETTING UP YOUR SMARTWATCH
