Permanent Confidentiality:

The applicant requests the exhibits listed above as permanently confidential be permanently withheld from public review due to materials that contain trade secrets and proprietary information not customarily released to the public. As the product is owned, professionally installed, and maintained by Vivint, it is requested that a permanent confidentiality be granted with respect to the internal photos as well.


Short-Term Confidentiality:

The applicant requests the exhibits selected above as short term confidential be withheld from public view for a period of 180 days from the date of the Grant of Equipment Authorization and prior to marketing. This is to avoid premature release of sensitive information prior to marketing or release of the product to the public. Applicant is also aware that they are responsible to notify FCC in the event information regarding the product or the product is made available to the public. FCC will then release the documents listed above for public disclosure pursuant to FCC Public Notice DA 04-1705.

The applicant understands that until such time that Industry Canada distinguishes between Short Term and Permanent Confidentiality, either type of marked exhibit above will simply be marked Confidential when submitted to IC.

Removal of potting material causes irreparable damage to internal circuitry. See photographs exhibits that outline the device before and after potting."
