### **Product Description for Equipment under Test (EUT)**

The *b mobile HK Limited's* product, model number: *AX600 (FCC ID: ZSW-30-004)* or the "EUT" in this report was a *Mobile Phone*, which was measured approximately: 118 mm (L) x62 mm (W) x 11 mm (H), rated with input voltage: DC 3.7V rechargeable Li-ion battery or DC 5.0V from adapter.

### **Objective**

This test report is prepared on behalf of *b mobile HK Limited* in accordance with Part 2-Subpart J, Part 15-Subparts A, B and C of the Federal Communication Commissions rules.

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz, and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.









# EDR ( $\pi/4$ -DQPSK): Band Edge-Left Side




# EDR ( $\pi$ /4-DQPSK): Band Edge-Right Side
