

## 7 Description of the test setup

Typically, the calibrations of the test apparatus are commissioned to and performed by an accredited calibration laboratory. The calibration intervals are determined in accordance with the DIN EN ISO/IEC 17025. In addition to the external calibrations, the laboratory executes comparison measurements with other calibrated test systems or effective verifications. Weekly chamber inspections and range calibrations are performed. Where possible, RF generating and signaling equipment as well as measuring receivers and analyzers are connected to an external high-precision 10 MHz reference (GPS-based or rubidium frequency standard).

In order to simplify the identification of the equipment used at some special tests, some items of test equipment and ancillaries can be provided with an identifier or number in the equipment list below (Lab/Item).

Each block diagram listed can contain several test setup configurations. All devices belonging to a test setup are identified with the same letter syntax. For example: Column Setup and all devices with an A.



#### 7.1 Shielded semi anechoic chamber

The radiated measurements are performed in vertical and horizontal plane in the frequency range from 30 MHz to 1 GHz in semi-anechoic chambers. The EUT is positioned on a non-conductive support with a height of 0.80 m above a conductive ground plane that covers the whole chamber. The receiving antennas are conform to specifications ANSI C63. These antennas can be moved over the height range between 1.0 m and 4.0 m in order to search for maximum field strength emitted from EUT. The measurement distances between EUT and receiving antennas are indicated in the test setups for the various frequency ranges. For each measurement, the EUT is rotated in all three axes until the maximum field strength is received. The wanted and unwanted emissions are received by spectrum analyzers where the detector modes and resolution bandwidths over various frequency ranges are set according to requirement ANSI C63.



- At each turntable position the analyzer sweeps with positive-peak detector to find the maximum of all emissions.

#### Final measurement

- Identified emissions during the pre-measurement are maximized by the software by rotating the turntable from 0° to 360°.
- Loop antenna is rotated about its vertical axis for maximum response at each azimuth about the EUT. (For certain applications, the loop antenna plane may also need to be positioned horizontally at the specified distance from the EUT)

- Measurement distance is 10 m or 3 m (see ANSI C 63.4) see test details.
- EUT is set into operation.

#### **Premeasurement**

- The turntable rotates from 0° to 315° using 45° steps.
- The antenna is polarized vertical and horizontal.
- The antenna height changes from 1 m to 3 m.
- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

#### Final measurement

- The final measurement is performed for at least six highest peaks according to the requirements of the ANSI C63.4.
- Based on antenna and turntable positions at which the peak values are measured the software maximize the peaks by changing turntable position ± 45° and antenna height between 1 and 4 m.






Plots: DSSS - peak / average

Plot 2: TX mode, upper band edge, vertical & horizontal polarization






Plots: OFDM / g - mode - peak / average

Plot 2: TX mode, upper band edge, vertical & horizontal polarization






Plots: OFDM / n HT20 - mode - peak / average

Plot 2: TX mode, upper band edge, vertical & horizontal polarization






Plots: OFDM / n HT40 - mode - peak / average






Plots: OFDM / n HT40 - mode - peak / average





Plot 1: 9 kHz to 30 MHz, lowest channel




Plot 2: 9 kHz to 30 MHz, middle channel

Plot 3: 9 kHz to 30 MHz, highest channel






Plots: OFDM (20 MHz nominal channel bandwidth)

Plot 1: 9 kHz to 30 MHz, lowest channel




Plot 2: 9 kHz to 30 MHz, middle channel

Plot 3: 9 kHz to 30 MHz, highest channel






Plots: OFDM (40 MHz nominal channel bandwidth)

Plot 1: 9 kHz to 30 MHz, lowest channel




Plot 2: 9 kHz to 30 MHz, middle channel





Plot 2: Lowest channel, 18 GHz to 26 GHz, vertical & horizontal polarization






Plot 3: Middle channel, 1 GHz to 18 GHz, vertical & horizontal polarization


Plot 4: Middle channel, 18 GHz to 26 GHz, vertical & horizontal polarization




Plot 5: Highest channel, 1 GHz to 18 GHz, vertical & horizontal polarization


Plot 6: Highest channel, 18 GHz to 26 GHz, vertical & horizontal polarization








Plot 2: Lowest channel, 18 GHz to 26 GHz, vertical & horizontal polarization




Plot 3: Middle channel, 1 GHz to 18 GHz, vertical & horizontal polarization

Plot 4: Middle channel, 18 GHz to 26 GHz, vertical & horizontal polarization






Plot 5: Highest channel, 1 GHz to 18 GHz, vertical & horizontal polarization

Plot 6: Highest channel, 18 GHz to 26 GHz, vertical & horizontal polarization






Plot 2: Lowest channel, 18 GHz to 26 GHz, vertical & horizontal polarization




Plot 3: Middle channel, 1 GHz to 18 GHz, vertical & horizontal polarization

Plot 4: Middle channel, 18 GHz to 26 GHz, vertical & horizontal polarization






Plot 5: Highest channel, 1 GHz to 18 GHz, vertical & horizontal polarization




Plot 1: Middle channel, 1 GHz to 18 GHz, vertical & horizontal polarization

Plot 1: Middle channel, 1 GHz to 18 GHz, vertical & horizontal polarization







Plot 1: 150 kHz to 30 MHz, phase line




