Kasa Smart Spot has a system LED that changes color according to its status, a microphone, a speaker, a power cord interface, and a RESET button. See the explanation below:

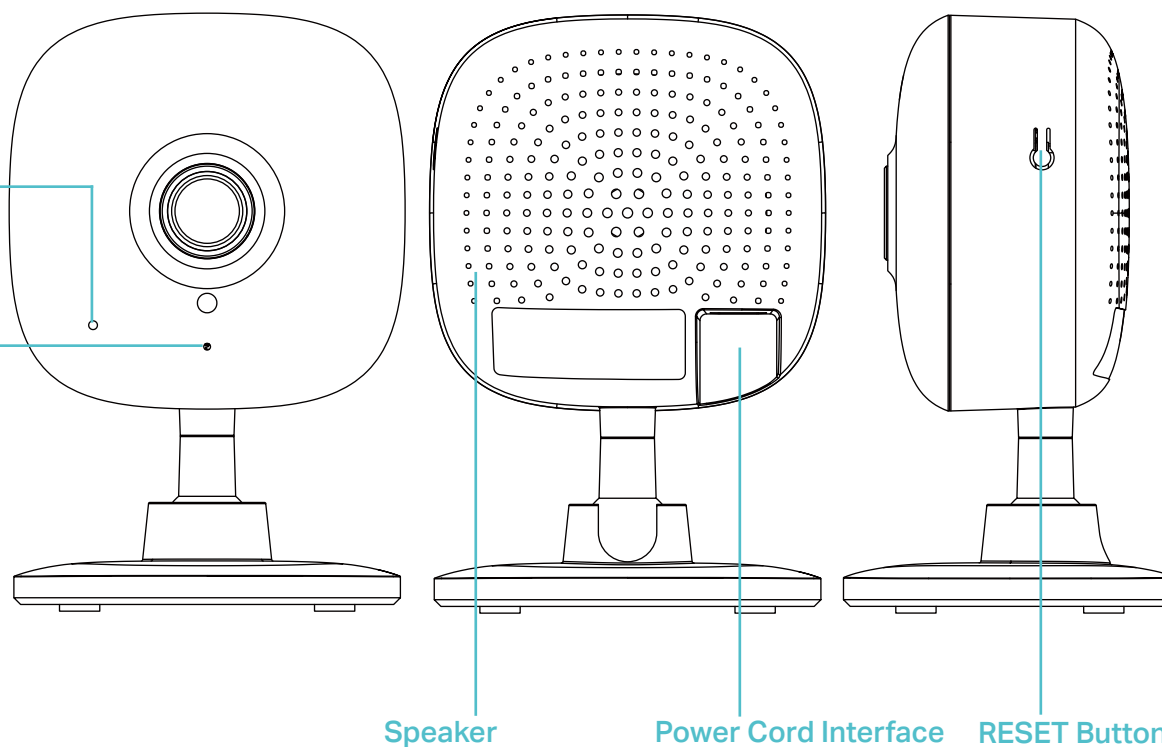
Microphone

Rebooting
- **Alternating amber and green:**
SoftAP Mode
- **Flashing red:**
Connecting to Wi-Fi
- **Flashing green:**
Connected to Wi-Fi
- **Solid green:**
Bound to Cloud
- **Flashing amber:**
Resetting to SoftAP/Factory mode



Speaker

The sound comes out of the camera.

Power Cord Interface

Connect the power cord provided.

RESET Button

- Press and hold for 3 to 15 seconds:
Reset to SoftAP mode
- Press and hold for over 15 seconds:
Reset to Factory mode

Follow the steps below to get started with your new camera.

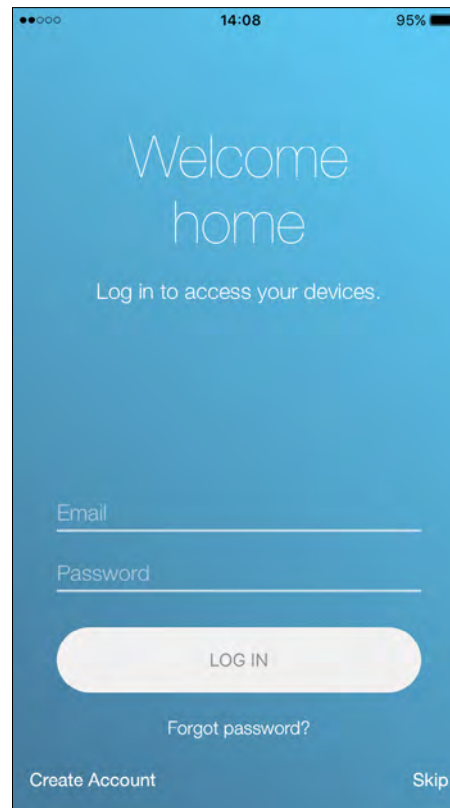
Step 1. Download Kasa
