

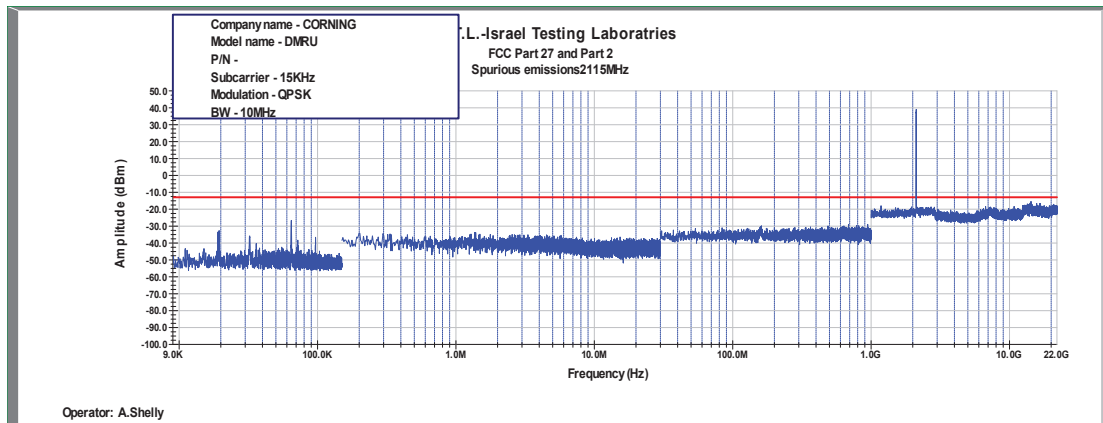


Figure 441: Spurious Emissions at Antenna Terminal QPSK, 2115MHz,
B.W. 10MHz, Sub Carrier 15kHz

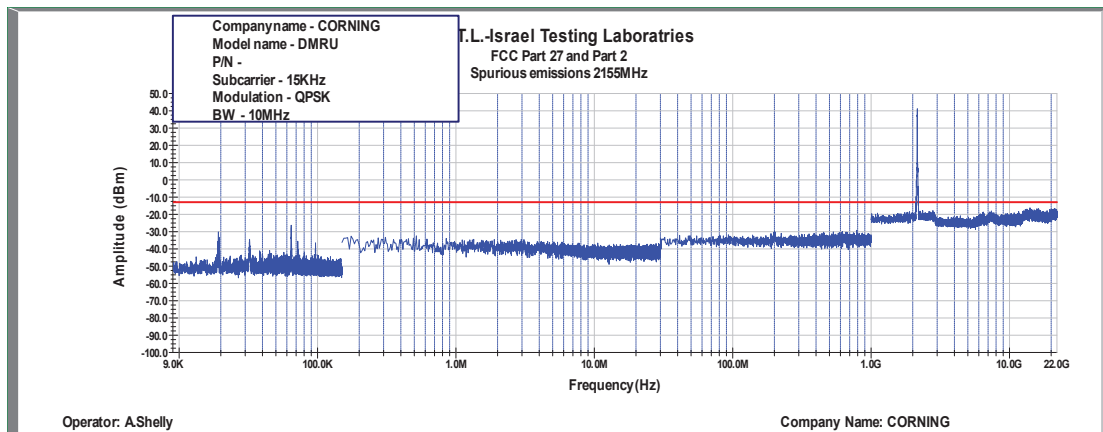


Figure 442: Spurious Emissions at Antenna Terminal QPSK, 2155MHz,
B.W. 10MHz, Sub Carrier 15kHz

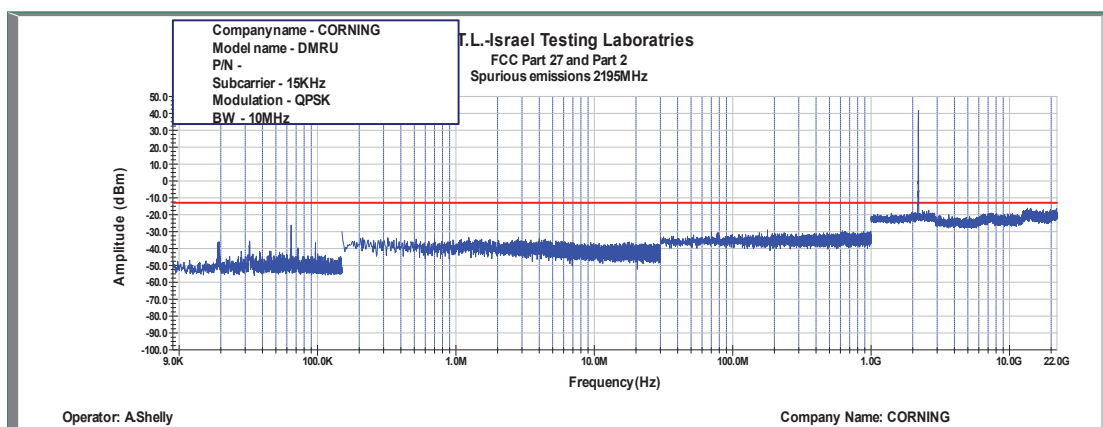


Figure 443: Spurious Emissions at Antenna Terminal QPSK, 2195MHz,
B.W. 10MHz, Sub Carrier 15kHz

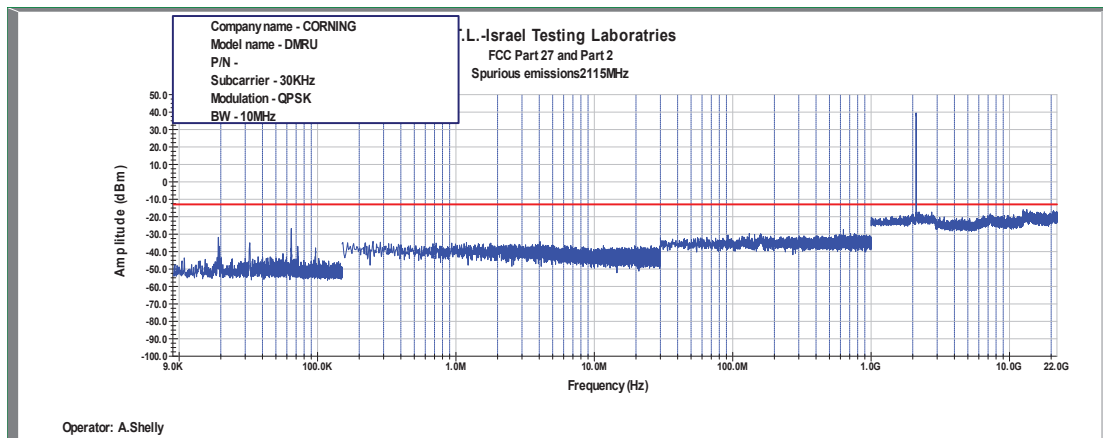


Figure 444: Spurious Emissions at Antenna Terminal QPSK, 2115MHz,
B.W. 10MHz, Sub Carrier 30kHz

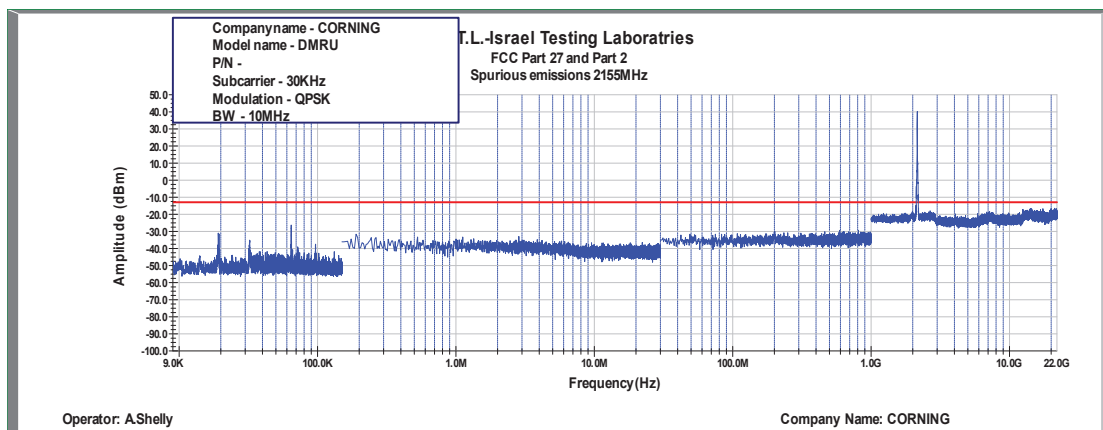


Figure 445: Spurious Emissions at Antenna Terminal QPSK, 2155MHz,
B.W. 10MHz, Sub Carrier 30kHz

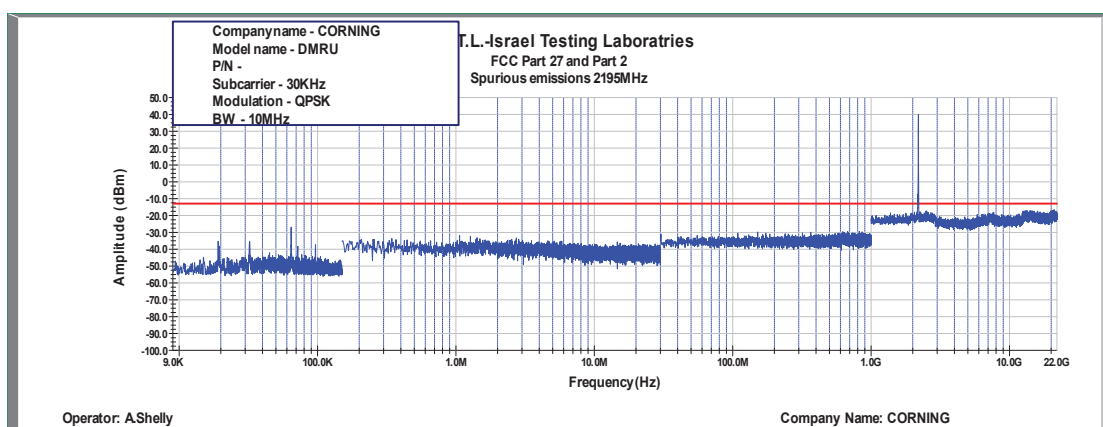


Figure 446: Spurious Emissions at Antenna Terminal QPSK, 2195MHz,
B.W. 10MHz, Sub Carrier 30kHz

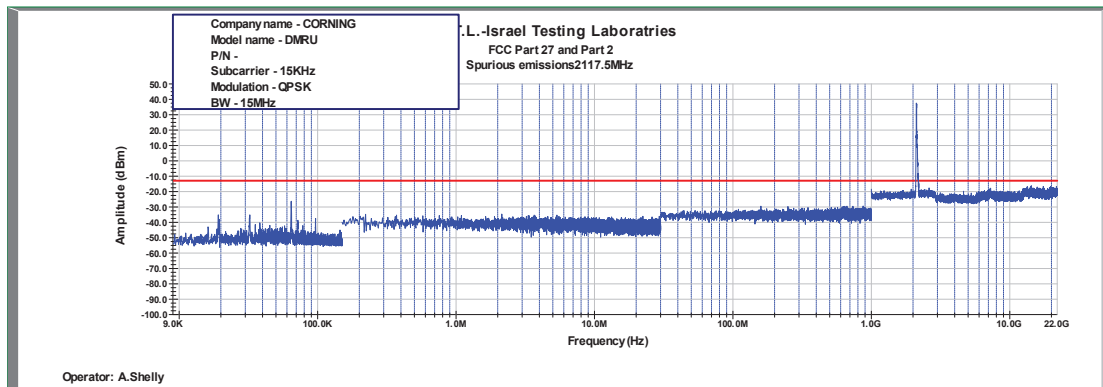


Figure 447: Spurious Emissions at Antenna Terminal QPSK, 2117.5MHz,
B.W. 15MHz, Sub Carrier 15kHz

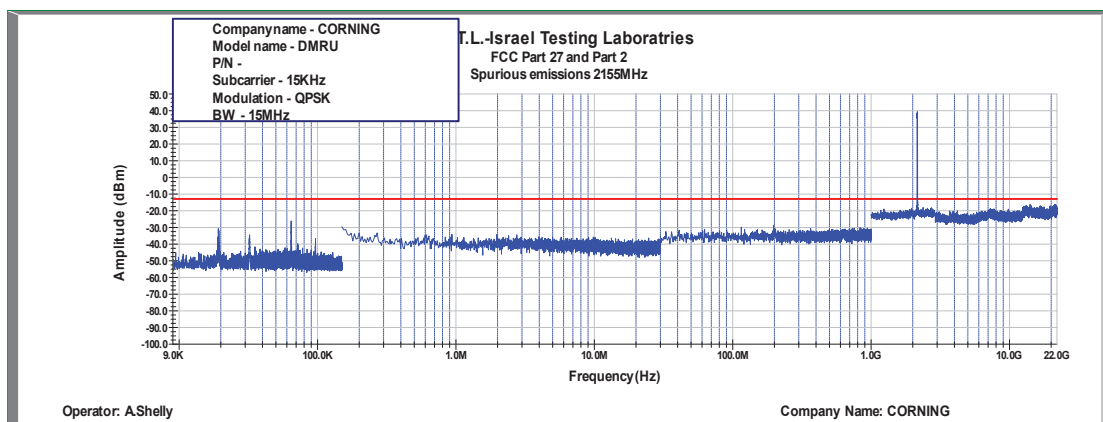


Figure 448: Spurious Emissions at Antenna Terminal QPSK, 2155MHz,
B.W. 15MHz, Sub Carrier 15kHz

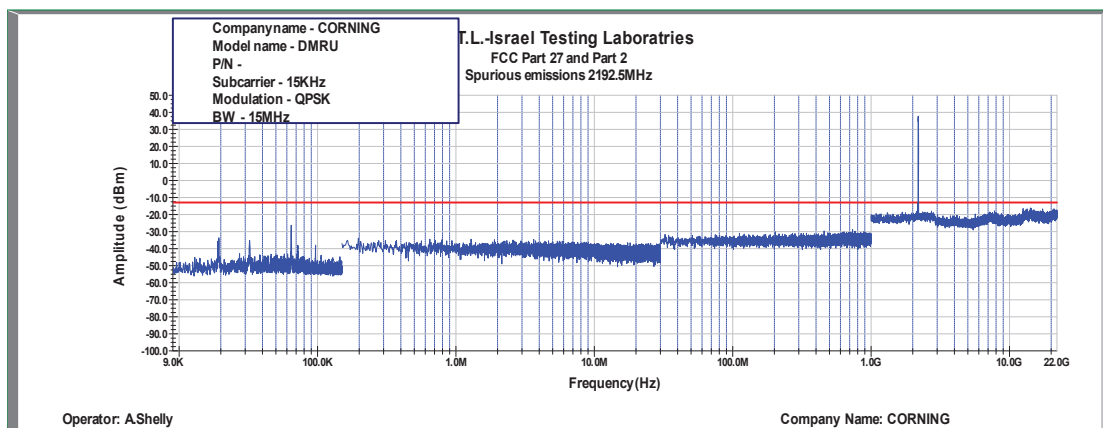


Figure 449: Spurious Emissions at Antenna Terminal QPSK, 2192.5MHz,
B.W. 15MHz, Sub Carrier 15kHz

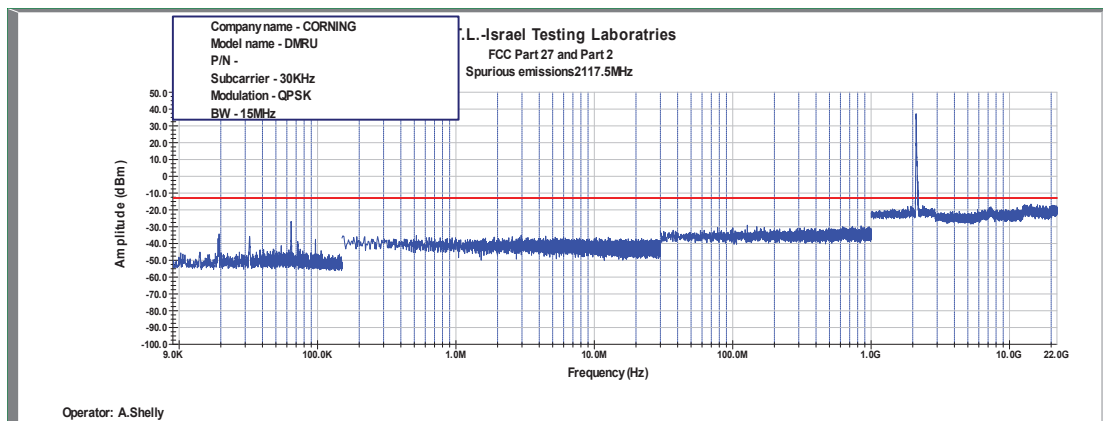


Figure 450: Spurious Emissions at Antenna Terminal QPSK, 2117.5MHz,
B.W. 15MHz, Sub Carrier 30kHz

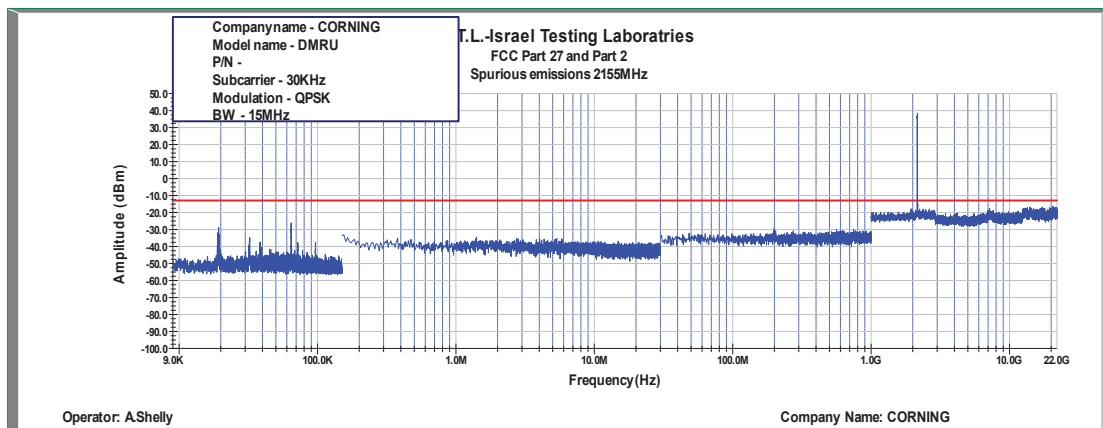


Figure 451: Spurious Emissions at Antenna Terminal QPSK, 2115MHz,
B.W. 15MHz, Sub Carrier 30kHz

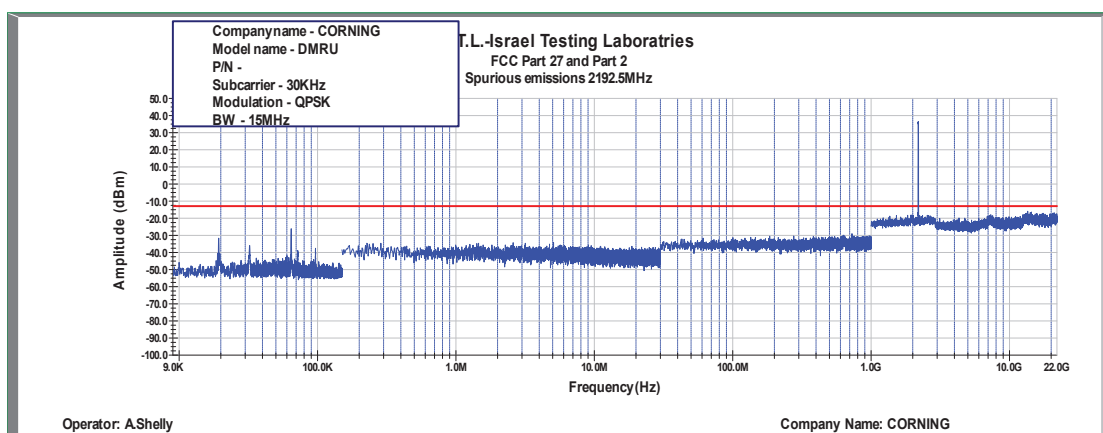


Figure 452: Spurious Emissions at Antenna Terminal QPSK, 2192.5MHz,

(Temperature (20°C)/ Humidity (48%RH))

The E.U.T. antenna terminal was connected to the spectrum analyzer through an external attenuator and an appropriate coaxial cable (max loss=44dB). scanning was performed until 22GHz

11.3 Test Limit

The power of any emission outside of the authorized operating frequency ranges (2110-2200 MHz) must be attenuated below the transmitting power (P) by a factor of $43 + 10 \log (P)$ dB.

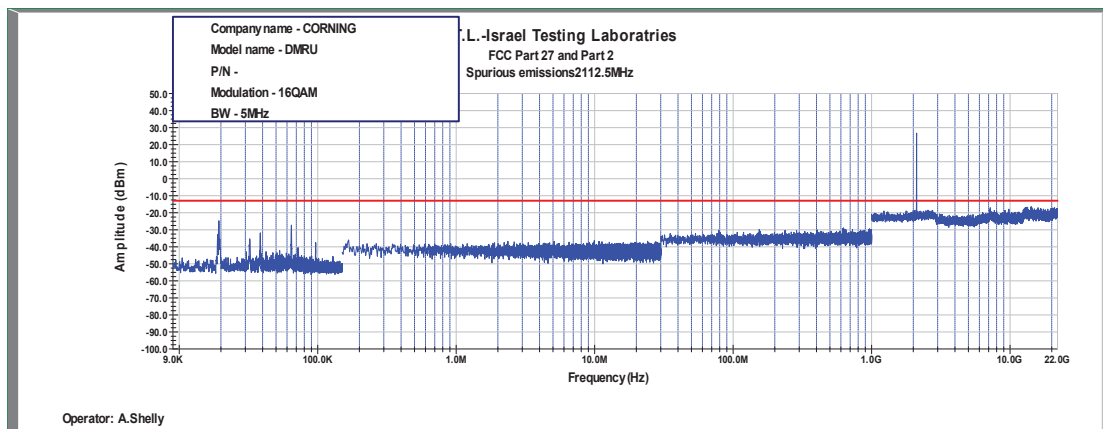


Figure 453: Spurious Emissions at Antenna Terminal 16QAM, 2112.5MHz,
B.W. 5MHz

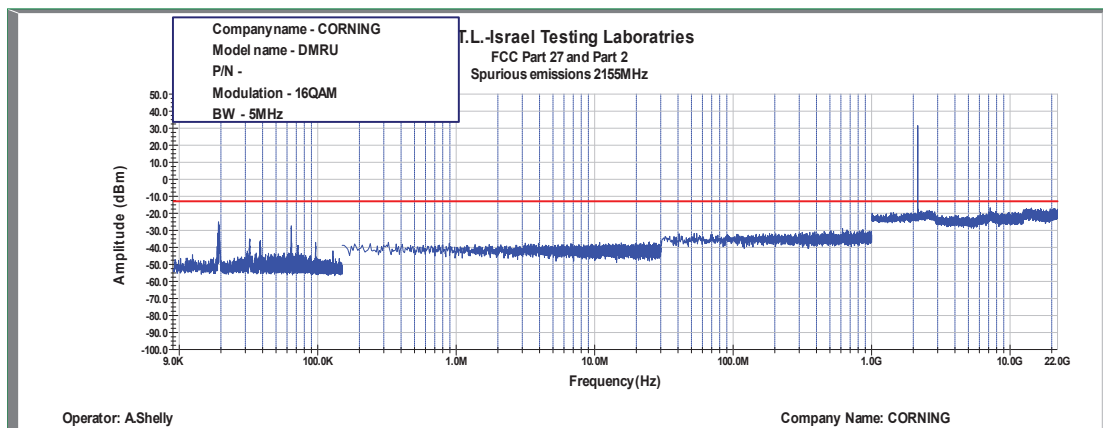


Figure 454: Spurious Emissions at Antenna Terminal 16QAM, 2155MHz,
B.W. 5MHz

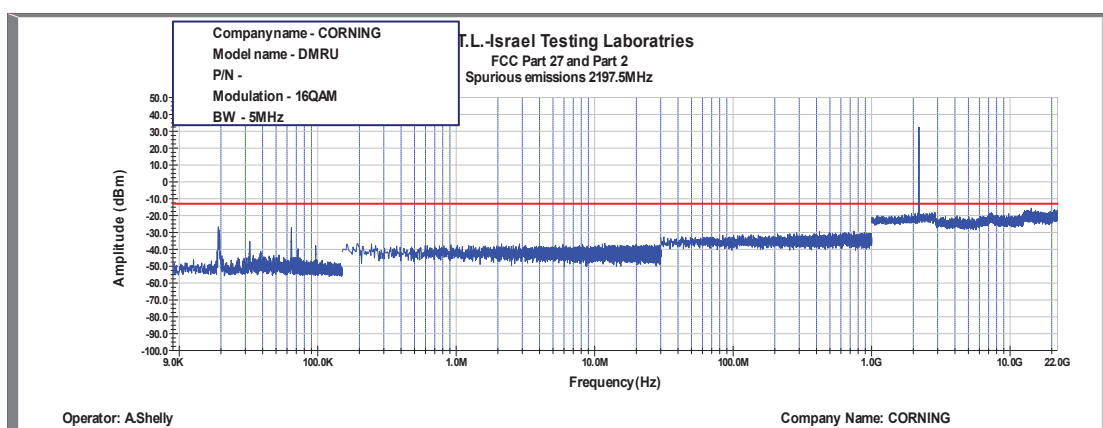


Figure 455: Spurious Emissions at Antenna Terminal 16QAM, 2197.5MHz,
B.W. 5MHz

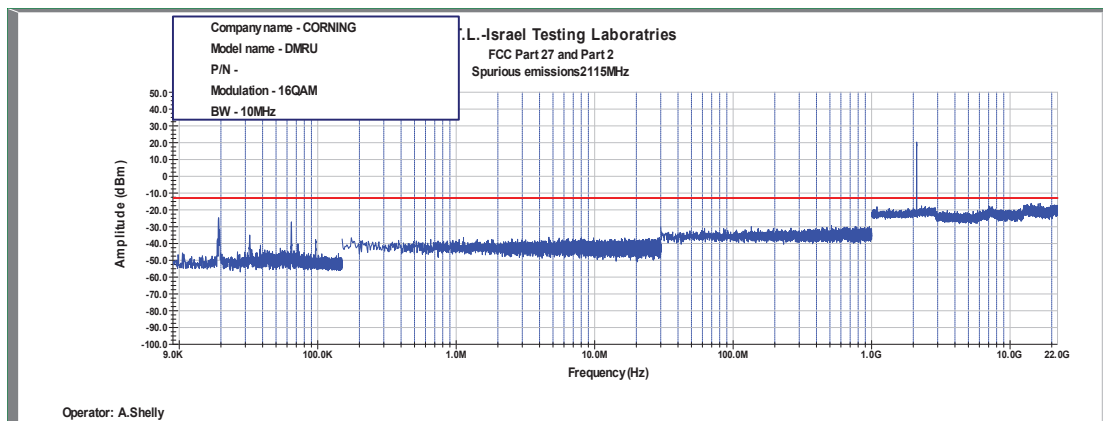


Figure 456: Spurious Emissions at Antenna Terminal 16QAM, 2115MHz,
B.W. 10MHz

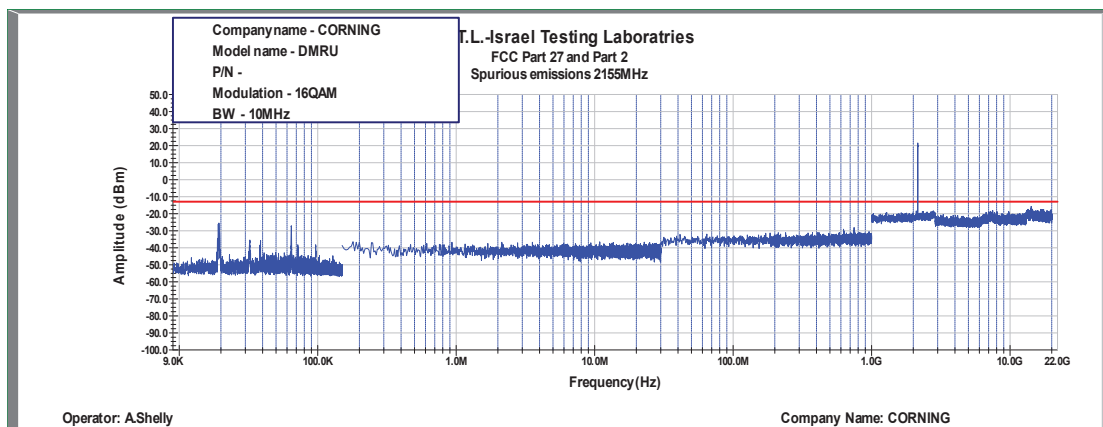


Figure 457: Spurious Emissions at Antenna Terminal 16QAM, 2155MHz,
B.W. 10MHz

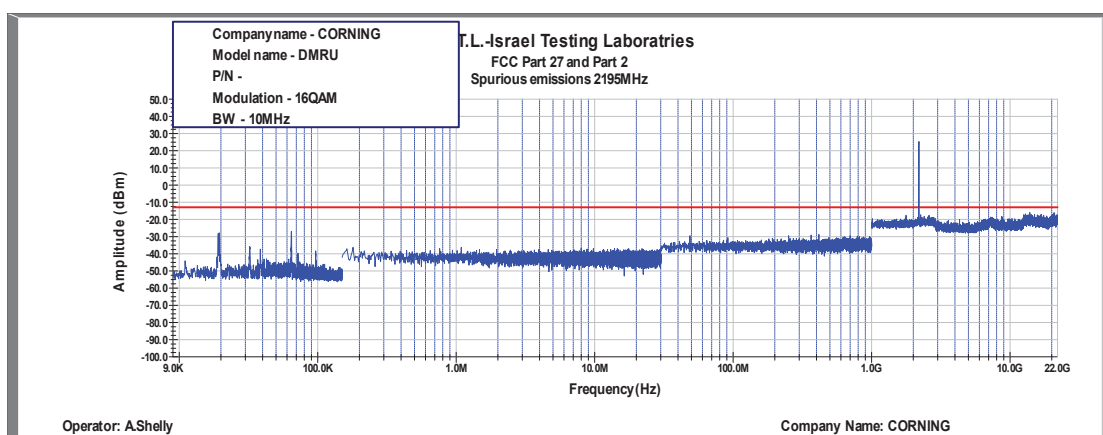


Figure 458: Spurious Emissions at Antenna Terminal 16QAM, 2195MHz,
B.W. 10MHz

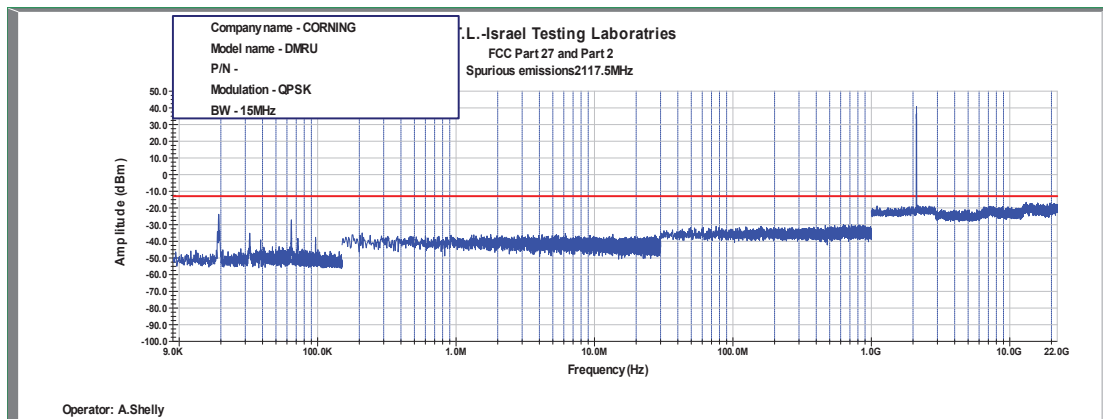


Figure 459: Spurious Emissions at Antenna Terminal 16QAM, 2117.5MHz,
B.W. 15MHz

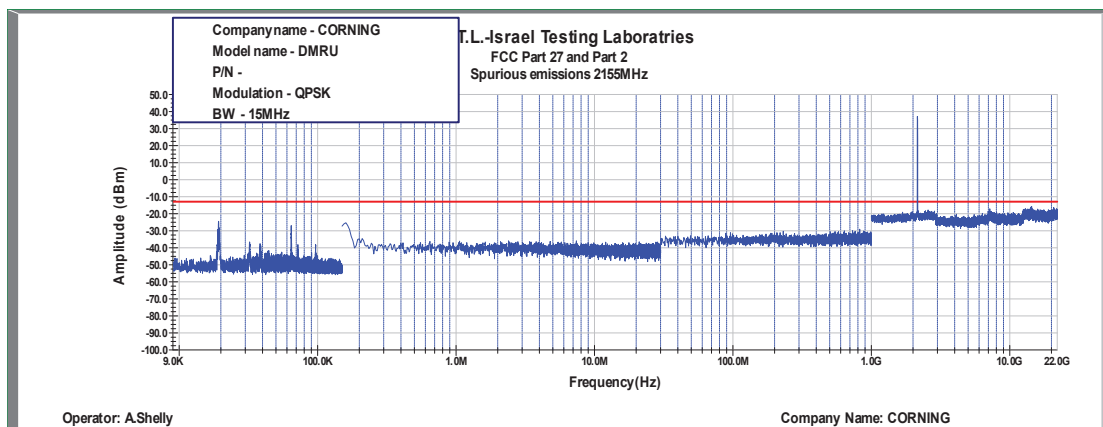


Figure 460: Spurious Emissions at Antenna Terminal 16QAM, 2155MHz,
B.W. 15MHz

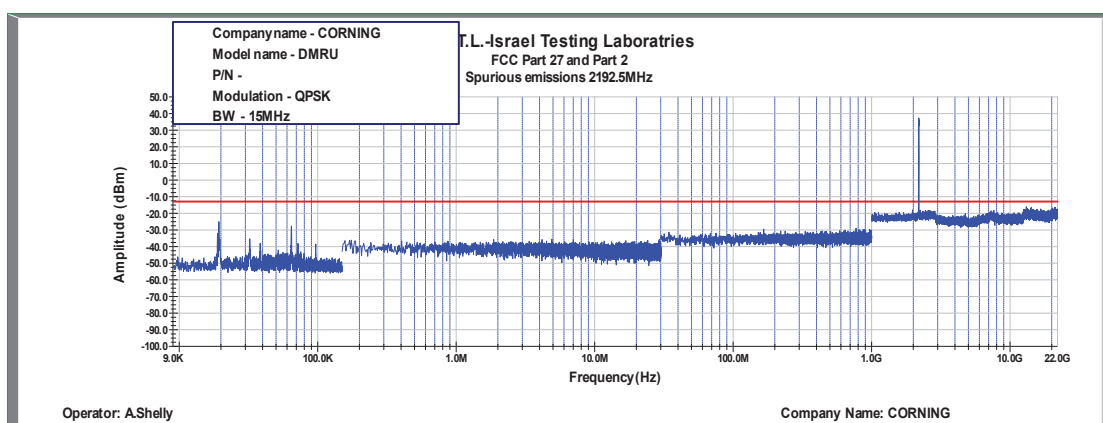


Figure 461: Spurious Emissions at Antenna Terminal 16QAM, 2192.5MHz,
B.W. 15MHz

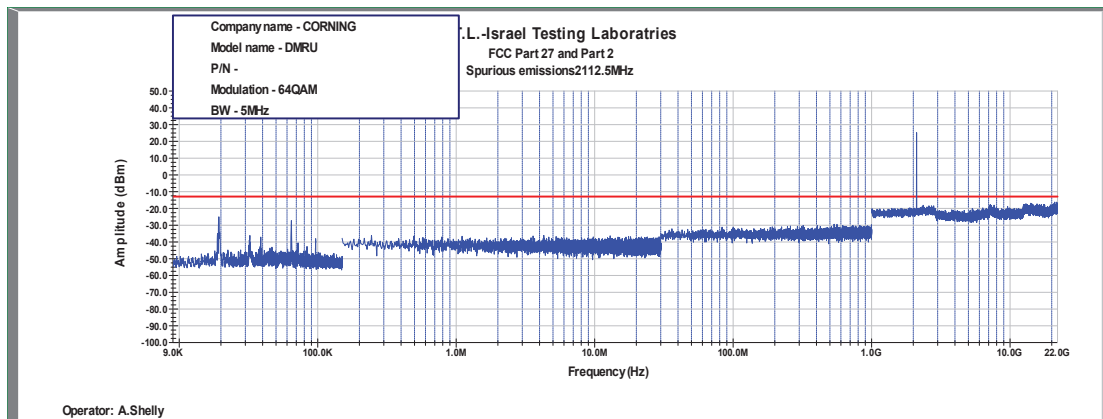


Figure 462: Spurious Emissions at Antenna Terminal 64QAM, 2112.5MHz,
B.W. 5MHz

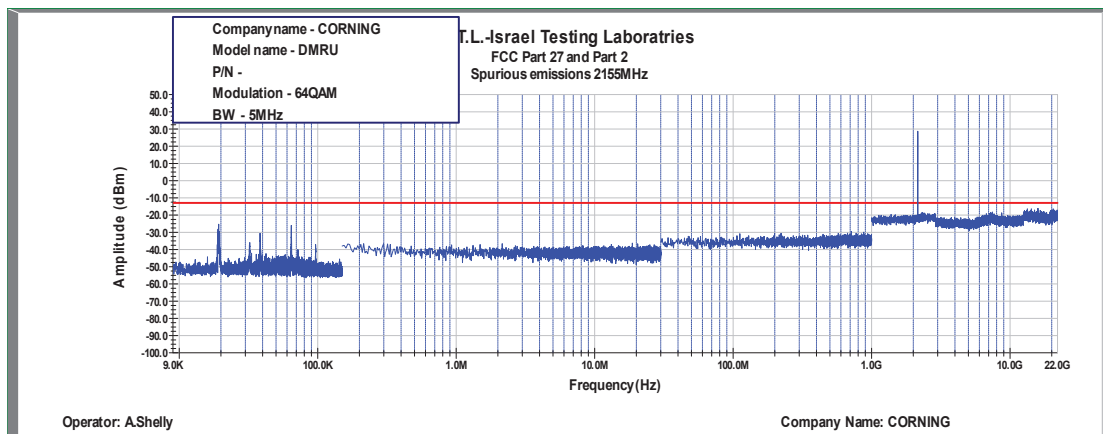


Figure 463: Spurious Emissions at Antenna Terminal 64QAM, 2155MHz,
B.W. 5MHz

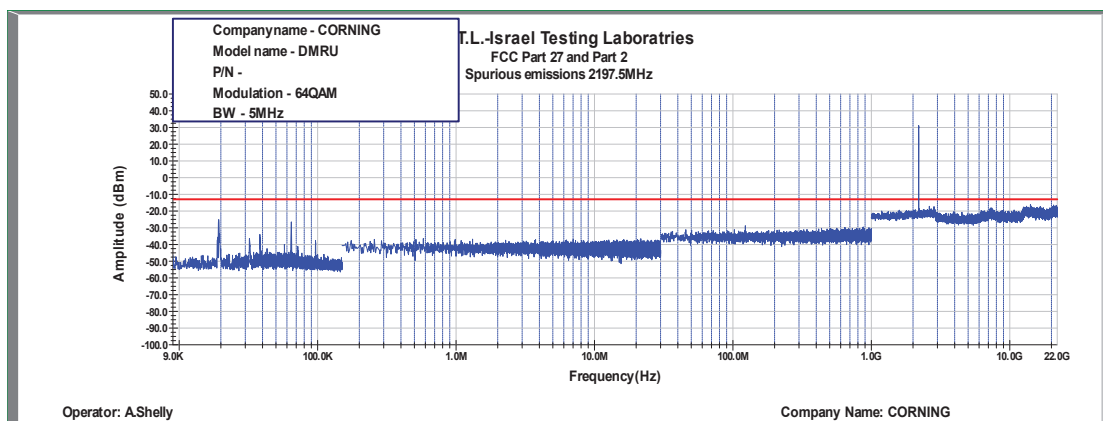


Figure 464: Spurious Emissions at Antenna Terminal 64QAM, 2197.5MHz,
B.W. 5MHz

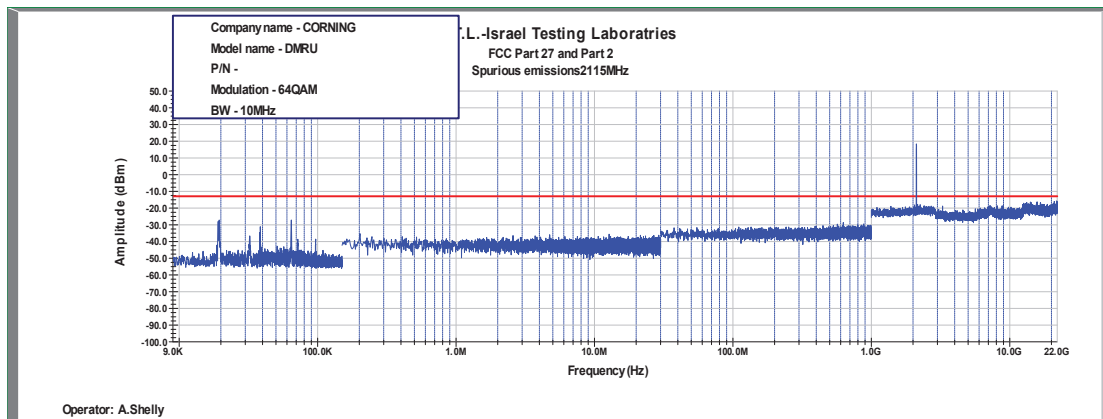


Figure 465: Spurious Emissions at Antenna Terminal 64QAM, 2115MHz,
B.W. 10MHz

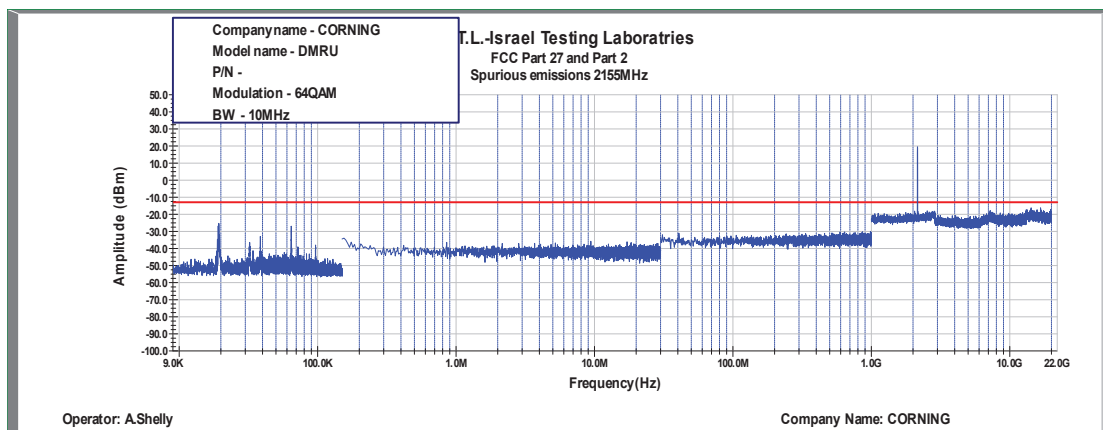


Figure 466: Spurious Emissions at Antenna Terminal 64QAM, 2155MHz,
B.W. 10MHz

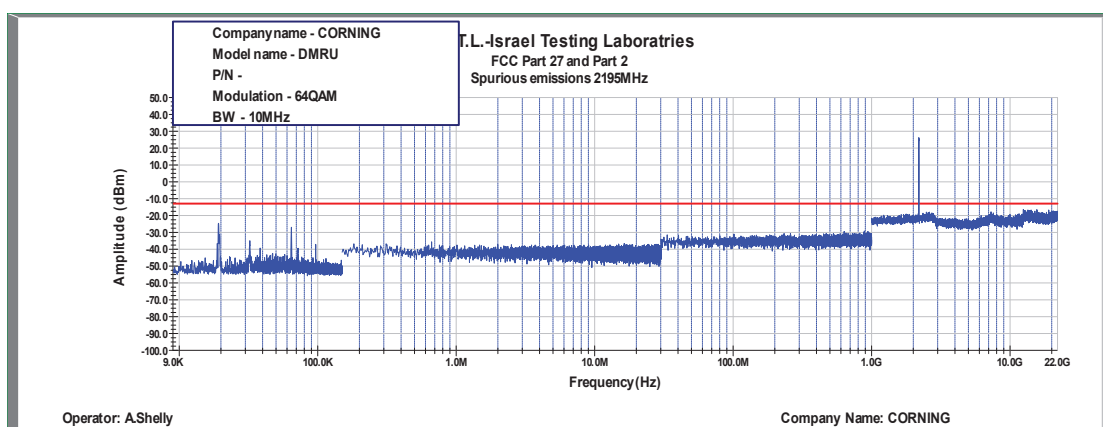


Figure 467: Spurious Emissions at Antenna Terminal 64QAM, 2195MHz,
B.W. 10MHz

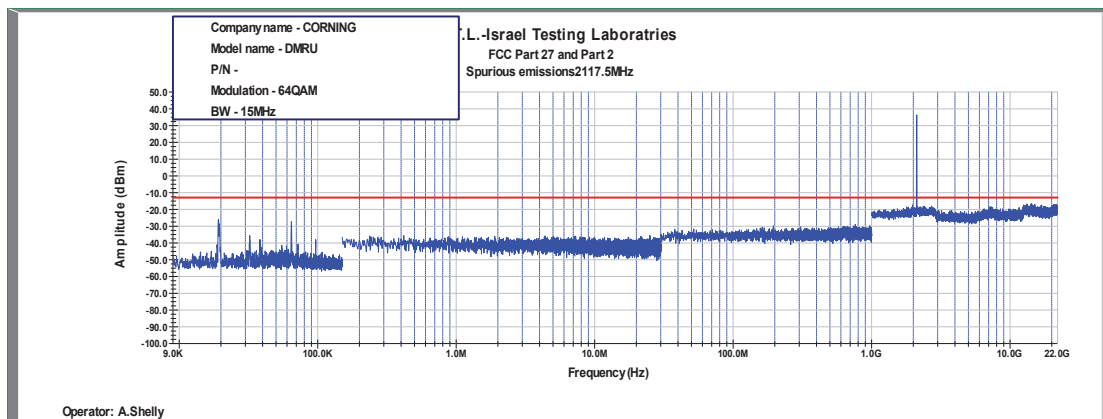


Figure 468: Spurious Emissions at Antenna Terminal 64QAM, 2117.5MHz,
B.W. 15MHz

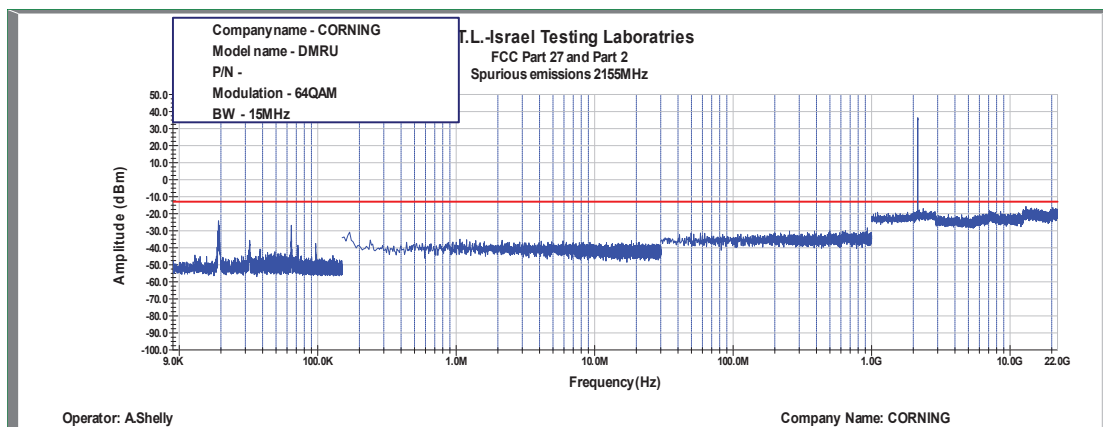


Figure 469: Spurious Emissions at Antenna Terminal 64QAM, 2155MHz,
B.W. 15MHz

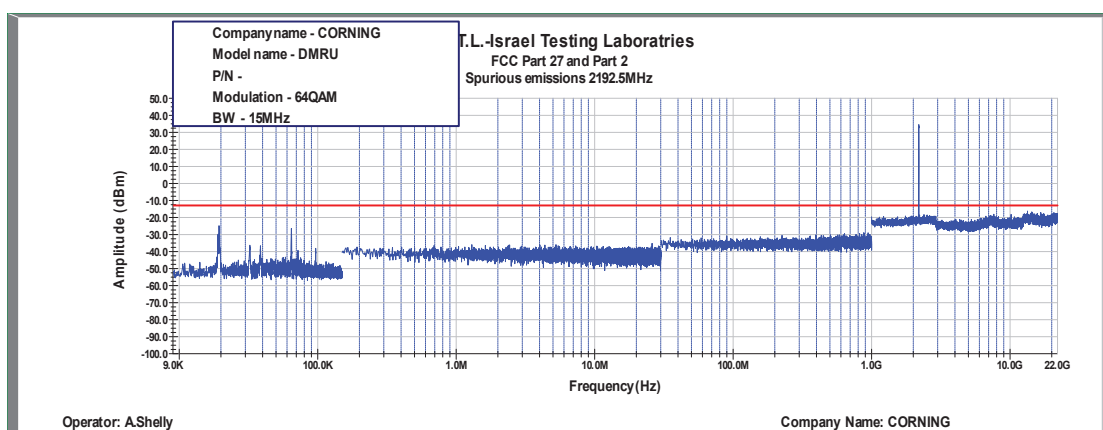


Figure 470: Spurious Emissions at Antenna Terminal 64QAM, 2192.5MHz,
B.W. 15MHz

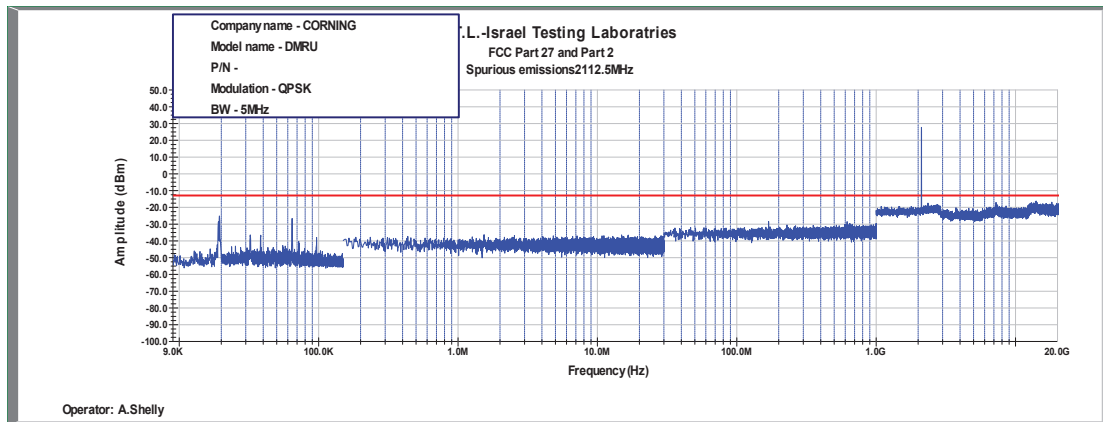


Figure 471: Spurious Emissions at Antenna Terminal QPSK, 2112.5MHz, B.W. 5MHz

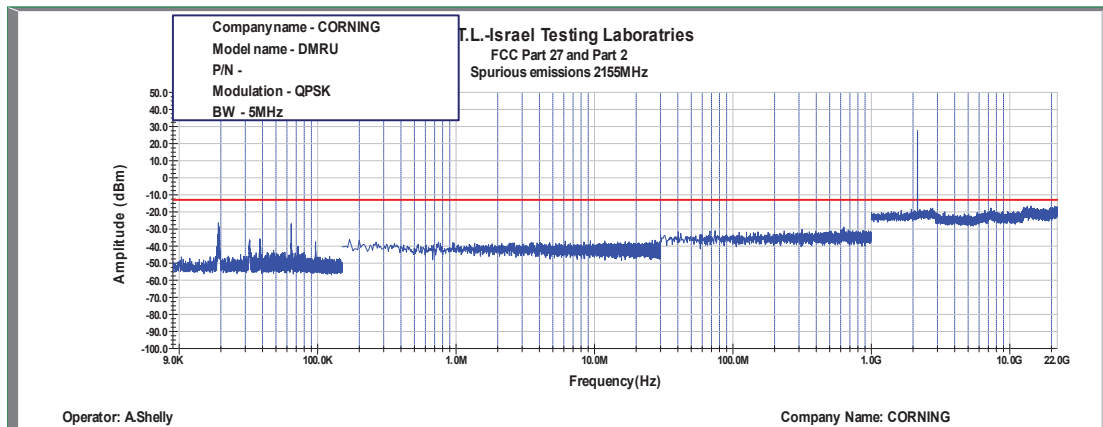


Figure 472: Spurious Emissions at Antenna Terminal QPSK, 2155MHz, B.W. 5MHz

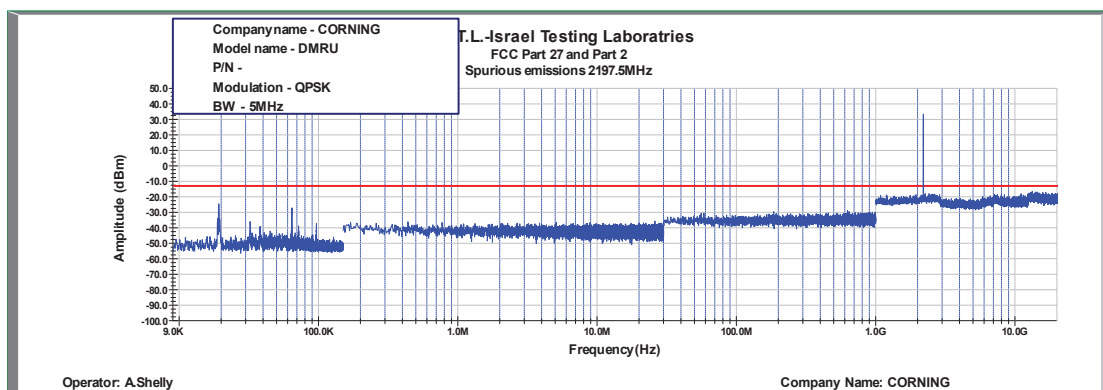


Figure 473: Spurious Emissions at Antenna Terminal QPSK, 2197.5MHz, B.W. 5MHz

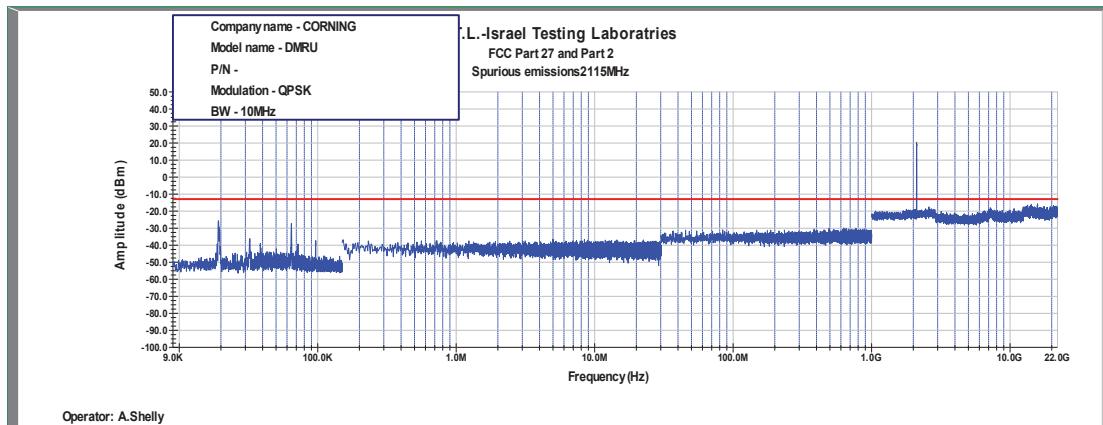


Figure 474: Spurious Emissions at Antenna Terminal QPSK, 2115MHz,
B.W. 10MHz

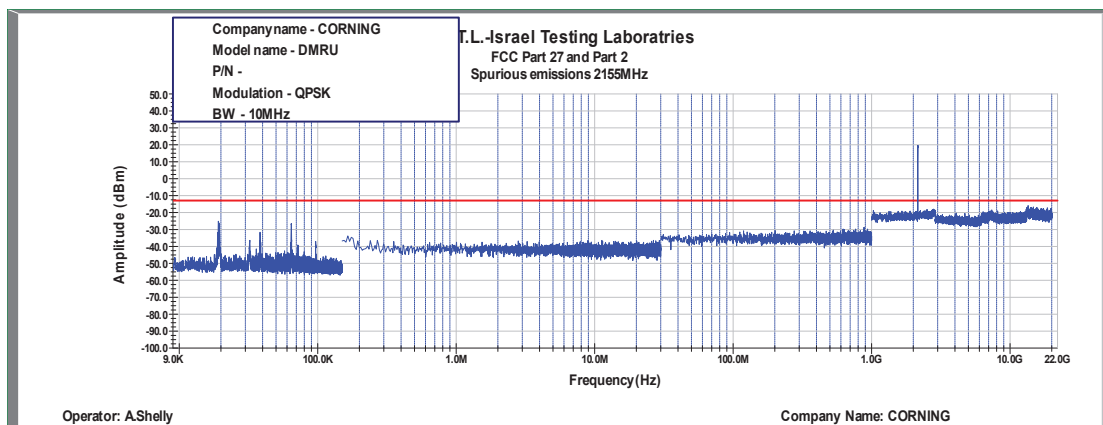


Figure 475: Spurious Emissions at Antenna Terminal QPSK, 2155MHz,
B.W. 10MHz

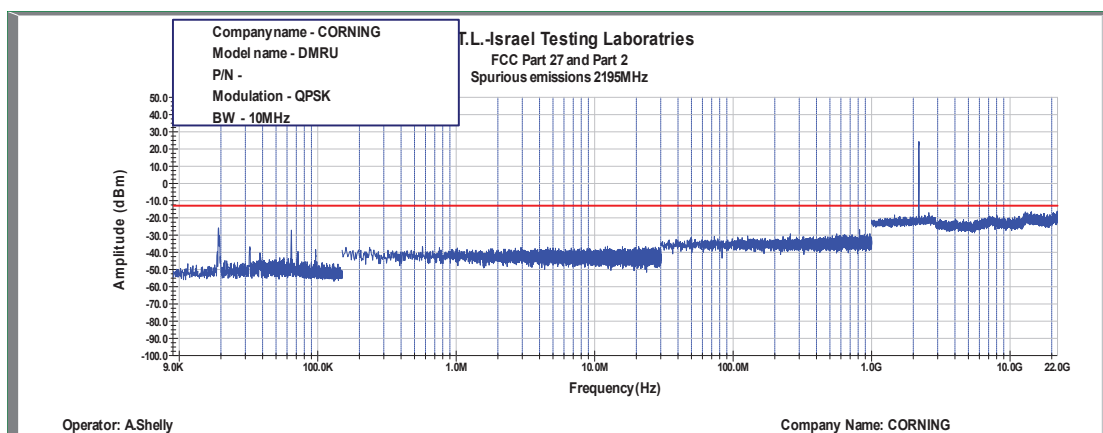


Figure 476: Spurious Emissions at Antenna Terminal QPSK, 2195MHz,
B.W. 10MHz

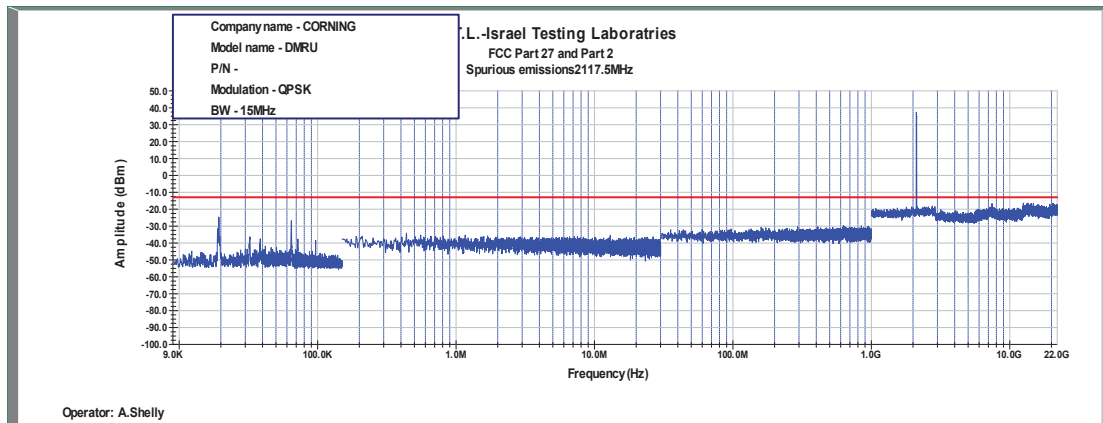


Figure 477: Spurious Emissions at Antenna Terminal QPSK, 2117.5MHz,
B.W. 15MHz

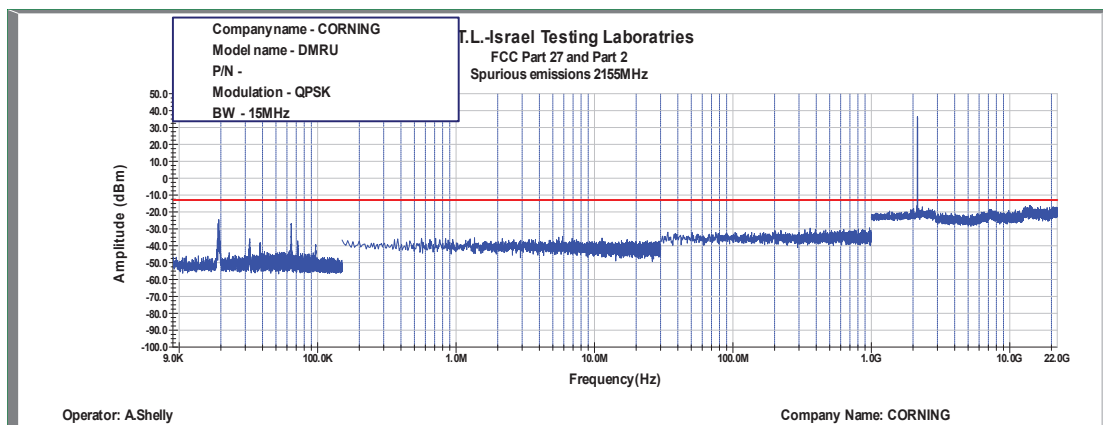


Figure 478: Spurious Emissions at Antenna Terminal QPSK, 2155MHz,
B.W. 15MHz

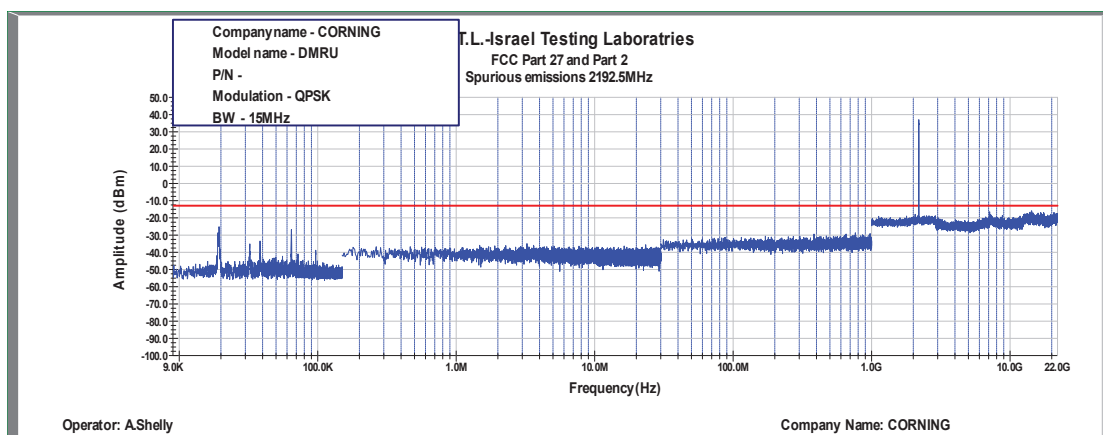


Figure 479: Spurious Emissions at Antenna Terminal QPSK, 2192.5MHz,
B.W. 15MHz

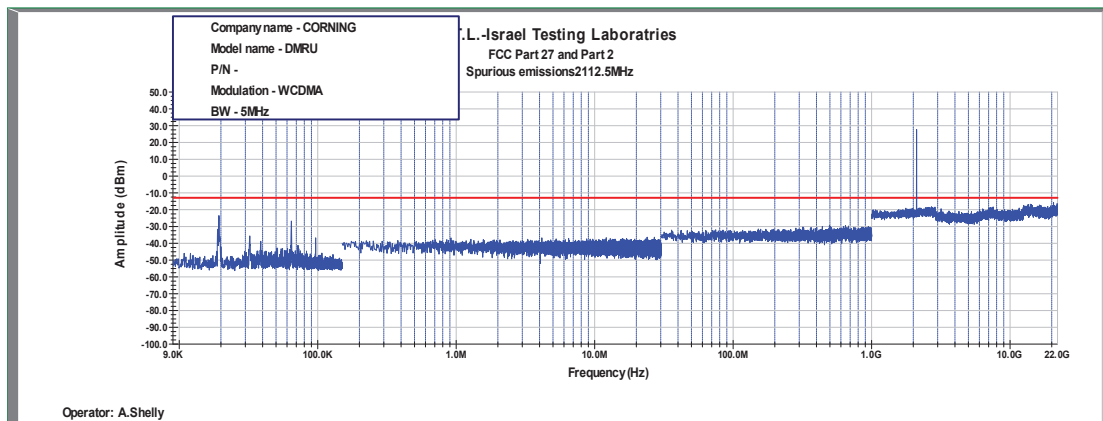


Figure 480: Spurious Emissions at Antenna Terminal WCDMA, 2112.5MHz,
B.W. 5MHz

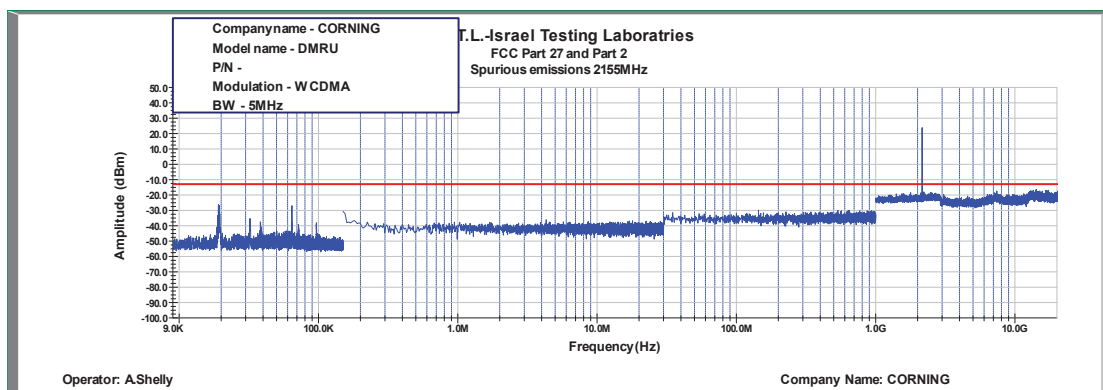


Figure 481: Spurious Emissions at Antenna Terminal WCDMA, 2155MHz,
B.W. 5MHz

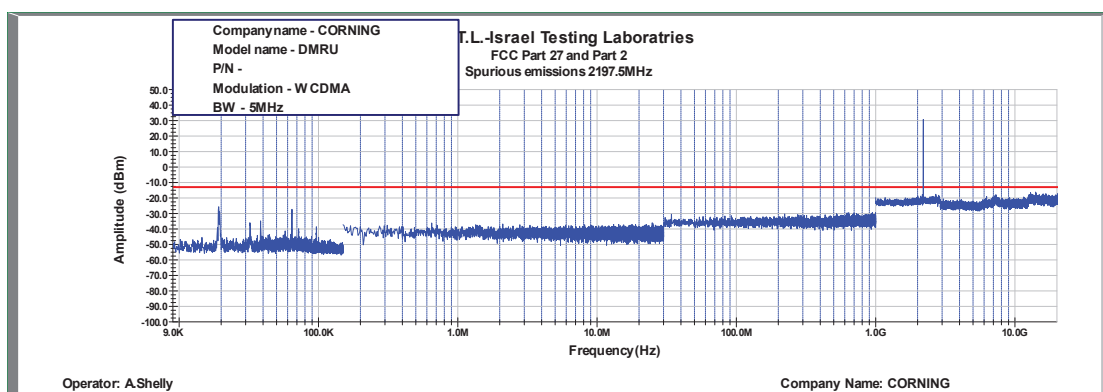


Figure 482: Spurious Emissions at Antenna Terminal WCDMA, 2197.5MHz,

12 Spurious Radiated Emission

12.1 Test Specification

FCC, Part 27, Subpart C, Section 27.53 (h)

12.2 Test Procedure

(Temperature (18°C)/ Humidity (40%RH))

The test method was based on ANSI/TIA-603-D: 2010, Section 2.2.12 Unwanted Emissions: Radiated Spurious.

For measurements between 0.009MHz-30MHz:

The E.U.T was tested inside the shielded room at a distance of 3 meters and the E.U.T was placed on a non-metallic table, 1.5 meters above the ground. The frequency range 0.009MHz-30MHz was scanned. The readings were maximized by the turntable azimuth between 0-360°, and the antenna polarization.

The emissions were measured at a distance of 3 meters.

For measurements between 30.0MHz-1.0GHz:

A preliminary measurement to characterize the E.U.T was performed inside the shielded room at a distance of 3 meters, using peak detection mode and broadband antennas. The preliminary measurements produced a list of the highest emissions. The E.U.T was then transferred to the open site, and placed on a remote-controlled turntable. The E.U.T was placed on a non-metallic table, 0.8 meters above the ground. The frequency range 30.0MHz -1.0GHz was scanned and the list of the highest emissions was verified and updated accordingly.

The readings were maximized by adjusting the antenna height between 1-4 meters, the turntable azimuth between 0-360°, and the antenna polarization.

The emissions were measured at a distance of 3 meters.

For measurements between 1.0GHz-22.0GHz:

The E.U.T was tested inside the shielded room at a distance of 3 meters and the E.U.T was placed on a non-metallic table, 1.5 meters above the ground. The frequency range 1.0GHz -22.0GHz was scanned. The readings were maximized by the turntable azimuth between 0-360°, and the antenna polarization.

The emissions were measured at a distance of 3 meters.

RMS detector was used for this test.

Testing was performed when the RF port was connected to 50 Ω termination

Evaluation was performed for all possible modulations, bandwidths, and sub carriers.

Only the highest spurious radiation value describes in the table results



12.3 Test Limit

The power of any emission outside of the authorized operating frequency ranges (2110-2200MHz) must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log (P)$ dB, yielding -13dBm
